

**Manitoba Public Sector  
Collective Bargaining Settlements - 2010 and 2011**

**1. "Wage Pause" Settlements - 2010 & 2011:**

- In 2010 and 2011 - collective bargaining settlements - have been concluded - in Government, Health Care, Post-Secondary Education, Crown Corporations and Family Services - representing approximately 42,000 employees and total payroll of approx \$3.0B +.
- All settlements contain 2-zero years - in - either 2010/11 & 2011/12 - or - 2011/12 & 2012/13.
- Settlements range from 3½-to-5-Yrs - include 2-zero years - with increases in the non-zero years.
- Settlements typically are either:     0 + 0 + 2.9;  
  0 + 0 + 2.9 + 2.9;  
  or 0 + 0 + 2.75 + 2.75 + 2.00 Long Service Step/20-Yrs/Yr-3.
- Some Settlements - in the non-zero years - provide for "Market Adjustments"- for some jobs based on Recruitment/Retention/Market criteria.

4. UMDCSA – 3 years (0.0% in 2010/11, 0.0% in 2011/12 and 2.9% in 2012/13)
5. CUPE 1482 (Engineering) – 4 years (0.0% in 2010/11, 0.0% in 2011/12, 2.9% in 2012/13 and 2.9% in 2013/14)
6. CUPE 3909 (Teaching Assistants) – 4 years (0.0% in 2010/11, 0.0% in 2011/12, 2.9% in 2012/13 and 2.9% in 2013/14)
