## Residence Authorization for Minors

In Manitoba the age of majority is 18 years of age, therefore students planning to live in Residence at the University of Manitoba who are under the age of 18 require the signature of a parent or legal guardian on application and contractual documents. The purpose of this document is to ensure that students under the age of 18 and their parents/guardians have reviewed and agree to the University of Manitoba Residence Contract, (which can be found online at <http://umanitoba.ca/campus/housing/living/contract.html>), including the discipline procedures as they relate to minors. This document will also ensure that Student Residences has up to date contact information should communication be required. This form will become obsolete upon the student's 18th birthday.
