

## **Master of Education Required Documentation**

(All required documentation MUST be submitted by the APPLICATION DEADLINE)

Graduate online application and application fee.
Transcripts from all recognized, post-secondary institutions attended other than the University of Manitoba. For initial assessment purposes, copies of unofficial transcripts (uploaded to the online application) are acceptable and preferred. Official transcripts will only be required by the Faculty of Graduate Studies if you are recommended for admission.
For applications to all concentrations in <b>Curriculum, Teaching and Learning</b> : A statement indicating (1) whether your initial plans are to take a thesis or course-based route; and (2) what is your motivation to pursue a Master degree program in the concentration you are applying for (ACE   Arts, Community and Education; Critical Perspectives in Curriculum, Teaching and Pedagogy; Indigenous (First Nations, Métis, Inut) Perspectives in Curriculum, Teaching, and Learning; Studies in Contemplative, Holistic, and Integrative Education; or Studies in Mathematics Education and science Education
For applications to <b>Adult and Post-Secondary Education</b> ; <b>Cross-cultural, Sociological, and Philosophical Foundations in Education</b> ; <b>Educational Administration</b> ; and <b>Inclusive Education</b> specializations: A statement of intent, in support of your application for admission (maximum 500 words, double-spaced). Address the following categories (and any additional areas) in any order you wish:
<ol> <li>Professional experience (comment on any relevant work experience),</li> <li>Personal qualities related to your career objectives,</li> </ol>
<ol> <li>Reasons for study and plans for completion; this should include both whether you intend to study part-time or full-time, and whether your initial plans are to take a thesis or course-based route to the degree.</li> <li>Career interests and objectives.</li> </ol>
For applications to the <b>Counselling Psychology</b> specialization: A statement of intent that should address: (a) why you are interested in counselling psychology, (b) why you think this program would be a good fit for you, (c) key learnings taken away from your volunteer/work experiences as a counsellor and (d) how this program would contribute to your professional development and goals (short- and long- term career objectives). If you are pursuing a thesis-based route you would also need to include (e) your research topic of interest, significance to the field, what previous research skills you will draw from to inform your work, and who you are interested in being supervised by on your thesis work. The maximum length for your statement of intent is 3 pages, single spaced, 12-point font.  N.B. The statement of intent is an important component of your application, and we ask that you pay attention to both form and content.
Two letters of recommendation. (You will be asked to provide names and e-mail addresses of recommenders to the online application system; the recommenders will be prompted to complete a form and upload a letter directly to the online application system.)
Academic background and relevant professional experience (CV/resumé).
English Language Proficiency Test Score (if applicable; see online application for admission details).
