

## SELF–DECLARATION FORM FOR 2024-2025 NEWLY ADMITTED STUDENTS: CHILD ABUSE REGISTRY AND STATEMENT OF CRIMINAL RECORDS

The Faculty of Education and the University of Manitoba Senate have approved that all students admitted to the B.Ed. program:

1. be required to submit the enclosed <u>Self-Declaration form for Newly Admitted Students: Child Abuse Registry & Statement of Criminal Record(s)</u>

A signed self-declaration of *adult* criminal convictions will not necessarily preclude admission. Decisions with regard to criminal records will be made by the Associate Dean (Undergraduate Programs and Partnerships), Faculty of Education. However, applicants to and graduates of Bachelor of Education programs who have criminal records which indicate they may pose a threat to the safety and well-being of children and others in the school or who appear on the Child Abuse Registry will be denied admission and/or teacher certification.

Any changes in a student's status while in the B.Ed. program must be reported to the Associate Dean (Undergraduate Programs and Partnerships), Faculty of Education. A signed self-declaration form is required for each year of attendance.

2. be required to submit and be cleared on a formal <u>Criminal Records Search/Check</u> (including Vulnerable Sector screening) <u>prior to</u> registration. Documents (including electronic submissions from Winnipeg Police Services) MUST be dated March 15, 2024 or newer. Any form dated prior to March 15, 2024 is considered stale-dated and is NOT acceptable

A formal Canadian Criminal Records Search (<u>including</u> Vulnerable Sector screening) is required prior to registration in any coursework. Originals must be submitted to Student Services, Faculty of Education. Originals submitted in person or via mail will be **copied and returned to student.** 

Criminal Records Searches can be obtained from Winnipeg Police Services at 245 Smith Street. See <a href="https://www.winnipeg.ca/police/services/online-record-checks">https://www.winnipeg.ca/police/services/online-record-checks</a> for ordering online and for more detailed information. If residing outside of Winnipeg in Canada, contact your local law enforcement agency. We are not able to provide students with copies of any checks submitted online.

3. be required to submit and be cleared on a formal <u>Child Abuse Registry Self-Check</u> prior to registration. Documents MUST be dated March 15, 2024 or newer. Any form dated prior to March 15, 2024 is considered stale-dated and is NOT acceptable.

A formal Child Abuse Registry Self-Check is required prior to registration in any coursework. Originals must be submitted to Student Services, Faculty of Education. Originals will be **copied and returned to student**.

If residing in Manitoba, Child Abuse Registry Self-Checks can be obtained from Manitoba Family Services, Child and Family Services, Child Protection, 777 Portage Avenue or <a href="https://www.gov.mb.ca/fs/childfam/child">https://www.gov.mb.ca/fs/childfam/child</a> abuse registry.html. If you reside in Canada but outside of Manitoba, contact your provincial authority for an equivalent check. If your provincial authority does not provide an equivalent check, you may obtain a check from Manitoba instead.

## **Please Note:**

Although the Province of Manitoba notes on its webpage that if you are applying for an unpaid position working with children, you are to make your application "through the employer/agency as a fee exemption may apply", the Faculty of Education is requiring all students admitted to complete a Child Abuse Registry Self-Check through the Registry itself.

## Please be advised of the following pertinent information.

- 1. Only criminal convictions obtained as an adult need be reported. Students are not required to disclose records under *The Young Offenders Act or The Youth Criminal Justice Act*.
- 2. Students whose name appears on the Child Abuse Registry will have their admission offer revoked.
- 3. The formal checks are the property of the student and will be returned to the student. Copies will be held separate from the students file until such time as their program is complete.
- 4. The above information will be kept strictly confidential by the Faculty of Education and will not become a part of the student's permanent record with the University.
- 5. Failure to disclose any criminal record or listing on the Child Abuse Registry will invalidate the application and shall result in immediate expulsion from the Faculty of Education.
- 6. Registration in coursework is subject to clearance of the Criminal Record Check (including vulnerable sector screening) and Child Abuse Registry.
- 7. It is the continuing student's responsibility to inform the Associate Dean (Undergraduate Programs and Partnerships) in the Faculty of Education should there be a change to their status on the Child Abuse Registry or should they obtain an adult criminal record while enrolled in the Faculty of Education.
- 8. The Faculty of Education/University of Manitoba cannot be held responsible for future changes in legislation which may affect teacher certification. Further information may be obtained from:

The Criminal Record Check and the Child Abuse Registry Self-Check forms <u>must</u> be <u>dated after March 15, 2024</u> and should be mailed to:

You should retain the instruction pages for future reference.

In order to register for Fall 2024 and Winter 2025, all three forms - Self Declaration, Criminal Record Check (with VS screening) and the Child Abuse Registry Check - must be completed and submitted no later than July 8, 2024.

• Students who submit these documents after July 8 will be considered on a case-by-case basis and may not be able to register for courses in Fall 2024. If no documents are submitted by August 23, the student will be restricted from completing practicum in the Fall. All documents must be submitted by August 29 to attend classes in Fall Term 2024.
