#### What is CSEP

The Canadian Society for Exercise Physiology (CSEP) is an organization that seeks to establish a standard for exercise professionals in Canada by creating minimum requirements and education for each certification and specialization offered. The FKRM and broader exercise physiology community recognizes CSEP as the gold standard in exercise science and prescription. CSEP offers four different certifications/specializations: (1) Certified Personal Trainer, (2) High Performance Specialist, (3) Clinical Exercise Physiologist, and (4) Pre and Postnatal Exercise Specialist.

#### What Can you do with CSEP Certifications/Specializations?

There are a variety of places you can work depending on the certification/specialization and your area of interest. Use the chart below to see who you can work with and general places to find employment.

#### Brief Overview of Certifications/Specializations

There are 4 possible certifications/specializations you can work towards while taking your kinesiology degree. Our kinesiology degree in and of itself covers most of the core competencies that CSEP requires, however there are a few additional electives that you **must** take if you want to become CSEP certified. Please use this document instead of the *"Recommended Course Maps"* on the CSEP website.

\*By taking KIN 4460 and KIN 4560 you will take the practical exam required by CSEP, all that you would have left to do is sign up to take the theory exam within 6 months of passing the practical exam.





#### CSEP-Clinical Exercise Physiologist Core Competencies

There are 8 core competencies that CSEP has determined are essential to have as a Clinical Exercise Physiologist. The chart below is "for your information," and outlines the core competencies. You may use this information to help you in your elective decision making (refer to page 5 for elective options), to see where your gaps in knowledge might be and choose courses accordingly. At the U of M, we want you to graduate with confidence in your theoretical and practical knowledge so you feel prepared to enter the workforce as the best CSEP-CEP you can be.

Core Competencies	Description
1 – Anatomy, Biomechanics, and Exercise Physiology	Functional anatomy, biomechanics, and exercise physiology as it applies to fitness assessment, exercise prescription, demonstration of exercise, and exercise education of the client(s) related to physical activity/exercise, fitness, and health. Exercise physiology and its application to submaximal and maximal exercise, acute bouts of exercise and chronic exercise (training) for both men and women of all ages. The impact of physical activity and exercise training on all of the body systems.
2 – Health Behaviour Change and Education	Health and exercise psychology and behavior change theory and application. Client education in areas of nutrition and weight management, sleep, sedentary behaviour.
3 – Client Pre-Participation Screen (& pharmacology)	Proper use of pre-screening tools and the ability to gather client subjective history. Describe the effect of common medications on rest and exercising responses
4 – Advanced Exercise and Health Assessment for Apparently Healthy Populations	Develop and select appropriate assessments and implement valid reliable testing protocols. Apply fitness assessment outcomes and fitness assessment normative data accurately and appropriately.
5 – Advanced Exercise and Health Assessment for Chronic Conditions	Develop and select appropriate assessments and implement valid reliable testing protocols for clinical population. Apply fitness assessment outcomes and fitness assessment normative data accurately and appropriately for clinical populations.
6 – Advanced Exercise Prescription for Apparently Healthy Populations	Development and design of appropriate exercise prescriptions that fulfill different needs of the individual (health-related fitness program). Application of appropriate training principles and lifestyle interventions to enhance aerobic fitness, anaerobic fitness, musculoskeletal fitness, balance, flexibility, and a healthy body composition. Demonstration of exercises and the use of exercise equipment. Monitoring activity and providing appropriate progression.
7 – Advanced Exercise Prescription for Chronic Conditions	Development and design of appropriate exercise prescriptions that fulfill different needs of the individual (health-related fitness program). Application of appropriate training principles and lifestyle interventions to enhance aerobic fitness, anaerobic fitness, musculoskeletal fitness, balance, flexibility, and a healthy body composition. Demonstration of exercises and the use of exercise equipment. Monitoring activity and providing appropriate progression. Knowledge of the physiology, pathophysiology, clinical management, contraindications, precautions and exercise modifications for the following: Cardiopulmonary, metabolic, pulmonary, musculoskeletal, neurological, cancer, musculoskeletal injuries, and mental health.
8 – Professional and Ethical Practice	Program Administration, including effective communication (oral and written). Statistics and Research Methodologies in Health and Fitness. Professional Ethics

#### **Frequently Asked Questions**

#### 1. Can I work towards my CSEP certification(s) if I am in BPE or AT?

a. Maybe. Working towards your CSEP-CPT would be easier as there are fewer requirements. However, if you wish to pursue your CSEP-CEP you still must take the required electives and courses that cover all core competencies. This means you must complete 120 credit hours of course work (which may be difficult for BPE students completing a 3-year degree). Accumulating the 100 practical hours would be more challenging as Supervised Fieldwork Experience is not part of the program; however, it could be done on your own time. If you are in AT, you cannot use your AT hours as practical hours for CSEP as the skills required for AT vs. CEP are quite different; however, it would still be your choice to apply and see what CSEP says.

#### 2. Where can I accumulate my practical hours?

a. Practical hours should be accumulated under the supervision of a CSEP-CEP. CSEP recommends gaining experience with MSK, pulmonary, neuromuscular, and cardiometabolic conditions. "Proof (for example, letter from Education Supervisor, or from Supervisor of work/volunteer experience, or logbook copy) of at least 100 hours of practical experience is REQUIRED." For more information please refer to their website: <u>https://csep.ca/csep-certification/csep-professional-standards-program-cep/csep-cep-prerequisites/</u>. Hours can be accumulated in a paid or volunteer position and is not limited to one location.

#### 3. What if I fail my theory and/or practical exams?

- a. You have two attempts at both exams (two attempts for the theory and two attempts for the practical). If you can't pass after two attempts, you can apply again to CSEP to take them a third time. If you are unsuccessful after three attempts, a waiting period is imposed, and you can apply to keep your file open. As well, it is recommended that you take an upgrade course in the specific area you are challenging through CSEP.
- **b.** Remember, if you pass one exam you still must pass the other in 6 months.

#### 4. How do I maintain my certification?

**a.** Every year you will have to renew your membership through paying a membership fee

#### 5. Do I have to renew my CPR and standard first aid every year to maintain my certification?

**a.** Every year you must renew your CPR, while standard first aid can be renewed every three years as designated by the organization you were trained by

#### 6. Do I need professional development credits to maintain my certification?

- **a.** CPT you must accumulate 20 hours every two years
- b. CEP you must accumulate 30 hours every two years

- **d.** Because the high performance and pre and postnatal are specializations they don't require additional PDC's because it assumed you have either your CPT or CEP already

#### 7. What is the difference between CSEP and Manitoba Fitness Council (MFC)?

a. MFC offers several certification courses, most of which focus on group training. For example, if you wanted to teach fitness classes like yoga or spin, MFC would be the organization to turn to. <u>https://manitobafitnesscouncil.ca/</u>




