## FROM THE DEPARTMENT HEAD

The Fall term is coming to a close, and it has been a busy term for all of us. The teaching program has been particularly busy, with our large graduate and undergraduate student enrolments this year. Thanks to all of our faculty members and support staff who have contributed to the successful delivery of these programs. We had an external review of our graduate program earlier this year, with a number of

recommendations made for improving and enhancing the program. As a follow-up to one of the program review recommendations, we brought in Dr. Kue Young, a former Head of CHS, in early October for an external review of the MPH program in particular, and he made some very pertinent observations and suggestions. Some of the graduate program review recommendations have already been acted upon, such as extending our graduate program admission deadline from November 30 to January 10, effective this year. The more substantive recommendations will be reviewed and discussed at a faculty retreat planned for the winter/spring of 2018.

A major restructuring of the Bachelor of Health Studies (BHSt) degree program, within the Interdisciplinary Health Program (IHP), has almost been completed, and after a lengthy review and modification process, Senate approval is expected in December. The new structure comprises three concentrations: Health Policy, Planning and Evaluation; Health Promotion and Education; and Family Health. Each student enrolled in the BHSt degree program must choose at least one of the concentrations, which consist of 18 credit hours from an approved list of concentration courses. The Family Health concentration was created in particular to ensure that those students who would previously have enrolled in the Family Social Sciences degree program would seamlessly be able to choose the

Family Health concentration in the BHSt degree program, as the same courses and program requirements would apply. Once the new BHSt program structure is approved, we will be able to begin the process of merging the current Family Social Sciences program into the IHP. We expect that the restructured BHSt program, as well as the recently restructured companion Bachelor of Health Sciences program, will attract a large number of students, and provide a strong pathway for graduate studies in CHS and in other departments in the Rady Faculty of Health Sciences.

Many of you will have noticed that our weekly colloquium series has been particularly well attended this Fall, with the Betty Havens Room at times filled to overflowing. This has in large part been due to enhanced student attendance, attributable to many instructors providing course marks for students attending a given number of colloquia. This new system will be reviewed and evaluated, but it has been great to see such good attendance, at least by students. Thanks to Brenda Elias and Michelle Driedger for facilitating this innovation. Now any suggestions for improving faculty member attendance will be welcome!

As most of you know, I will be on administrative leave for the calendar year 2018, returning in 2019, so this will be my last newsletter until then. Sharon Bruce will be Acting Department Head in 2018, and Lisa Lix Acting Associate Department Head, and I'm sure that the transition will be smooth. Another important upcoming milestone is that Kathy Bell, who is the glue that has held the Department together for many years, will be retiring on January 31, 2018. We are in the process of recruiting a replacement, but Kathy will be sorely missed. Her knowledge of the Department, the College, the Faculty and the University, her effective and efficient work, her conscientious approach, her attention to detail, and her sunny disposition will be impossible to replace. My heartfelt thanks to Kathy for all of the support that she has provided to me over the past five plus years, and we all wish her a happy and healthy retirement, with her rapidly expanding extended family.

Hope to see many of you at the CHS holiday potluck on December 14 at 12:00 noon in the Betty Havens Room, and we will take that opportunity to formally say goodbye to Kathy. Have a fine holiday season and a great 2018.

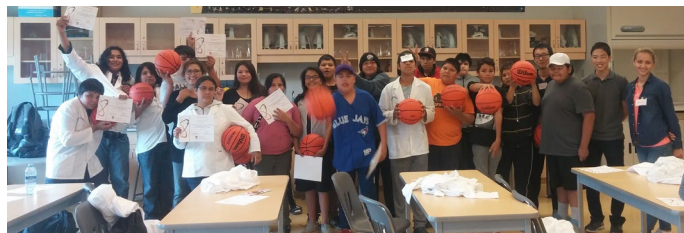

### BIOMEDICAL YOUTH PROGRAM

From July 17-21, over 100 camp participants from Grades 5-12 participated in the annual BYP camp at Bannatyne. Fifteen students from northern Manitoba also attended the camp as part of their ACCESS Program careers in health week. Students came from Garden Lake, Cross Lake, Thompson, Flin Flon and various other First Nations and northern communities. Over fifty volunteers make this week-long camp possible – thank you to all!

Karen Cook and students from the Max Rady College of Medicine and College of Rehabilitation Sciences travelled to Opaskwayak Cree Nation from July 24-28 to offer the BYP camp to First Nations youth from 13-15 years. The youth enjoyed many of the hands-on activities facilitated by RFHS student volunteers. While at OCN, we also participated in the “Mad About Science” camp hosted by the Town of The Pas. Students facilitated sessions during the morning to a young group of participants, ages 5-9 years. During our week there, RFHS students also participated in daily job shadowing at the RHA in The Pas. All conveyed how valuable the experience was!

## ORIENTATION WEEK ACTIVITIES

On September 15, 480 incoming Rady Faculty of Health Sciences students visited various agencies in the community to learn about services/programs and available service learning and volunteering opportunities.

Community Engagement staff worked with the Office of Interprofessional Collaboration to coordinate these activities, including a debrief session at the end of the day.

## MAX RADY COLLEGE OF MEDICINE – SERVICE LEARNING

As of October 2017, there are now 220 med students completing community-based service learning as part of their Population Health course. Students are completing their hours at approximately 25 different inner-city agencies such as Child and Family Services, Boys & Girls Club, Spence Neighbourhood Association, House of Peace, Bear Clan and many others. Students remain with the same agency for their first two years of med school. Community Engagement staff worked with UGME to coordinate placements.

## CANU PROGRAM

The CanU Program started again on Thursday, October 26 and runs for thirteen weeks. Participants from the local community will meet at Bannatyne each Thursday and participate in various health science activities led by student volunteers from all colleges in the Rady Faculty of Health Sciences. The Bannatyne program has grown since it started in 2014 and now hosts close to 80 Grade 7-9 participants and approximately 100 RFHS student volunteers! Thank you to all for contributing to the success of the program.

## MANITOBA RESEARCH DATA CENTRE

The Manitoba RDC is a place for faculty and students to access confidential Statistics Canada microdata, located at both the Bannatyne Campus (390 Brodie) and the Fort Garry Campus (228 Helen Glass). Below is a summary of some of the newest data that is available to researchers:

### (1) Call for Proposals – Longitudinal Immigration Database

The Longitudinal Immigration Database (IMDB) combines linked administrative immigration and tax data files for persons who obtained permanent resident status since 1980 and filed at least one tax return since 1982, followed longitudinally. The data are combined from administrative files through exact matching record linkage techniques. The IMDB brings together immigration from IRCC, taxation data from the Canada Revenue Agency ([Annual Income Estimates for Census Families and Individuals –T1 Family files](#)), and the date of death from Statistics Canada's Amalgamated Mortality Database (AMDB). It is a comprehensive source of data on the socio-economic outcomes of the immigrant tax filer population in Canada. The IMDB provides detailed and reliable information on the labour market behaviour of different categories of immigrants over a period that is long enough to assess the impact of characteristics at admission, such as education and knowledge of French or English. The database also provides information on pre-admission work or study experience in Canada, provincial mobility and family composition. Proposals are due December 22, 2017, and you can contact the Manitoba RDC for more information.

### (2) Call for Proposals – Extended Longitudinal Survey of Immigrants to Canada

The Longitudinal Survey of Immigrants to Canada (LSIC), an immigration panel survey, and tax data information from the Longitudinal Immigration Database (IMDB) have been combined to provide an extended analytical file (LSIC-IMDB). Topics covered in the survey include language proficiency, housing, education, foreign credential recognition, employment, health, values and attitudes, the development and use of social networks, income, and perceptions of settlement in Canada. Latest additional socio-economic outcomes are then provided from tax filing information. The target population for the LSIC survey consists of immigrants who meet all of the following criteria: arrived in Canada between October 1, 2000 and September 30, 2001; were age 15 years or older at the time of landing; landed from abroad, must have applied through a Canadian Mission Abroad. Refugees claiming asylum from within Canada are also excluded from the scope of the survey. To be linked to the IMDB, the respondent will have filed at least one tax return since 1982. Proposals are due December 22, 2017, and you can contact the Manitoba RDC for more information.

### (3) Canadian Community Health Survey 2000-2011 linked to the Discharge Abstracts Database 1999-2012

These datasets allow researchers to link the Discharge Abstracts Database to a given Canadian Community Health Survey year. For an example, researchers can refer to this [Health Reports article on nutritional risk and hospitalization](#).

### (4) Graduate Fellowship Awards

Every year, the Manitoba RDC offers up to 5 awards of \$5000 to graduate students who are using Statistics Canada data at the Manitoba RDC for a part or all of their thesis / dissertation. The call for applications generally goes out in February, and students can apply for the award before they have access to the RDC. ### (5) Post-Doctoral Opportunity with Statistics Canada

The Statistics Canada Post-Doctoral Fellowship provides recent PhD graduates with the unique opportunity to conduct high quality research at one of the world's leading statistical agencies. The research conducted at Statistics Canada advances knowledge on emerging issues related to Canadian society and informs Canada's policies and programs.
