Professor Chow drew attention to item \#3.1 about the elimination of systemic barriers (page 172), and she asked about the purpose of these employment systems reviews. She also wanted to know how the information would be used, and whether any reports would be published.

Dr. Galloway responded that this was the second group of Faculties and Schools which were undertaking the process of employment systems reviews. These reviews were a commitment made by the University of Manitoba to the Federal Contractors Programme, and the University would be reporting to the Federal Contractors Programme when the reviews had been completed. Dr. Galloway anticipated that the Faculties would be circulating the reports internally. Some may also choose to make those reports public, but that would be their decision.

Professor Gabbert wished to thank Ms. LeMere for the comprehensive and useful account of the activities of the office.

Professor Vessey thought that the workshops were an excellent idea, but he wondered whether the information could be published in the form of pamphlets and brochures for those individuals who were unable to attend the workshops.

Mr. Bradshaw responded that the suggestion would be considered, although the workshops were intended to be interactive.

With regard to case \#054 (page 165), Professor Stimpson asked whether that same benefit would now be extended to all staff members.

Ms. LeMere responded that this case had been resolved for that particular individual. She did not know whether the University policy had been revised, as that would be the responsibility of the Staff Benefits Office. She however did not expect similar problems in the future.

Further to item \#3.3 on special measures and reasonable accommodation (page 172), Professor Feld asked whether items such as loudspeaker systems and large print material would be made available for an aging professoriat.

Dr. Galloway replied that she had conducted some preliminary investigations in this regard, although there were limited funds available for the purchasing of equipment.

Mr. McAdam indicated that he would look into the possibility of a loudspeaker system for the Senate Chamber. He agreed that these were serious issues, and suggested that Deans and Directors should comment about their own facilities in their budget submissions.

## IV REPORT OF THE PRESIDENT

Dr. Szathmáry noted that the University of Manitoba had gone up to $13^{\text {th }}$ from $15^{\text {th }}$ in the annual McLean's survey and ranking of Canadian universities. This was basically due to the way in which the magazine weighted the various factors and categories. The real issue was finding a way for the University to improve its standing in the reputational portion of the survey, where it had placed $15^{\text {th }}$ out of 15. The overall response rate in this most-heavily-weighted category had been only $13.4 \%$. Dr. Szathmáry indicated that members of the professoriat as well as students had a role to play here, and she encouraged individuals to think about the implications of this information.

The University would be receiving a $\$ 1$ million endowment to support its Icelandic Collection in the Libraries as well as the Department of Icelandic. This was an extraordinary sum of money, especially in light of the small population of Iceland (between 250,000 and 280,000).

The Presidents of Manitoba's universities had met with the Premier and the Minister of Training and Continuing Education, and they had been told that education was second only to health care on the government's agenda. Although the new government had encountered some unexpected deficits, it was their intention to honour their election promise of a $10 \%$ reduction in student tuition fees. The University of Manitoba had modeled its budget submission on the expectation of a $5 \%$ tuition increase and a 2\% increase in operating grant. Obviously, some other model would now have to be pursued, and Dr. Szathmáry encouraged Senators to stay tuned for future developments.

Professor Gabbert suggested that the first sentence of the ninth paragraph on page 3 be amended to read: "With regard to appeals, Professor Gabbert observed that there did not seem to be very much protection for faculty members, and he suggested that the language of the collective agreement respecting appeals, tenure and promotion cases be added to section 3.7.1 (page 156) [change shown in bold face].

Professor Duckworth suggested that the fourth paragraph on page 4 be amended to read: "Professor Duckworth thought the appeals arrangements were sensible, as it would not be possible to have an appeal on substantive grounds to a body less qualified to judge the technical aspects of a research proposal" [change shown in bold face].

Dr. Lobdell suggested that the word "additional" be struck from the third paragraph in item III. 3 on page 5. The sentence would then read: "Ms. Sawicki added that only those proposals where the University was requesting funding from COPSE had to be approved by COPSE".
