## VI REPORT OF THE PRESIDENT

Dr. Szathmary reminded Senators that the provincial government is presenting its annual budget this afternoon. It is her belief that the government intends an expansion of the community college system, as well as a $10 \%$ reduction to tuition fees. This will likely mean a difficult year for the University of Manitoba.

There are however also many things to be proud of, including the recent ground-breaking ceremony for the new grain handling and storage facility, as well as the beautification of Chancellor Matheson Boulevard, where some 405 elm trees have been planted.

Dr. Keselman expressed congratulations to Professor Judy Anderson (Human Anatomy and Cell Science), who has recently discovered a method of triggering muscle growth. This was met with a round of applause.

Dr. Gardner expressed concern that the operating grant is being announced so late this year, as the institution is already well down the track of scheduling courses for the fall term. He added that the decanal searches for the Continuing Education Division and the Faculty of Human Ecology are nearing completion.

Dr. Gardner drew attention to the upcoming Convocation sessions, and he encouraged Senators to attend. As always, a high point for him had been the recent UMSU-sponsored Student/Teacher Recognition awards, and he expressed congratulations to Professor Michael Feld (Philosophy) and Professor Norm Halden (Geological Sciences), both of whom had received awards. This was met with a round of applause.

Dr. Szathmáry echoed Dr. Gardner's remarks about the importance of attending Convocation.

Ms. McCallum invited individuals to participate in the annual sneaker day on May $17^{\text {th }}$, and in the $3^{\text {rd }}$ annual campus beautification day on May $24^{\text {th }}$.

## VII QUESTION PERIOD

1. The following question was submitted by Professor Kevin Vessey (Agricultural and Food Sciences):
"For our University to be able to apply for Canada Research Chairs in 2000-2001, we must submit a Strategic Research Plan to the program by September 1, 2000. To quote the Program Guide for the Canada Research Chairs:
"The president/rector/principal of an eligible university is accountable for the strategic research plan, which must be supported by the university's most senior planning body."
"Could Senate please be informed as to the efforts that are being made to develop the University's Strategic Research Plan and to what extent Faculty and School Councils and Senate will be involved in the development of this plan?"

Dr. Keselman explained that a call for proposals was being sent to Deans and Directors, together with the program guidelines.

With regard to the Strategic Research Plan, Dr, Keselman made four points:

1) the Senate Committee on University Research has been engaged in a University-wide assessment of expertise in research;
2) the Canada Foundation for Innovation (CFI) program required justification of those projects which were submitted;
3) with regard to units not involved in the CFI program, many have already developed strategic plans; and
4) the call for proposals requires units to articulate their plans and priorities.

Dr. Keselman and Dr. Gardner intend to compile all this information and prepare a draft Strategic Research Plan, which will be circulated for commentary from the Senate Committee on University Research and may then undergo further refinement. The process therefore involves input from the grass roots in the formulation of the plan. The Senate Planning and Priorities Committee will have an opportunity to comment on allocations under the Research Plan.
2. The following question was submitted by Professor Peter Blunden (UMFA assessor):
"The Faculty Association is concerned about the new diploma Nursing Program which is to be offered at Red River Community College commencing this September. We understand that our administration has agreed to the use of the Faculty of Nursing's detailed curriculum as a basis for the diploma program at Red River. Please inform Senate on these recent developments and on the nature and content of any such agreement. Please outline the steps you have taken to protect the rights of individual faculty members with regard to course materials they have developed."

Dr. Gardner advised that no agreement has been signed with regard to the diploma Nursing Program at Red River College. He added that Canadian copyright law and the UMFA agreement do protect the creator/owner of intellectual property, but that
questions remain on the issue of what is owned by whom. The use of someone's curriculum material by another institution has not yet been challenged, and Dr. Gardner believed the University would have a difficult time making the case that its curriculum is owned by it. Course materials however are another issue entirely.

Professor McKay stated that the Faculty of Nursing is concerned that University courses are being used to produce diploma graduates, which would be an inappropriate use of the material.

Dr. Gardner responded that, under provincial legislation, this is an issue for the accrediting body of the province and not the University.

Committee on Academic Computing on Faculty Workstation Replacement Costs

The Committee on Academic Computing notes that the cost of replacing faculty workstations is a major concern, as access to computing and networking facilities is a crucial tool for academic teaching and research.

The report only deals with workstations attached to Novell networks, and likely underestimates the true costs of replacement of obsolete computers. Consequently, the Committee recommends that a full audit of desktop equipment be conducted by faculties, schools and administrative units.

Dean Secco thought that the report gives the sense that the equipment listed on page 94 is funded by the University's operating grant, which is often not the case. He expressed concern that Senate was being asked to endorse that assumption, and suggested that the source of funding should be included in the audit.

Dr. Lobdell indicated that Senate was only being asked to approve the recommendation that an audit should be done, and he added that the audit should make use of all existing information available.

Mr. Leclerc advised that the Senate Executive Committee endorsed the report to Senate.

MOVED by Dr. Lobdell, seconded by Dean Dronzek, THAT Senate approve the recommendation that a full audit of desktop equipment be conducted by Faculties, Schools and Administrative Units (as recommended in the report of the Senate Committee on Academic Computing dated March 29, 2000).

The purpose of this stream is to attract students holding a degree in Arts or Science or having achieved substantial progress towards a degree. The stream is designed to be taken in an accelerated manner, with students able to complete all program requirements in two years and four months.

The Faculty proposes to reintroduce the former transfer student admissions category, as students applying with a first degree may not have all of the requirements of University 1.

Mr. Leclerc advised that the Senate Executive Committee endorsed the report to Senate.

The proposed revisions to this policy were first considered at the Senate Executive Committee meeting in November of 1999. At that time, the Executive Committee suggested a number of further revisions, which were subsequently referred to Legal Counsel for advice and drafting.

The policy was considered again at the Executive Committee meeting of January 19, 2000, at which time it was endorsed to Senate. Subsequent to that meeting but before the February Senate meeting, a number of further revisions were made, and the revised policy was forwarded to UMFA for their consideration. No comments were made by UMFA within the time period set out in the UMFA Collective Agreement.

With regard to section 2.3 .3 (page 105), Dean Secter noted that the use of the word "shall" will require the University to comply, and he cautioned against mandating something which may be counterproductive.

On behalf of the Committee on University Research, Dr. Glavin agreed that the first sentence of section 2.3 .3 should be revised to read: "During the first year of the appointment, appointees to Chairs and Professorships shall normally be required to give a public lecture" [change shown in bold face].

Mr. Leclerc advised that the Senate Executive Committee endorsed the report to Senate.

MOVED by Dr. Glavin, on behalf of the Committee on University Research, THAT Senate approve and recommend to the Board of Governors the report of the Senate Committee on University Research on proposed revisions to

## 5. Report of the Senate Committee on Appeals

Warden Hoskins advised that, since last reporting to Senate, the Senate Committee on Appeals has completed work on four appeals.

The first appeal, held on March 10, 2000, was an appeal against the Faculty of Engineering decision that a student was ineligible to proceed in his program. The grounds cited were extenuating personal circumstances and that the student had been given poor advice by the Faculty. This appeal was denied.

The second appeal, held on March 20, was an appeal against the Faculty of Education decision to debar a student from the 21 credit hours of courses remaining to finish the student's B.Ed. degree. The grounds cited were extenuating personal circumstances. This appeal was denied.

The third appeal, held on April 18, was an appeal against the Faculty of Arts decision not to grant retroactive authorized withdrawals from the 1988 and 1989 regular sessions or allow the appellant to "start afresh". The grounds cited were extenuating personal circumstances. This appeal was upheld, with the remedy being a retroactive authorized withdrawal from all courses taken in the 1988 and 1989 regular sessions.

The fourth appeal was considered by the Senate Appeals Committee at a meeting on April 24, and was from the Faculty of Graduate Studies. The Committee decided not to hear this appeal since, in its view, the appeal was requesting a decision and a remedy which were outside the Committee's terms of reference.

## 6. Report of the Senate Committee on Nominations Page 107

Two students need to be nominated to serve on the Senate Committee on Appeals, namely:
a) one as an alternate (to fill an existing vacancy); and
b) one as a regular member (an additional student committee member as recommended by the Ad Hoc Committee on Committees and approved by Senate in April 2000). This additional position will help create a larger pool from which to draw when setting hearing panels.

Mr. Leclerc advised that the Senate Executive Committee endorsed the report to Senate.

MOVED by Dean Dronzek, on behalf of the Committee on Nominations, THAT Senate approve the student nominees to the Senate Committee on Appeals (as recommended by the Senate Committee on Nominations in its report dated April 25, 2000).

## XII ADDITIONAL BUSINESS

## 1. Libraries Consolidation Update

Ms. Presser advised that the last report to Senate on the Libraries Consolidation Project was made in February 1999. That report outlined the five phases of the project and the progress to that date.

Since that time, no further activity has taken place. There are three reasons for this inaction:
a) the Pan American Games activity on the campus meant that no construction or renovations could take place during the summer of 1999;
b). the Nursing Faculty was temporarily located on the second floor of the Dafoe Library for a period of 18 months, precluding any further work in that building; and
c) no funding was allocated for the project in 1999/2000.

Activities remaining to complete the entire project include:
a) additional work in the Dafoe Library, including shifting the entire collection to integrate the Education, Slavic and Management Collections;
b) create the appropriate space in the Management Library to transform that library into a Management Information Centre;
c) construction of the Remote Site Storage Facility; and
d) construction of a new Architecture/Fine Arts/Music Library, part of the University's Capital Campaign.

## 1 MATTERS TO BE CONSIDERED IN CLOSED SESSION

1. Report of the Senate Committee on Honorary Degrees Hand-out

Dr. Gardner, Vice-President (Academic) and Provost, assumed the Chair for this portion of the meeting.

The report was circulated at the meeting.
MOVED by Dr. Szathmáry, on behalf of the Senate Committee on Honorary Degrees, THAT Yash P. Gupta, Peter Michael Liba, Flora MacDonald, David Oddsson and Gerard Van Walleghem be approved by Senate as candidates for honorary degrees.
(The candidates received the required two-thirds majority of those voting and were approved as candidates for honorary degrees.)

Dr. Szathmary then informed Senate of the following items which have been approved by the Committee on Honorary Degrees:
a) Spaces in the Helen Glass Centre for Nursing were named as follows:

- Victorian Order of Nurses Home Care Lab
- Manitoba Association of Registered Nurses Clinical Education Facilitators Work Space
- Victoria General Hospital Post RN Student Office
- Grace General Hospital Undergraduate Student Office.
b) Streets in SMARTpark were named as follows:
- Technology Trail
- Innovation Drive
- Research Road
- RH Way.

Dr. Szathmary advised that the Committee on Honorary Degrees considered a proposal to name the Faculty of Management The I. H. Asper School of Business. This will honour Dr. Asper's achievements, while at the same time it will establish the Faculty of Management as one of Canada's leading business schools. The proposal was passed unanimously at the Management Faculty Council meeting on May 4, 2000.

MOVED by Dr. Szathmary, on behalf of the Senate Committee on Honorary Degrees, THAT Senate approve that the Faculty of Management be named The I. H. Asper School of Business, subject to the University Administration executing a mutually agreeable contract(s) with the Asper Foundation.

Dean Gray explained that it will still be the Faculty of Management within the University, whereas publicly it will be known as the Asper School. He added that "Faculty" is a uniquely Canadian term, but that "School of Business" is recognized globally.

A number of Senators expressed concern that the Faculty's academic freedom should be protected in the contract, and Dean Gray assured Senate that would be done.

Dr. Szathmáry's motion was CARRIED.
Professor Gabbert suggested that, in future, additional information on draft contracts should be provided to Senate. Dr. Szathmary took his suggestion under advisement. She noted that normally contracts are not disseminated, and we have not been able to obtain copies of the full text of contracts from Canadian institutions. Further, there are two parties to each contract and the parties may cite confidentiality of their agreements.

Senators were reminded about the importance of keeping this matter confidential until they are advised that a contract(s) has been executed with the Asper Foundation.

The closed session was adjourned and Dr. Szathmáry assumed the Chair.
