Mr McAdam advised that the University has received a 2.5\% increase in operating grant this year, as well as some $\$ 14.8$ million in capital funding. Full details of this year's budget are available on the University's web site. Mr McAdam encouraged all members of the University community to participate in Campus Beautification Day on May $24^{\text {th }}$.

Dr Gardner noted that applications to first year are up by 3-5\% over the same time last year.

Dr Keselman indicated that there are three new Canada Research Chairs at the University of Manitoba. The opening of the Manitoba First Nations Centre for Aboriginal Health Research was held on April $26^{\text {th }}$.

In answer to an expression of concern that in the past Faculties and Schools have had to use retirement funds to balance their budgets, Mr McAdam agreed there is a need for additional flexibility within units' budgets.

A question was raised about the status of the shuttle bus, and Mr McAdam replied there will continue to be two buses operating, with an additional bus scheduled to run between the Health Sciences Centre and St Boniface Hospital. In addition, attempts are being made to make one bus wheelchair accessible.

The Vice-President (Academic) and Provost advised that the midwifery proposal has been submitted to COPSE, together with a request for funding. No response has been received to date.

Dr Szathmáry attended an alumni reception while she was in Hong Kong. She also took part in the annual graduation pow wow activities.

## a) Report of the Senate Planning and Priorities Committee

Page 123
The Faculty of Graduate Studies is proposing the establishment of an interdisciplinary graduate degree program in disability studies. "The master's degree will build on the firm foundation of knowledge and skills developed during undergraduate studies from one of a variety of disciplines. The program is designed to build an appreciation for and an application of disability studies across the students' chosen disciplines of expertise."

It is intended that the program will commence in September of 2001, with an anticipated enrolment of 5-10 students.

Dean Secco introduced the following individuals, who had been involved in the development of the proposal: Dr Henry Enns, Professor Zana Lutfiyya and Ms Laurie Ringaert.

Dr Enns advised this has been a very exciting initiative and has involved a great deal of consultation with the disabled community.

Professor Lutfiyya indicated that the following Faculties have been involved in the development of this proposal: Architecture, Education, Medical Rehabilitation, Nursing, Social Work, and Physical Education and Recreation Studies.

Professor Halden stated that the Planning and Priorities Committee is recommending approval of the proposal, provided that:
a) implementation not be authorized until sufficient new long-term funding is available; and
b) administrative responsibility and reporting lines are clearly identified.

Dean Stimpson advised that the Senate Executive Committee endorses the proposal to Senate.

It was MOVED by Dean de Toro, seconded by Professor Feld, THAT Senate approve and recommend to the Board of Governors the proposal from the Faculty of Graduate Studies dated March 13, 2001 for a Master in Disability Studies (subject to the report of the Senate Planning and Priorities Committee dated April 9, 2001).

## CARRIED

The Vice-President (Academic) and Provost wished to acknowledge Professor Wendy Dahlgren for her assistance in the development of this proposal. This was met with a round of applause.

## 2. Report of the Senate <br> Committee on Academic Review with Respect to Periodic Review of Graduate Programs

Page 125
A proposal for the periodic review of graduate programs has been developed by the Faculty of Graduate Studies in response to the Task Force on Strategic Planning. The proposal recommends that graduate programs be reviewed on a seven-year cycle, which will mean about 18 programs being reviewed each year. The process is to begin in September 2001.

Dr Gardner advised that the Board of Governors has approved baseline funding for this proposal.

A number of concerns were expressed, including the following:

1. re the financial commitment (page 147): although it is good to see funding being made available to the Library for this, the individual departments' needs should be recognized as well;
2. this will generate a great deal of work and expense;
3. there are a number of processes already in place to review graduate programs; and
4. the proposal appears to give the Dean of Graduate Studies the power to eliminate graduate programs.

The following responses were given:

1. other institutions do not provide funding to individual units for this type of review;
2. while it is true that this will require a great deal of work, the results will be worthwhile in terms of being competitive with graduate programs elsewhere in the country;
3. while the process will not be identical to the accreditation reviews, every attempt will be made to coordinate the two in order to reduce duplication as much as possible; and
4. policy 411 states that "it is the President who approves changes to, or the introduction of, enrolment limits following consultation and discussion with the Dean or Director and with Senate".

Dean Stimpson advised that the Senate Executive Committee endorses the report to Senate.

It was MOVED by Dr Gardner, seconded by Dean Collins, THAT Senate approve the report of the Senate Committee on Academic Review dated March 26, 2001 with respect to the periodic review of graduate programs.

## 3. Report of the Senate

Committee on University Research on a Proposal to Establish a Chair in Internal Medicine

Page 148
Section 2.1 of policy 428 on Chairs and Professorships outlines the steps to be followed in the establishment of Chairs or Professorships. In accordance with that policy, the Senate Committee on University Research is recommending the establishment of a Chair in Internal Medicine. The proposal was developed by the Faculty of Medicine.

This Chair will "provide leadership, scholarship and mentorship in clinical research in an area of research priority for the Department of Internal Medicine at the University of Manitoba. The primary objective of this Chair is to enhance clinical research activity and, in so doing, the overall research profile of the Department of Internal Medicine and the Faculty of Medicine".

The Chair will be funded through investment income from the H E Sellers Fund.
In answer to a question about the level of support available for the Chair, the VicePresident (Research) explained that the Administration determines minimum values for all newly-established Chairs and Professorships. The current minimum for endowed Chairs is $\$ 2$ million, and the funding in this instance is well above that amount.

Dean Stimpson advised that the Senate Executive Committee endorses the proposal to Senate.

It was MOVED by Dr Keselman, seconded by Dean Hennen, THAT Senate approve and recommend to the Board of Governors the proposal to establish a Chair in Internal Medicine (as set out in the report of the Senate Committee on University Research dated March 26, 2001).
