## 1. Report of the Senate Committee on Honorary Degrees

## II MATTERS RECOMMENDED FOR CONCURRENCE WITHOUT DEBATE

1. Report of the Senate Committee on Curriculum and Course Changes: Part A

The Senate Committee on Curriculum and Course Changes met on six occasions in the month of October, 2002 to consider requests from various units for course and curriculum changes of less than 10 credit hours per department.

Professor Dronzek noted that the fourth line from the top of page 22 should read "Transportation Principles" as opposed to "Transportation Policy".

It was also noted that the notations for course changes had been amended by the handout distributed at the door. It was further noted that references to 002.277 and 002.278 should also include the phrase "or 060.277" or "or 060.278" respectively, as they are also offered with microbiology course numbers.

With regard to the course changes in the Department of Anthropology, as described on page 18, should be amended by deleting the words "binary classifications of social and physical anthropology" and replacing them with "outdated dichotomous classifications". It was also noted that course 076.244 Peasant Society and Culture should be noted on page 41 as a course to be deleted from the Global Political Economy List of Suggested Electives.

It was MOVED by Professor Dronzek, on behalf of the Committee, THAT Senate approve the report of the Senate Committee on Curriculum and Course Changes Part A dated October 8, 2002.

## 2. Report of the Faculty Council of Graduate Studies re: a proposed Master's <br> Practicum Stream in Pathology

The Faculty of Graduate Studies is proposing the introduction of a Master's Practicum Stream within the existing M.Sc. In Pathology. The proposal was approved by the Faculty Council of Graduate Studies on May 23, 2002.

Professor Sparling advised Senate that the Senate Executive Committee endorses the report to Senate.

3. Proposed Academic Schedule for 2003-2004

Page 72
The 2003-2004 academic schedule was prepared by the Director of Student Records. It has been reviewed by each Faculty and School, the Director of Admissions and Rabbi Stern (re: religious holidays).

Professor Sparling advised Senate that the Senate Executive Committee endorses the report to Senate.

Professor Duckworth asked why the Voluntary Withdrawal date could not be set at November 15 rather than changing each year. Mr. Marnoch noted that the changing date each year occurs to allow equity in the number of teaching days prior to the VW deadline. Professor Dronzek noted that the current practice was a based on a formula regarding teaching days and has been in place for a number of years.

It was MOVED by Professor Duckworth, seconded by Professor Cooper, THAT the proposed Academic Schedule be amended by making November 15 or the next business day, if November 15 falls on a weekend, the Voluntary Withdrawal date every year.

Professor Taylor noted that if we were to set a fixed date, the decision should be in the best interests of students, noting that the current system provides students sufficient exposure to course materials and evaluative feedback.

Professor Dronzek, in speaking against the motion, noted that the VW deadline currently represents two-thirds of the course having been completed, and noted that a simple November 15 date is arbitrary and does not address the second term.

It was MOVED by Professor Bright, seconded by Dean Wiens, THAT Senate approve the proposed academic schedule for 2003-2004 [under cover of a memorandum from the Director of Student Records dated November 7, 2002].

## III MATTERS FORWARDED FOR INFORMATION

1. Report of the Senate Committee on Awards

Page 78
At its meeting on October 30, 2002, the Senate Committee on Awards approved 13 new awards and eight award amendments [as set out in the report of the Senate Committee on Awards dated October 30, 2002]. All these award decisions comply with the published guidelines of November 3, 1999, and are reported to Senate for information.

In response to questions about the value of the Thompson Prizes, Ms. Cindric noted that this is a usual occurrence in the Faculty of Law, with Dean Secter adding that the new prizes would, in fact, be "topping-up" existing prizes.
2. Program Accreditation - 2002 Update

Page 85
Each year, the Vice-Provost (Programs) provides Senate and the Board of Governors with an annual update on Program Accreditation at the University of Manitoba.

Dr. Lobdell noted that the Dentistry has recently received full accreditation for all of its programs.

He also noted that the visits by accreditors are very helpful and welcome and that their questions are well put and help to improve programs. Dr. Lobdell also noted that future accreditation reports may be placed on the University web site in order to reduce the amount of paper used and to update the summary as new information comes in.

Dean Jamieson noted that Canadian Computer Science Accreditation Council has recently granted the Computer Science Program a 3 year accreditation. He also pointed out that the past chair of the Canadian Computer Science Accreditation Council is Science Senator Professor Peter King.

Dean Jamieson also observed that accreditation for the University's Chemistry program is imminent.

With regard to page 99 of the agenda, Professor Graff noted that like with department of Psychology's accreditation, the American Psychological Association
provides the Predoctoral Internship Training Program in Clinical Psychology with international accreditation.

Dr. Szathmáry also noted that AUCC is being pressured by a number of foreign countries to provide a solution to the absence of accreditation for Canadian Universities since Canada has no federal ministry of education. Dean Hennen also noted that Research Ethics Boards are facing similar pressures to put in place national accreditation standards.

## 6. Report of the Senate Committee on Appeals

As Dr. Hoskins had another commitment, Senate agreed to hear this report out of order.

Dr. Hoskins noted that since last reporting to Senate, the Senate Committee on Appeals has completed work on three appeals.

The first of these was heard on October 31, 2002 and was an appeal against the Faculty of Law decision to permanently withdraw the appellant from the program in Law. The grounds cited were compassionate and medical. The Senate Committee on Appeals considered that this constituted two appeals and made the following motions:

1) "THAT the Senate Committee on Appeals deny the appeal from the appellant for Retroactive Authorized Withdrawals from the Faculty of Law for all courses taken in the 01 Regular session.
2) THAT the Senate Committee on Appeals grant the appeal to write the deferred Contracts 2002 Final Exam with reasonable accommodation, as defined by the University of Manitoba's Disability Services, and that privileges to write a supplemental exam for this course still be available to the student, should the student not achieve the required mark as set out in the Exam and Prize Regulations of the Faculty of Law."

The second appeal was held on November 4, 2002 and was also an appeal against a Faculty of Law decision to permanently withdraw the appellant from the program in Law. The grounds cited were compassionate. This appeal was denied.

The third appeal was held on November 12, 2002 and was an appeal against the Faculty of Engineering decision not to grant the appellant a retroactive voluntary withdrawal from a course taken in the 2001-2002 regular session. The grounds cited were procedural irregularities. This appeal was granted.

## IV REPORT OF THE PRESIDENT

## 1. President's Report December 4, 2002

Page 107
In addition to the written report, Dr. Szathmáry noted her letter to the Chair of the Board of Governors regarding the University's placement in the annual Maclean's rankings of Universities. The President pointed out that $11 \%$ of the ranking is based on students incoming grades at admission, rather than being based on that which they accomplish while at the University. She was pleased to note that the new publication of distribution of the entrance grades of incoming students at all participating universities shows that University of Manitoba ranks $5^{\text {th }}$ nationally (tied with Waterloo) in the percentage of new students with entrance averages of $95 \%$ or higher.

Dr. Szathmáry also reported that the Strategic Planning Committee had met on number of occasions was reviewing the 40-plus submissions received.

Dr. Kerr reported that he had recently met with the Dean of Arts the Head of English regarding the "W" course designation and the Dean of Science and the Head of Mathematics regarding the " M " designation, noting that this was the starting point for a review of such course designations.

He also noted that he has met with representatives of colleges and universities in Manitoba and the new deputy minister of Advanced Education, reporting that there is a great deal of interest in expanding cooperation amongst institutions.

Mr. McAdam thanked members of the University Community for their responses to the first IST discussion paper and noted that the second version of the report is currently in development.

Ms. Goldie reported on two successful alumni receptions, one in Toronto on November 23 and the other in Minneapolis on December 3. She also reported that On Manitoba will be mailed to alumni in the next week.

The gala finale to the $125^{\text {th }}$ Anniversary celebrations was held at the Winnipeg Symphony Orchestra and was well received. With regard to the capital campaign, Ms. Goldie reported that $\$ 177.7$ million has been raised.

Professor Dronzek noted that the Committee reviewed more submissions than anywhere before, some 1825 pages and recognized the work of units in revamping, and changing their programs.

Professor Halden added that the level of curricular change is high and that SPPC notes that such renewal is very good for the institution.

Professor Sparling advised Senate that the Senate Executive Committee endorses the reports to Senate.

Professor Duckworth note that Women's Studies proposed courses use popular culture references and wondered if it was wise to use such references in course titles.

Professor Janice Dodd, coordinator of the Women's Studies program took Professor Duckworth's comments under advisement and noted that the course titles and descriptions were drafted in such a way as to entice student to think about the course content and to be interested in the courses.

Professor Kaminski wondered whether the reference to "Riot Grrrls" on page 146 of the agenda was a spelling mistake or onomatopoeia. It was noted that it was onomatopoeia and that "Riot Grrrls" is a designation for feminist activists who are involved in independent music production.

It was MOVED by Professor Dronzek, on behalf of the Committee, THAT Senate approve the report of the Senate Committee on Curriculum and Course Changes dated October 7, 2002 and the report of the Senate Planning and Priorities Committee dated October 27, 2002.

The Faculty of Medicine is proposing the introduction of a Bachelor of Allied Health Science (Radiation Therapy). The program will consist of University 1 plus 3 years and will be offered in partnership with CancerCare Manitoba. The proposal has been reviewed and endorsed by both the Senate Committee on Curriculum and Course Changes and the Senate Planning and Priorities Committee.

Professor Cooper noted that this is the first of four Allied Health Science degree proposals to come to Senate, and that these programs are being developed to meet needs in the health care sector and with licencing bodies. She introduced Ms. Tricia Van Denakker, Program Implementation Coordinator for the Allied Health Science Programs and acknowledged her efforts in the development of this program.

In response to a question, Professor Cooper noted that MRI technicians are not covered under this program and that they are currently trained by Red River College. Dr. Cooper also noted that there has not been an external review of this program proposal, as it is a new kind of degree in Canada, and that the review will occur by graduates of the program sitting the national board examinations.

Professor Halden complimented the proponents of the program for collaborating with the community to address a pressing need.

Professor Sparling noted the comments of the Senate Executive Committee regarding an affiliation agreement with CancerCare Manitoba and advised that the Senate Executive Committee endorses the report to Senate.

It was MOVED by Professor Cooper, seconded by Dean Hennen, THAT Senate approve and recommend that the Board of Governors approve the Proposal of the Faculty of Medicine to introduce a Bachelor of Allied Health Science (Radiation Therapy) [as endorsed by the Report of the Senate Committee on Curriculum and Course Changes dated November 1, 2002 and the Report of the Senate Planning and Priorities Committee dated September 30, 2002], and that the program not be implemented until the Vice-President (Academic) and Provost is satisfied that an appropriate affiliation agreement is in place between CancerCare Manitoba and the University of Manitoba.

The Faculty of Environment is proposing the introduction of a Bachelor of Environmental Science and a Bachelor of Environmental Studies degrees. The Bachelor of Environmental Science program is based on the successful Environmental Science Program currently in the Faculty of Science. The Bachelor of Environmental Studies degree program will be based on course work from the social sciences and the humanities. The proposal has been reviewed and endorsed by both the Senate Committee on Curriculum and Course Changes and the Senate Planning and Priorities Committee.

Dean Dahlgren acknowledged that these degree proposals were big step forward for the new faculty and acknowledged the assistance of Student Affairs, the Office of the University Secretary, the office of the Vice-President (Academic), SPPC and the Senate Committee on Curriculum and Course Changes. She also noted that the Environmental Studies degree has been under development for 10 years.

Professor Feld expressed a concern that 015.275 Ethics in the Environment was being deleted from the program. It was noted that the course was deleted because of content overlap with 128.200.

It was noted that pages 185-186 of the agenda list 17 degrees that will be offered by the Faculty and a question was raised as to whether these will be consolidated. Dr. Hunter noted that all programs will be reviewed and revised on an on-going basis.

It was MOVED by Dean Dahlgren, seconded by Professor Svenne, THAT Senate approve and recommend that the Board of Governors approve the Proposal of the Faculty of Environment to introduce a Bachelor of Environmental Studies and a Bachelor of Environmental Science degree [as endorsed by the Report of the Senate Committee on Curriculum and Course Changes dated November 6, 2002 and the Report of the Senate Planning and Priorities Committee dated November 8, 2002].

In response to a question Professor Simons noted that the application process consisted of grades, a written and problem-solving component and the personal profile. The problem with the personal profile was the difficulty in accurately evaluating it. Professor Kristjanson observed that even if it is difficult to assess, shouldn't the personal profiles still be included?

Professor Sparling advised Senate that the Senate Executive Committee endorses the report to Senate.

Mr. Kusie wondered why the $10 \%$ from the personal profile was moved into the GPA category and not split. Professor Simons responded that the issue wasn't discussed, but that once implemented, a review of the effectiveness of the new process would take place.

It was also noted that the personal profile was not helpful in detecting professional unsuitability as the applicants basically supplied a resume. It was also pointed out that the essay component of the application process is often used to find out about the professional suitability of applicants.

It was MOVED by Dr. Morphy, on behalf of the Committee, THAT the Report of the Senate Committee on Admissions regarding the Pharmacy Ranking Criteria [dated September 30, 2002] be approved by Senate.

The Senate Committee on Academic Dress recommends that Senate approve hood colors for the Master's in Music and Master's in Occupational Therapy degree programs.

Professor Amundson displayed the proposed hood for the Master's in Music degree and thanked Karen Jensen of the School of Music for providing it.

Professor Sparling advised Senate that the Senate Executive Committee endorses the report to Senate.

It was MOVED by Professor Amundson, on behalf of the Committee, THAT the Report of the Senate Committee on Academic Dress dated November 12, 2002] be approved by Senate.
