## IV REPORT OF THE PRESIDENT

The President reported he had been focused on the budget, attending meetings both with other Presidents and University of Manitoba staff together with the Minister of Advanced Education, the Minister of Finance, the government caucus and the Premier to discuss the financial situation of the Province and the University. The Province will be releasing the budget on March 23 and further information will be available at that point. Dr. Barnard indicated that the pattern of increases to post-secondary education has historically been somewhat less than that of the K-12 education which recently received a 2.95 percent increase in funding. The President indicated that the government intended to provide matching funds for all federal research grants requiring matching provincial funds.

## V QUESTION PERIOD

Senators were reminded that questions shall normally be submitted in writing to the University Secretary no later than 10:00 a.m. of the day preceding the meeting.

The following question was submitted by Professor Judith Owens, Faculty of Arts:

1. I've been looking on the University website and I can't find a list of the $\mathbf{1 2}$ proposals that were selected for funding through the Academic Enhancement Fund competition announced last fall. Can Senators be provided with a list of the successful proposals?

Also, the Academic Enhancement Fund initiative is described as a "competitive funding process." What is the adjudication process?
Are all proposals vetted by an interdisciplinary committee, in a way comparable to, say, the University Research Grants programme?
If the adjudication is by committee, what guidelines and criteria does this committee follow?

Dr. Lobdell provided the following table of successful applicants for the 2009 Academic Enhancement Fund.

Dr. Lobdell reviewed the process for this competition indicating that, at the end of September, 2009, the Vice-President (Academic) had circulated to Deans and Directors and Heads of Colleges a Call for Proposals for the Academic Enhancement Fund. The Fund is designated to support academic and research program innovation in the six areas identified for focused development in the University's new strategic planning framework. These areas were identified as:

- Healthy, Safe, Secure and Sustainable Food and Bioproducts
- Sustainable Prairie and Northern Communities
- Human Rights
- Innovations in Public and Population Health
- Innovative Materials and Technologies
- Culture and Creativity.

Dr. Lobdell further noted that the applications required sponsorship and support by at least two Deans/Directors of Faculties/Schools, the Director of Libraries or Heads of Colleges. He indicated that the following assessment criteria were employed:

- $\quad$ Contribute to the University's unique positioning in the area(s)
- Draw upon strengths from across the University
- Foster linkages within the University's teaching, research and public service activities
- Contribute to areas of strategic importance to Manitoba
- Build/strengthen strategic linkages with local community and beyond.

Twenty-seven applications were received and were assessed and ranked in terms of the degree to which they aligned with the overall purposes of the Fund. Applications were evaluated by the committee established by the Vice-President (Academic) and the VicePresident (Research). This committee was established in early December and consisted
of the three Vice-Provosts and the two Associate Vice-Presidents (Research). Letters confirming the awards were sent out in early January 2010. Dr. Lobdell noted that most of the proposals run across two fiscal years and have a total cost of less than \$75,000. A similar competition will take place in 2010.

Professor Young asked for clarification that the adjudication was done solely be administration and did not mirror the URGP (University Research Grants Program) process. Dr. Lobdell confirmed that these are not research projects but rather focus on service delivery. Projects which could be sheltered within a research grant were eliminated from the competition. He further noted the involvement of Deans/Directors in the process as sponsors of the proposals.

The Chair noted that Professor James Blatz, Chair of the Committee, was unable to attend Senate but noted that SPPC had submitted a number of reports for the consideration of Senate which would appear later in the agenda.

## IX REPORTS OF OTHER COMMITTEES OF SENATE, FACULTY AND SCHOOL COUNCILS

The Chair noted that the program proposals for PhD's in Food Science and Human Nutritional Sciences arise out of the current Inter-departmental PhD in Food and Nutritional Sciences. He further noted that Masters graduate program reviews in both departments recommended that separate PhD Programs in Food Science and Human Nutritional Sciences be established. These proposals could be used in marketing to offer a complete suite of courses from the Bachelor to the PhD level. Senate agreed to consider the two proposals under one motion.

Dean Doering noted that while separating the Inter-departmental PhD in Food and Nutritional Sciences into two separate PhD programs might seem to contradict the purposes of the ROSE and OARs projects, there would, in fact, be no resource implications as each of the units currently have their own graduate programs with
administration and Graduate Chairs. Currently the two departments share PhD students which, Dean Doering noted, does not work well.

1. Program Proposal from the Faculty of Graduate Studies RE: Ph.D. in Food Science

## a) Program Proposal Page 34

Dean Doering noted that the proposal would require 12 credit hours rather than the 15 credit hours required in the inter-departmental program. He further indicated that the proposal had received strong letters of support and that there is a market demand for this program. It is anticipated that the PhD program in Food Science would have 15 - 20 students in a steady state.

## b) Report of the Senate Planning and Priorities

Page 54 Committee

Dean Doering noted that there are no resource implications to this proposal which would replace the current inter-departmental program.
2. Program Proposal from the Faculty of Graduate Studies RE: Ph.D. in Human Nutritional Sciences
a) Program Proposal Page 56

Dean Doering reported that the Department of Human Nutritional Sciences currently has 39 Masters students. This proposal calls for 6 credit hours beyond the Masters level. He further indicated that the proposal has received strong letters of support. It is anticipated that the PhD program in Human Nutritional Sciences would have 15 students in a steady state.

## b) Report of the Senate Planning and Priorities <br> Page 90 Committee

Dean Doering noted that there are no resource implications to this proposal which would replace the current inter-departmental program.

Dean Doering MOVED, seconded by Professor Scanlon, THAT: Senate approve, and recommend to the Board of Governors, the establishment of a Ph.D. in Food Science and a Ph.D. in Human Nutritional Sciences.

3. Program Proposal from the Faculty of Graduate Studies RE: Master of Dentistry in Pediatric Dentistry

The Chair noted that this proposal would provide dentists with an opportunity to pursue further studies in pediatric dentistry. Graduates could serve underserved populations and implement preventative strategies in these communities.

## a) Program Proposal

Page 92
Dean Doering indicated that the proposed program would provide an opportunity for dentists to pursue higher education and research in the field of Pediatric Dentistry with an emphasis on prevention and public health in underserved and disadvantaged communities (Aboriginal, rural, and urban poor). He noted that the main purpose of this program is to prepare a specialist who is proficient in providing both primary and comprehensive preventive and therapeutic oral health care for infants and children through adolescence, including those with special health care needs. Dean Doering noted that the program is three years in duration with 60 credit hours. The proposal calls for 210 hours of didactic teaching in pediatric dentistry (compared to 22 hours in the undergraduate program) and 420 days of clinical pediatric dentistry (compared to 30 days in the undergraduate program). He noted that the proposal has received strong support.
b) Report of the Senate Planning and Priorities

Page 163 Committee

Dean Doering noted that the proposal requires significant start up funds of \$1 million. Referring to the SPPC report, he noted that the allocation from the Winnipeg Foundation had not been successful but that alternative funding was being sought.

## Dean Doering MOVED, seconded by Professor McNicol THAT Senate approve, and recommend to the Board of Governors, the establishment of a Master of Dentistry degree in Pediatric Dentistry.

Dr. Cronin asked whether funds were being sought for this program from private dentists and questioned the ethics of requiring students to attain a certain number of billing hours during the program. Professor Lekic, Faculty of Dentistry, responded that the recent $\$ 500$ increase in the licensing fee for dentists in the province was not in response to this proposal but rather to service underserved populations. Regarding the question of billing, Professor Lekic noted that students in the general practice clinic are required to perform a certain number of procedures which translates into billing numbers; this contributes to financing the clinic but also teaches students skills on managing their practice.

Mr. Vahedi questioned the necessity of a $\$ 1$ million investment and asked whether other alternatives could be developed. Professor Lekic responded that the $\$ 1$ million investment was a capital investment which would be paid within three years. He noted that a $\$ 250,000$ profit was anticipated in year two of the program.

Professor Young, referring to observation 3 of the SPPC report, questioned the liability of HSC taking out a loan for renovations. Mrs. McCallum indicated that sometimes the University provides internal loans, and confirmed that if such a loan was made that the University would be liable for it.

## 4. Program Proposal from the Faculty of Arts

 RE: Bachelor of Arts: Integrated Studies
## a) Program Proposal

Page 165
Dean Sigurdson reported that this proposal had come forward as a result of tremendous cooperation between faculties and offered his thanks to Dean Wallace and Associate Dean Matheos of the Division of Extended Education and Associate Dean Wilson and Ms. Sealey of the Faculty of Arts for the work they put into this proposal.

Dean Sigurdson noted that the proposed program would open undergraduate education for a group who often experience difficultly entering and completing a degree, an underserviced group with some prior post-secondary education. He referred Senate to page 190-192 of the agenda for a list of names of participants. He further noted that there are some course development costs attached to the proposal which would be covered by the Faculty of Arts. Dean Sigurdson invited Dr. Linda Wilson, Associate Dean (Undergraduate), Faculty of Arts, to speak to the proposal.

Dr. Wilson reported that this program has been in development for about three years and had its genesis in a meeting between Deans and Associate Deans of the Faculty of Arts and the Division of Extended Education. The proposal focuses on expanding options for working adults with non-traditional entry including certificates and diplomas. The proposed program would attract a pool of students not currently served by degree programs at the University. The program will contribute to academic synergies by providing a flexible, yet rigorous liberal arts education that permits students to select broadly across Faculty, School, and disciplinary boundaries in addition to laddering previous certificate and diploma credentials. She further noted that the proposed degree would meet a critical need in Manitoba, build on existing areas of strength, and move the institution in directions identified as priorities. Dr. Wilson reported that this proposal has been vetted widely across the University and the feedback received has been incorporated into the proposal presented here.

## b) Report of the Senate Committee on Admissions Page 193

Mr. Dueck noted that there were three aspects to this proposal which made it out of the ordinary: i) students would be admitted to a program rather than to the faculty as usually occurs in the Faculties of Arts and Science; ii) the program is designed for a specific cohort; iii) the admission requirements differ in that the 10 year limit for previous work does not apply.

## c) Report of the Senate Committee on Curriculum and <br> Page 200

 Course ChangesDean Frankel noted that this is an innovative and flexible program and that SCCCC recommends its approval.
d) Report of the Senate Planning and Priorities

Page 202 Committee

Dean Sigurdson MOVED, seconded by Dean Wallace, THAT: Senate approve, and recommend to the Board of Governors, the establishment of a Bachelor of Arts: Integrated Studies.

Professor Judy Anderson questioned how long a student would normally require to complete this degree. Dr. Wilson responded that, based on two courses per term, including the summer session, and in consideration of job and life commitments, and assuming the student came into the program with 24 credit hours of admissible credit, it was calculated that the degree would be completed by the majority of students in 4-5 years. Professor Anderson then asked if there was any concern expressed by employers that wages could be inflated due to this program. Dr. Wilson indicated that, in some cases, students required a Bachelor degree to maintain their employment and that the completion of a degree can also facilitate career advancement. Professor Anderson then questioned offering such a substantial program with a heavy reliance on sessional instructors ( 30 sessional instructors and 28 of professorial rank listed on page 185-187 of the agenda). Dr. Wilson responded that the list refers to those who have taught or are currently teaching the courses listed. The Faculty of Arts is strongly committed to maintaining the courses in this program though the number of sections and those teaching the courses may change.
