Dean Wittenberg offered a memorial tribute to Professor Emeritus Walter Bushuk, Department of Food and Human Nutritional Sciences, Faculty of Agricultural and Food Sciences. Dr. Bushuk earned a B.Sc.(Hons.) in Biochemistry at the University of Manitoba and a Ph.D. in Biochemistry at McGill University. Following a career in industry, he returned to the University of Manitoba in 1966, where, during the course of his tenure, he held academic appointments in the Departments of Plant Science and Food Science, served as Head, Department of Plant Science, Associate Vice-President (Research Administration), and Head, Department of Food Science.

Dean Wittenberg said Dr. Bushuk was an international expert in cereal science and a leading authority in dough rheology, protein composition and structure, and bread making quality. His pioneering research on the relationship between dough
strength and gluten protein composition and structure continued to be widely cited. Among his many awards and honours, Dr. Bushuk was a Fellow of the Royal Society of Canada (F.R.S.C.) and a Member of the Order of Canada.

Dr. Hiebert-Murphy informed Senate that the Senate Committee on Instruction and Evaluation (SCIE) had struck a subcommittee, the Teaching and Course Evaluation Review Committee, to review how teaching and course evaluations were conducted at the University. The last such review had occurred in 2007. The subcommittee would undertake a review of the significant volume of scholarship and research on teaching that had taken place in this area since that time, and would return to Senate with its recommendations. The review was expected to take twelve to eighteen months to complete.

Dr. Barnard recalled that it had been twenty-eight years since the day in 1989 when the nation and the education sector had been horrified when fourteen women were murdered at l'École Polytechnique de Montréal. He said the day was etched in many people's memories as a day when our understanding of the world suddenly and irrevocably changed. Dr. Barnard said that, on the National Day of Remembrance and Action on Violence Against Women, the University renewed its commitment to confronting the reality of gender-based violence and taking actions to address all forms of it at all times and, on this day in particular, to honouring the victims that day.

Senate observed a moment of silence.
Dean Beddoes informed Senate that l'École Polytechnique had established the Order of the White Rose as a continuing memory of the women killed on that day in 1989. The Order presents one award of $\$ 30,000$ annually to one female graduate of an engineering program who pursues graduate studies in engineering at a university in Canada or the United States. Dean Beddoes announced that, in 2017, the Order of the White Rose was presented to Ms. Ella Thomson, who had graduated from the Electrical Engineering program at the University of Manitoba in the spring 2017, and would undertake a Ph.D. in Biomedical Engineering at Stanford University, in California.

Dr. Barnard invited Senators to attend a presentation by Dr. David Naylor, who had served as Chair of the Advisory Panel for the Review of Federal Support for Fundamental Science that had produced the report, Investing in Canada's Future: Strengthening the Foundations of Canadian Research, Canada's Fundamental Science Review, 2017. The presentation, which was hosted by the University, in collaboration with the Manitoba Organization of Faculty Associations, would be held that evening, at 7:30 p.m., at the Fort Garry Hotel.

## V QUESTION PERIOD

Senators are reminded that questions shall normally be submitted in writing to the University Secretary no later than 10:00 a.m. of the day preceding the meeting.

The following question was received from Professor Gary Anderson, Faculty of Science:
The Government of Manitoba has in recent months enlisted KPMG to conduct fiscal performance reviews. In phase 2 of this exercise a business case - Postsecondary funding was recently published on the Government of Manitoba website. Under considerations section 5.1 Preferred option - Trade-Offs; the third option reads, and I quote:
"Governments are concerned that allowing universities and colleges to significantly increase tuition would in turn be directed to salaries. There are challenges in the trade-off of stable operating funding while enabling tuition increases. A better performance reporting and accountability framework can help resolve these issues. As part of overall changes to the funding system, Government should expect annual performance reporting focused on educational outcomes from post-secondary institutions that directly receive funding from the Provincial Government. At the same time, post-secondary institutions should also be expected to also find efficiencies and improve their value for money. Performance indicators should also include key financial and operational metrics, including cost control of salaries and other expenditures. Fiscal constraints will promote greater collaboration between universities and colleges to remove duplication and ineffective programs from the system and encourage specialization and innovation in their programs and practices."

Does the University of Manitoba upper administration share these views; in particular the governments concern over spending more on salaries. Further, by what measure will the University define a particular program as "ineffective".

Dr. Barnard remarked that universities and colleges, like all large publicly assisted organizations, were under scrutiny to ensure they were accountable for the public funds they received. The provincial government had identified balancing the budget as a key priority. Dr. Barnard observed that the KPMG report commissioned by government noted at page 8 , that, "...no direct engagement would take place with post-secondary institutions during phase 2." He confirmed that the University had not spoken with KPMG during their report. Dr. Barnard said University representatives met frequently with the Minister and other government officials to brief them on the activities of the University, the opportunities the institution provides for the people of Manitoba, and the University's careful stewardship of the resources entrusted to it.

Dr. Barnard observed that, in the context of grant funding levels to the University having levelled off in recent years, it was increasingly important for the University to maintain its careful stewardship of funds entrusted to it; including by ensuring that processes and delivery mechanisms were as effective and sustainable as possible, while also ensuring that the academic mission and the student experience were the first priority.

Dr. Barnard said the University's largest expenditure was salaries, which accounted for almost 80 percent of the expenditure budget. With the tabling of The Public Services Sustainability Act, the mandate for negotiating collective agreements was transparent and clearly demonstrated that the Manitoba government viewed salary cost containment as integral to meeting its financial imperative. While understanding government's imperative, the University was also aware that salaries must keep pace with those at other U15 Universities. Competitive salaries affected the institution's ability to attract and retain faculty, and the talent at the University was essential to ensuring that the students receive the best education and educational experience possible.

Dr. Barnard said the University regularly reviewed its program offerings, introducing new programs, revising existing programs, and suspending and closing programs, as necessary. The University would continue to engage in academic program reviews and accreditation processes to ensure that it delivered high quality academic programs that were effective and would continue to do so using collegial governance processes.

Dr. Barnard observed that many other provincial governments across the country required annual reporting from universities based on educational outcomes. If and when the Manitoba government moved to articulating specific outcomes as one measure of program effectiveness, the University would expect to be involved in conversations with government to help shape and define those outcomes. In the meantime, the University would continue to engage with the government to help them understand the value and opportunities that the University of Manitoba provided to the cultural and socio-economic well-being of the people of Manitoba.

Professor Brabston said she had been a member of Senate for thirteen years and a member of the Senate Executive Committee for twelve years. She expressed her appreciation to her colleagues in the Asper School of Business, for their faith in her ability to represent their interests and the interests of the University on these governing bodies. She thanked Mr. Leclerc and all of the staff in the Office of the University Secretary over the past thirteen years for their outstanding work in supporting Senate and its committees.

Professor Brabston said she had had the privilege of serving on several Senate committees and had the opportunity to participate in rational discourse that reflected well on Senators' passion for education and research. Often, she had been persuaded by the arguments of those who held different views on particular matters before the committees. She said the respect shown at Senate, for other Senators and for teaching, research, and progress on social issues had made her proud to have had the privilege and honour to work alongside other Senators.

Professor Brabston's remarks were met with a round of applause.

## 2. Report of the Senate Planning and Priorities Committee

Ms. Ducas said the Senate Planning and Priorities Committee (SPPC) had met on November $27^{\text {th }}$. The committee had concluded its review of a proposal for a Master of Human Rights program, which would come forward to Senate in due course.

Ms. Ducas thanked Dr. Barnard and Mr. Leclerc for the opportunity to serve on SPPC, including, for a number of years, as Chair. She said was grateful for having had the opportunity to learn more about the University and to have made a contribution to the institution through her service.

1. Undergraduate Course Changes Beyond Nine Credit Hours

## RE: Faculty of Law

Dean Black-Branch said the Faculty of Law was proposing a complete reform of the curriculum for the Juris Doctor program. The last time the curriculum had been reformed was in 1982. Dean Black-Branch said that, for consistency with the requirements of the accrediting body, the Federation of Law Societies of Canada, the number of credit hours required in the program would be reduced
from 97 to 92 credit hours, and the number of compulsory courses would also be reduced. That latter change would provide more opportunities for students to participate in experiential learning within the degree. Dean Black-Branch said there had been extensive consultation on the proposed changes, including with the executive of the Manitoba Law Students Association, who supported the changes. The revised curriculum had been endorsed by the Faculty's standing committee on Academic Affairs in March 2016 and by the Faculty Council of Law in April 2016.

Professor Smith said the Senate Committee on Curriculum and Course Changes (SCCCC) had reviewed the proposal. He reported that the Faculty had been responsive to a number of comments and requests for changes to the proposal and, with those corrections, the SCCCC had endorsed the proposal.

Dr. Hiebert-Murphy said the Faculty of Science was proposing changes to its regulations concerning entrance to the Bachelor of Computer Science (Honours) and Bachelor of Science (Major) in Computer Science, to require that students achieve a grade of "C+" or better in MATH 1300 and MATH 1500 and a grade of " C " or better in MATH 1700. The rationale for the revised requirements was to ensure that students were better prepared to be successful in these degree programs.

Dr. Hiebert-Murphy said the SCIE had endorsed the changes.
b) Report of the Senate Committee on

Professor Smith said the SCCCC considered the curriculum changes that would result from adding the equivalent mathematics courses and for replacing COMP 2130 with MATH 1240, as set out in item II (1). He said the SCCCC had endorsed the proposed changes to the degree regulations and the curriculum.

Dr. Hiebert-Murphy MOVED, on behalf of the committees, THAT Senate approve revised degree regulations for the Bachelor of Computer Science (Honours) and Bachelor of Science (Major) in Computer Science, effective for the Fall 2019.

a) RE: Department of Human Anatomy and Cell Science Page 271

Dean Mondor said the Department of Human Anatomy and Cell Science was proposing to expand the number of elective courses available to students in the M.Sc. and Ph.D. degrees in Human Anatomy and Cell Science, so they would have more flexibility in planning their program.

## 4. Reports of the Senate Committee on Admissions

a) RE: Admission Requirements for the Architecture

Page 279 Master Preparation (AMP) Option, Faculty of Architecture

Ms. Gottheil said the Senate Committee on Admissions (SCADM) and Senate did not have an opportunity to review the admission requirements for the Architecture Master Preparation (AMP) Option, Faculty of Architecture, when it was established (December 2, 2009). She reported that SCADM had reviewed the admission requirements, at its meeting on September 27, 2017. Proposed changes included (i) revised wording throughout the document, to improve clarity, and (ii) an amendment to the eligibility requirements, to specify that the calculation of the Adjusted Grade Point Average used for admission would be based on coursework completed by January $15^{\text {th }}$ of the application year, rather than April $30^{\text {th }}$. The latter change would allow the Faculty to make offers of admission earlier, which would benefit students.

Ms. Gottheil MOVED, on behalf of the committee, THAT Senate approve the Report of the Senate Committee on Admissions concerning admission requirements for the Architecture Master Preparation Option, effective for the Fall 2019 intake.

Ms. Gottheil said the Faculty of Arts was requesting that students who had completed the Sprachdiplom II Certificate program be eligible to receive first year transfer credit for GRMN 1120. ## 6. Reports of the Senate Committee on University Research

(a) RE: Proposal for Chair in Interprofessional Collaborative Page 297 Practice, Rady Faculty of Health Sciences

Dr. Jayas said the Senate Committee on University Research (SCUR) had endorsed a proposal for a Chair in Interprofessional Collaborative Practice.

Dr. Jayas MOVED, on behalf of the committee, THAT Senate recommend that the Board of Governors approve the Report of the Senate Committee on University Research concerning a proposal for a Chair in Interprofessional Collaborative Practice, Rady Faculty of Health Sciences.

Mr. Shaw raised concerns about two items related to the terms of appointment for the proposed Chair. First, he suggested that a requirement for evidence of a specific number of publications in a certain type of journal, for a successful performance review, would undermine the peer review process by substituting metrics for that process. Second, he raised a concern that, in a situation where the a review of the Chair's performance within the context of the Faculty's research strategy was deemed to be unsuccessful because the individual's research fell outside of the Faculty's research agenda, this would potentially be a violation of the individual's academic freedom.

Dr. Jayas said he had received a communication from UMFA prior to the meeting, which outlined the same concerns. He observed that endowed research Chairs and Professorships were normally established with a purpose and a research mandate. Given this, there were expectations for individuals who held these positions to conduct research in support of that mandate. Dr. Jayas proposed two amendments to the terms of reference for the Chair in Interprofessional Collaborative Practice, to address the concerns raised.

Dr. Jayas MOVED, seconded by Professor Blatz, THAT the third bulleted item, in the section concerning evidence provided as part of a successful performance review, be revised to read: "Evidence of research productivity and impact commensurate with a research Chair in the Rady Faculty of Health Sciences."
