The Chair informed Senate that the Speaker of the Senate Executive Committee was Dean Karin Wittenberg, Faculty of Agricultural and Food Sciences.

The committee agreed to reorder the agenda, to permit Dr. Barnard to make a statement under item V.

## V REPORT OF THE PRESIDENT

President Barnard addressed Senate regarding recent racist activities that struck the campus and, according to the publication Inside Higher Ed, other campuses across North America and Australia. He said these sorts of provocations are unacceptable, and he reported that he had made a statement the previous week condemning them unequivocally.

President Barnard said many within the University community feel targeted by these messages. He said members of the University community must stand together to support colleagues, students, and fellow University of Manitoba community members who feel threatened. Members of this community had a shared responsibility to work together to provide a safe and respectful work and learning environment. The University of Manitoba values diversity and inclusion; the community will not accepted hatred and divisiveness. President Barnard said that, to that end, he had ensured that recent activity involving racist posters, faxes, emails, and postings on social media sites was being investigated by Security Services and by the Winnipeg Police Service. Members of the University's Security Services team patrol the campus twenty-four hours a day and are watchful for any signs of additional activity. President Barnard asked members of the University community who observed receive racist or threatening material to notify Security Services. He said the University would continue to work with the appropriate authorities to do what could be done to put a stop to these activities and to hold accountable those responsible.

President Barnard said, at a time like this, there was a need to listen to the University community and its concerns. Community consultation sessions to inform revisions to the University's behavioural policies had been held on the Bannatyne and Fort Garry campuses that week. As well, Ms. Gottheil, Vice-Provost (Students), was working with her team to organize an open campus community session to discuss and work through the impacts of the recent racist activities and to explore ways to help ensure an environment of safety and respect. Dr. Barnard expressed his hope that long-term initiatives that would emerge from this conversation would improve levels of respect across campus, including in the classroom. He called upon all members of the University to work together to bring to life and to protect a shared belief in the value of inclusion and diversity on the campus.

Senators expressed their support for President Barnard's statement with a round of applause.

Following a secret ballot vote, Professor Miller and Professor McClement were declared ELECTED to the Senate Executive Committee, for terms beginning on January 1, 2019, and ending on June 30, and May 31, 2019, respectively.

Dr. Barnard noted that, under the Admission Targets policy, it is the President who approves changes to, or the introduction of, enrolment limits following consultation with the dean or director and with Senate and the Board of Governors, subject to the provisions of the provincial Programs of Study Regulation.

Dean Raman-Wilms reminded Senate that the College of Pharmacy would transition from offering a Bachelor of Science in Pharmacy (B.Sc.Pharm.) degree to a Doctor of Pharmacy (Pharm.D.) degree, in order to meet national accreditation standards. She said all pharmacy program in Canada were moving toward offering a Pharm.D. In the Fall 2018, students were admitted to the B.Sc.Pharm. program. Next Fall, this group of students would transition into the Pharm.D. program. With this transition, the College was requesting that admissions into the B.Sc.Pharm. degree be suspended.

Dean Raman-Willms indicated that once all students currently enrolled in the B.Sc.Pharm. program had graduated, the College would bring forward a proposal to close the program.
3. Report of Senate Committee on Academic Review RE:

Page 43 Undergraduate and Graduate Program Reviews [September 20, 2018]

Referring to the summary of the review of programs in the Department of Biological Sciences, Professor Blunden expressed strong support for a recommendation of the external reviewers that the University immediately initiate procedures to phase out the three-year Bachelor of Science (General) degree. He called attention to the recommendation at the Senate meeting, given that there were implications beyond both the Department of Biological Sciences and the Faculty of Science. He observed that the University of Manitoba was an anomaly among research universities in Canada with respect to the large proportion of undergraduate students enrolled in three-year Bachelor of Science and Bachelor of Arts degree programs.

Professor Blunden asked whether there was a plan to examine the historical and other reasons why the University continued to offer three-year degrees.

Dr. Collins replied that the question had been raised on a number of occasions, without any formal recommendation to review. He agreed that it was a matter that merits some evaluation.

Dean Taylor suggested it might be useful to consider whether external program review committees should include international representatives, given the usage of three-year degrees outside of Canada.

Referring Senators to the Report of the Senate Committee on Awards - Part B, Professor Carlberg said the Ralph G. Stanton Scholarship would be offered to a
female undergraduate student enrolled in Computer Science, in a Co-op program. Dean Baum, Faculty of Science, had presented evidence that female undergraduate students were 51.3 percent of the undergraduate population at the University, but within the Computer Science Co-op, enrolment of female students in the last five years had ranged from a low of 8.1 percent (in 2015) to a high of 24.0 percent (in 2017). Given this, the committee had endorsed the discriminatory award.

Professor Carlberg MOVED, on behalf of the committee, THAT Senate recommend that the Board of Governors approve the Report of the Senate Committee on Awards - Part B [dated September 27, 2018].

a) RE: Revised Direct Entry Admission Requirements,

Ms. Gottheil recalled that, in the Spring, Senate (May 16, 2018) had approved a new Direct Entry framework for undergraduate admissions. The Faculty of Engineering was proposing changes to its Direct Entry admission requirements that were consistent with the new framework. In particular, the Faculty was proposing to require a minimum 80 percent average for four required courses, including Chemistry 40S, Physics 40S, Pre-calculus 40S, and English 40S, with no grade lower than 70 percent in any of these courses. Ms. Gottheil noted that the Faculty had not previously required English 40S for admission.

Ms. Gottheil MOVED, on behalf of the committee, THAT Senate approve the Report of the Senate Committee on Admissions
concerning revised Direct Entry admission requirements for the Faculty of Engineering, effective for the Fall 2021 intake.

b) RE: Revised Transfer Policy for the Undergraduate

Medical Education Program, Max Rady College of Medicine

Ms. Gottheil said the Max Rady College of Medicine was proposing to revise its policy on Transfer into the Undergraduate Medical Education Program, which sets out a policy and procedures for dealing with requests from students enrolled in medicine programs at other institutions to transfer into the program at the University of Manitoba. Under the revised policy, transfers would be permitted solely on compassionate grounds, as outlined in the document. Students could transfer only into Year 3 of the program, provided they met academic standards and that there was an available space in the program. Ms. Gottheil said the revised policy was consistent with similar policies at other institutions.

Ms. Gottheil MOVED, on behalf of the committee, THAT Senate approve the Report of the Senate Committee on Admissions concerning a revised transfer policy for the Doctor of Medicine program, Max Rady College of Medicine, effective upon approval by Senate.
