1. Report of the Senate Executive Committee

Ms. Zapshala-Kelln said Senate Executive met on November 20, 2019. The comments of the committee accompany the reports on which they were made.

Ms. Zapshala-Kelln reported that Senate Executive had considered a request from Faculty of Arts Senators that Senate develop a statement on the importance of higher education. The request follows recent changes to the provincial cabinet. Senate Executive had accepted a proposal from the Chair that he and Professor Prentice (Faculty of Arts) draft a statement incorporating the Committee's feedback, for review at the December Senate Executive meeting, if not sooner. Under that plan, a statement would be forwarded to Senate in January 2020, for its consideration.

## 2. Report of the Senate <br> Planning and Priorities Committee

Professor Watt said the Senate Planning and Priorities Committee (SPPC) met on November $25^{\text {th }}$, to discuss proposals from the Faculty of Science and the Asper School of Business.

## IX REPORTS OF OTHER COMMITTEES OF SENATE, FACULTY AND SCHOOL COUNCILS

1. Report of the Senate Committee on Admissions

RE: Revised Advanced Entry Admission Requirements, Bachelor of Kinesiology, Bachelor of Kinesiology - Athletic Therapy, and Bachelor of Physical Education, Faculty of Kinesiology and Recreation Management

Ms. Schnarr said the Faculty of Kinesiology and Recreation Management was proposing to modify the Advanced Entry admission requirements for the Bachelor of Kinesiology, Bachelor of Kinesiology - Athletic Therapy, and Bachelor of Physical Education programs. The change would allow students to present BIOL 2410 - Human Physiology 1 and BIOL 2420 - Human Physiology 2 in place of BIOL 1412 - Physiology of the Human Body when applying to the programs. The modification would provide students with additional course options for admission purposes, which would be particularly beneficial for transfer applicants whose home institution might not offer courses equivalent to BIOL 1412.

Ms. Schnarr MOVED, on behalf of the committee, THAT Senate approve the Report of the Senate Committee on Admissions concerning revised Advanced Entry admission requirements for the Bachelor of Kinesiology, Bachelor of Kinesiology - Athletic Therapy, and Bachelor of Physical Education, Faculty of Kinesiology and Recreation Management, effective for the Fall 2021 intake.

2. Report of the Senate Committee on Instruction and Evaluation Page 350 RE: Modification of Regulations for the Co-operative Education and Industrial Internship Program, Faculty of Engineering

Dr. Torchia said the Senate Committee on Instruction and Evaluation (SCIE) met on October $17^{\text {th }}$, to consider a proposal from the Faculty of Engineering, to clarify the intake requirements for the Co-operative Education and Industrial Internship Program. Specifically, students would be required to successfully complete at
least 42 credit hours but no more than 90 credit hours toward the degree program by the end of the Fall Term. The intent was to ensure that students would have enough time remaining in their degree program to complete the work term requirements for the co-operative education designation.

## Dr. Torchia MOVED, on behalf of the committee, THAT Senate approve the

 Report of the Senate Committee on Instruction and Evaluation concerning modifications to the eligibility requirements for the Co-operative Education and Industrial Internship Program, Faculty of Engineering, effective September 1, 2020.Ms. Thomas raised a concern about the proposal. Observing that, because Engineering degrees required a minimum of 150 credit hours, a student who had completed more than 90 credit hours could still have two or more years in their program. Ms. Thomas suggested the proposed 90 credit hour limit was too restrictive. She said she had had a conversation with Dean Beddoes, who had agreed to further conversation with students, to identify a limit that both students and the Faculty could agree to. Ms. Thomas said she would support the motion with the expectation that the Faculty would bring forward a revised proposal in the coming months, to address students' concerns.

Dean Beddoes said he had met with student Senators from the Faculty of Engineering and had heard their concerns with respect to the 90 credit hour limit. He confirmed that the Faculty would consult with students in the Winter Term, including student Senators and the University of Manitoba Engineering Society, to determine whether the upper credit hour limit, as set out in the current proposal, was appropriate. Dean Beddoes asked that Senate approve the current proposal, as the important change was the reduction in the minimum credit hours for eligibility for the Co-operative Education and Industrial Partnership Program. He restated the Faculty's commitment to review the 90 credit hour limit, in consultation with Engineering students.

 Course ChangesProfessor Smith said that, following an internal review of its undergraduate curricula, the Faculty of Agricultural and Food Sciences was proposing major curriculum revisions, which the Senate Committee on Curriculum and Course Changes (SCCCC) had reviewed at its meeting on October $17^{\text {th }}$. The Faculty was proposing the deletion of nineteen courses, the introduction of thirteen courses, and the modification of forty-five courses across the Faculty and in the Department of Biosystems Engineering. The School of Agriculture was also proposing changes to five courses. Overall, the number of credit hours offered by the Faculty would decrease by 14 credit hours.

Professor Smith said the Faculty was proposing modifications to all of its degree programs, including the Co-operative Education Options, as described in the Report. The objectives were to: review, align, and renew curricula with future outcomes for students who would seek employment in various industries; establish core learning outcomes and technical competencies for each program; ensure graduates were recognized by one of the Partnership in Dietetic Education and Practice, Institute of Food Technologists, or the Manitoba Institute of Agrologists; consider course progression and prerequisites, to ensure students could complete their programs in a timely fashion.

Professor Smith said significant program modifications included the elimination of Faculty Core requirements, including a requirement for 3 credit hours of Philosophy courses; creation of a unique Degree Core for each of the Bachelor of Science in Agribusiness, Bachelor of Science in Agriculture, Bachelor of Science in Food Science, and Bachelor of Science in Human Nutritional Sciences, and the introduction of core introductory and capstone courses, to ensure required learning outcomes were addressed. The Faculty had provided a transition plan for continuing students, who would have the option to complete either the current or modified requirements for their program.

Professor Smith said the Faculty was proposing to: close the Agricultural Economics, Agribusiness Management, and International Agribusiness Options in the B.Sc. in Agribusiness; modify the Pre-Veterinary Program, Minor in Crop Protection, Minor in Food Science, Minor in Plant Biotechnology, and the Interfaculty Option in Aging; introduce a Minor in Agronomy, to address demand for agrologists in the labour market.

Professor Smith noted that the Faculty had indicated that the proposed course and curriculum changes would not affect the overall resources of the Faculty.

Professor Smith reported that some committee members had been concerned that the Faculty was eliminating the requirement for a Philosophy course, on the basis that students would benefit from exposure to questions of ethics, particularly with respect animal care. The Faculty had assured the committee that a number of courses in the revised curricula, including the capstone course, would incorporate topics on ethics.

Professor Smith said the SCCCC had discussed concerns related to the introduction of AGRI 2400 - Experimental Methods in Agricultural and Food Sciences. Specifically, whether it would overlap with STAT 1000 Basic Statistical Analysis 1 and STAT 2000 - Basic Statistical Analysis 2 and whether it would provide students with sufficient training in statistics to proceed in the programs. The Faculty had noted that if students wanted additional training in statistics, they would be able to complete STAT 1000 and STAT 2000 as elective courses.

## Professor Smith MOVED, on behalf of the committee, THAT Senate approve the Report of the Senate Committee on Curriculum and Course Changes concerning major curriculum revisions for programs in the Faculty of Agricultural and Food Sciences, effective Fall 2020.

Professor Botar asked how the Faculty would guarantee that the ethics content in its courses would be taught by instructors with specialized training in that field, in the way that faculty in the Department of Philosophy, Faculty of Arts, would be prepared to do.

Dean Scanlon acknowledged that the concern raised was legitimate. He invited Professor Amiro, who had championed the curriculum review within the Faculty, to address the question. Professor Amiro said current degree requirements did not include an ethics course. Rather, students were required to complete a course in either ethics or critical thinking. The Faculty felt it was important that the revised curricula should include learning outcomes for both critical thinking and ethics, including applied ethics in research and in industry practices surrounding animals and human nutrition. Professor Amiro said the Faculty had yet to determine who would teach the courses but he agreed that it would be important to identify instructors who were competent in these areas.

Professor Botar asked why the Faculty could not retain the current requirement for either an ethics or critical thinking course or require only an ethics course.

Dean Scanlon replied that two of the Faculty's undergraduate degree programs were outcomes-focused. Given this, ethics outcomes would be integrated across all courses and across all of the degree programs. The objective was to address learning outcomes related to the application of ethics in agricultural and foods systems rather than require a specific ethics course. Dean Scanlon said that, because instructors would be required to have training in ethics, it would behoove them to make sure they had received the appropriate training from experts in the discipline.

## 4. Undergraduate Course Changes Beyond Nine Credit Hours RE: Desautels Faculty of Music

a) Report of the Senate Committee on Curriculum and

Professor Smith said the Desautels Faculty of Music was proposing the deletion of eight courses and the introduction of eighteen courses. Several course introductions had previously been offered as topics courses. Others would replace existing courses proposed for deletion, but with some minor adjustments required as a result of the recent implementation of the Bachelor of Music (Music Education) degree. Two 3 credit hour courses used in this program, MUSC 3106 - Orff Schulwerk

1 and MUSC 3108 - Kodály Music Education 1, would be replaced by two 6 credit hour courses, MUSC 3200 - Orff Schulwerk 1 and MUSC 3220 Kodály Music Education 1, to reflect the workload and number of contact hours required for the courses.

Professor Smith said the Faculty was proposing modifications to the Bachelor of Music (Music Education) and to the lists of Core Music History Electives and Music Theory Electives used in the Bachelor of Music program that follow from proposed course changes.
b) Report of the Senate Planning and Priorities Committee

Professor Watt said course changes proposed by the Desautels Faculty of Music would result in a net increase of 48 credit hours. The SPPC was satisfied that the Faculty would not require new resources to support the course introductions, as many had previously been offered as topics courses. With respect to the introduction of the two 6 credit hour courses, MUSC 3200 and MUSC 3220, Professor Watt noted that these courses would be used not only by students in the B.Mus.(Mus.Ed.) program but by community members who would use the courses to receive certification from Carl Orff Canada or the Kodály Society of Canada.

Professor Watt MOVED, on behalf of the committees, THAT Senate approve undergraduate curriculum changes and course changes beyond nine credit hours, in the Desautels Faculty of Music, effective Fall 2020.

Professor Smith observed that the University offers both Bachelor of Arts and Bachelor of Science degrees in Psychology, through the Faculties of Arts and Science, respectively. The Faculty of Arts had recently introduced a Co-operative Education Option for its program (Senate, May 16,2018 ). The Faculty of Science was now proposing to modify the Bachelor of Science (Major) in Psychology, to include a Co-operative Option. Professor Smith said the SCCCC had reviewed the proposal, including the requirements to enter the program, which included eligibility to enter the B.Sc.(Maj.) in Psychology, completion of PSYC 2250 Introduction to Psychological Research and PSYC 2260 - Introduction to Research Methods in Psychology with a minimum grade of "C", and a minimum Degree Grade Point Average of 3.0. Students admitted to the Co-operative Option would alternate between full-time academic terms and full-time work terms. A minimum Degree Grade Point Average of 3.0 would also be required to continue in the program. Students who did not
meet the continuation requirements would be required to withdraw from the option and would revert to the B.Sc.(Maj.) in Psychology.

## ii) Report of Senate Committee on Instruction and Evaluation

Dr. Torchia said SCIE met on October $17^{\text {th }}$ to consider modifications to the entrance and continuation requirements for the B.Sc.(Maj.) in Psychology. Specifically, the language in the regulations would be revised, by removing the word "normally," to clarify that students must meet the entrance requirements set out in the regulation. The requirements for continuation in the program would be revised so students would no longer be required to obtain departmental approval of their Major program.

Dr. Torchia MOVED, on behalf of the committees, THAT Senate approve the Reports of the Senate Committee on Curriculum and Course Changes and the Senate Committee on Instruction and Evaluation concerning modifications to the curriculum and the academic regulations for the Bachelor of Science (Major) in Psychology, Faculty of Science, including a proposal for a Cooperative Education Option, effective Fall 2020.

Dr. Torchia said that, at its meeting on October $17^{\text {th }}$, SCIE considered proposed modifications to the academic regulations for the Co-operative Education Option in the Faculty of Science. In particular, Psychology would be added to the list of programs that offer a Co-operative Education Option. The description of the entrance requirements would be revised to communicate that a minimum Degree Grade Point Average of 3.0 would be required to enter the B.Sc.(Maj.) in Psychology, Cooperative Option. The language used in the regulations concerning continuation in the B.Sc.(Maj.) Co-operative Options would be revised to clarify that students must maintain, rather than attain, the minimum Degree Grade Point Average specified for their program in order to continue in the co-op option.

Acting Dean Simard said the Faculty Council of Graduate Studies had met on October $23^{\text {rd }}$ to consider a proposal from the Faculty of Agricultural and Food Sciences to close the Master of Science in Textile Science and to delete six TXSC courses totalling 21 credit hours. There were no students enrolled in the program. The proposal follows the merger of the former Department of Textile Sciences and the Department of Biosystems Engineering. Faculty members who had previously taught in the program had been fully integrated into, and were mentoring graduate students in, the Department of Biosystems Engineering

Acting Dean Simard MOVED, seconded by Dean Black-Branch, THAT Senate recommend that the Board of Governors approve the Report of the Faculty Council of Graduate Studies on Course, Curriculum and Regulation Changes concerning the closure of the Master of Science in Textile Sciences, Faculty of Agricultural and Food Sciences.

The rationale was to increase options to accommodate various focussed interests and the professional development of graduate students and to accommodate the student body, which included a large number of part-time students.

Acting Dean Simard said the Department of Pharmacology and Therapeutics was proposing to revise its supplemental regulations to
adopt the English language proficiency requirements established by the Faculty of Graduate Studies, for admission.
d) RE: Faculty of Social Work

Acting Dean Simard said that, based on a review of its curriculum, including core courses, the uptake of these courses, and time-tocompletion for the various program clusters, the Faculty of Social Work was proposing changes to the Master of Social Work and the Master of Social Work - Indigenous Knowledges. The number of required core courses would be reduced and revised to include courses that would prepare students for their thesis work. The five-cluster structure of the Master of Social Work program would be removed. Registration restrictions would be placed on three courses, SWRK 7780 - Social Work, Social Challenges, and Indigenous Peoples, SWRK 7750 Indigeneity, Power, Privilege, and Social Work, and SWRK 7810 - AntiColonial Social Work, to limit registration to students in the Master of Social Work - Indigenous Knowledges program, given limited space in, and increasing demand for, these courses. Access to these courses might be given to students in other Social Work programs where there were exceptional circumstances. In order to provide students with more structure, SWRK 7180 - Advanced Field Practices and SWRK 7190 Integrating Theory and Research in Advanced Field Practice would be scheduled during specific academic terms and students would no longer be required to secure their own practicum placement.
