### **Banking Resolution**

- 1. THAT the Royal Bank of Canada ("Royal Bank") is appointed banker for the Customer.
- 2. THAT any TWO of the Board Chair, Board Secretary, Vice-President (Administration), Comptroller, Associate Comptroller or Manager of Treasury Services are authorized on behalf of the Customer from time to time:

  - (c) to do, or to authorize any person or persons to do, any one or more of the following:
    - (i) to receive from Royal Bank any cash or any securities, instruments or other property of the Customer held by Royal Bank, whether for safekeeping or as security, or to give

- instructions to Royal Bank for the delivery or other transfer of any such cash, securities, instruments or other property to any person named in those instructions;

#### PRESIDENT'S REPORT: March 19, 2013

#### **GENERAL**

On March 6, the University of Manitoba hosted the finals of its first-ever Three-Minute Thesis competition, in which graduate students each used one slide and three minutes to explain the nature, goals and significance of their graduate research. It was an exciting evening, showcasing some of the incredible work that students are engaged in through their programs of study. Congratulations to Leah (Wong) Guenther (first place), Anthony Signore (second place) and Christopher White (people's choice), to all of the finalists, and to all 137 students who took on this challenge.

A signing ceremony with the University of Nairobi (UoN) and the University of Manitoba held in Nairobi in mid-January has renewed the Memorandum of Understanding between the two institutions for another five years. The ceremony marked the continuation of a productive partnership that began 32 years ago. The collaboration between the two institutions has over the years flourished in the establishment and growth of the University of Nairobi Institute for Tropical and Infectious Diseases (UNITID). UNITID was established in 2003 with the mandate of harnessing research activities and initiating training programs geared towards management and control of infectious diseases. The Institute houses two Biosafety Level 3 Laboratories which are run through joint partnership between the two universities and the National Microbiology Laboratory of Canada. Renewal of the MOU will ensure that operations and management of the UNITID facilities will proceed as planned and will continue the tremendous strides in research in infectious diseases already realized.

The Visionary (re)Generation International Urban Design Competition closed on January 10th with a total of 729 teams from 73 countries registered (logged onto site and downloaded competition brief). The deadline for submissions was March 11, 2013. Campus planning efforts continue on the Bannatyne campus as well, with the Bannatyne Campus Master Plan discussion paper having been released for consultation and engagement with the University community and the surrounding neighbourhood. Phase Two of the planning process has been launched (will include extensive consultation) including:

- Bannatyne Space Master Plan detailed look at interior requirements using the draft master plan as a guide.
- Residence Study looking at the feasibility of a Bannatyne Campus Residence.

At an awards ceremony held by the Council for the Advancement and Support of Education (CASE) the University of Manitoba was recognized with nine awards—two grand gold, four gold, one silver and two bronze—all for the successful "Trailblazer campaign" that began two years ago and that showcases the tremendous contributions of University of Manitoba faculty and students. In addition, the University of Manitoba was presented with the 2013 Virginia Carter Smith Grand Crystal Award, recognizing the most outstanding communications program of the year from among the nine Grand Gold category winners, as selected by a jury of CASE District VIII advancement professionals and peers. The ceremony was part of the annual CASE District VIII Celebration of Professional Achievement in Portland, Oregon, on Friday, February 15, 2013.

The role of universities in strong economies has been a significant theme in a number of recent fora, including *Visionary Conversations* discussions about the new West, joint meetings between Canadian and American university presidents hosted by Foreign Affairs and International Trade Canada, the recent Premier's Economic Advisory Council (PEAC) Skills Summit, and a Canada West Foundation roundtable at the University of Manitoba.

#### **ACADEMIC MATTERS**

- Dean Michael Trevan, agricultural and food sciences, travelled to the Ukraine as part of a Canadian Bureau for International Education (CBIE) delegation of 15 senior education leaders from 12 Canadian institutions with the aim of strengthening Ukrainian-Canadian higher education partnerships. The first ever mission of this kind began in Kyiv with a workshop with 24 Ukrainian institutions where they discussed lessons learned from past higher education partnerships and emerging areas for collaboration such as agriculture and the environment. The group then travelled to Lviv to meet with more regional institutions. Several memoranda of understanding were signed to formalize commitments to cooperation around higher education partnerships.
- Dean Mark Whitmore, science, was re-elected to a second term as President of the Canadian Council of Deans of Science.
- Redwan Moqbel, immunology, received the prestigious 2013 Lieutenant Governor's Award for the Advancement of Interreligious Understanding.
- David Levin, biosystems engineering, was recently awarded the Life Sciences Association of Manitoba Award for Outstanding Leadership in Research. This category is for the individual who demonstrates exemplary leadership in life science research in Manitoba in such areas as public awareness, scientific discovery and commercial application.
- Rayleen De Luca, psychology; Orest Cap, education; David Asper, law, Elsie Duff, nursing were awarded the Queen Elizabeth II Diamond Jubilee Medal.
- Roberta Woodgate, nursing, was selected as one of five university professors to present at the G20 Youth Forum Conference which will take place in St. Petersburg, Russia, in April 2013.
- Michael Eskin, human nutritional sciences, has been selected to receive the 2013 Alton E Bailey
  Award in recognition of his outstanding research and exceptional service in the field of lipids and
  associated products. The award is the oldest and one of the most prestigious recognitions given by
  American Oil Chemists' Society and dates back to 1959.
- Charles Wong, chemistry, was elected to a three year term on the North America Board of Directors for the Society of Environmental Toxicology and Chemistry (total international membership exceeding 6,000).
- Niigaanwewidam Sinclair, native studies, and Diana Hooper, extended education both received a Researcher and/or Curriculum Development Award at the Aboriginal Education Awards ceremony held in Winnipeg in January.
- Warren Cariou, English, film and theatre and Niigaanwewidam Sinclair, native studies, editors of
   *Manitowapow: Aboriginal Writings from the Land of Water*, hosted a special evening of readings
   and celebration at McNally Robinson Booksellers. This 2011 anthology of Manitoba Aboriginal
   writings takes readers back through the millennia and forward to the present day, painting a
   dynamic picture of a territory interconnected through words, ideas, and experiences. It is a rich
   collection of stories, poetry, nonfiction, and speeches.

- Co-editors Darcy MacPherson and Bryan Schwartz, law, are proud to announce the launch of a special issue of this year's *Manitoba Law Journal*: Five Decades of the Chief Justices of Manitoba. The issue explores the lives of the last three Chief Justices of Manitoba who served from 1971 to 2013.
- Bishwo Bandhu Pokharel and Mitch Rey, animal science students, received the highly coveted International Stockmen's Educational Foundation Travel Fellowship. The travel fellowship was awarded to 12 students representing 12 universities from six countries, including Australia, Brazil, Canada, Nepal, Uruguay and the United States.
- Kris Dick, biosystems engineering, travelled with students to Honduras to work on a housing project called El Pueblo Creciente The Growing Village. In addition to building a structure for a family of four, they are also working on projects such as a rainwater harvesting system, a new latrine design and a wood stove design.
- Prairie University Biology Symposium (PUBS) was hosted by the biological sciences graduate students at the Faculty of Science, University of Manitoba. PUBS is an annual event that originated in 1967 at the University of Manitoba; the conference attracts graduate and undergraduate students from Canadian Prairie and Northern US universities to share research, network, and explore academic opportunities.
- Let's Talk Science (LTS) is an award-winning, national, charitable organization that delivers sciencelearning programs to children and youth continues to deliver programs to urban and rural communities. The program is extending to six additional First Nations' communities.

### **RESEARCH MATTERS**

- On January 28, 2013 the Natural Sciences and Engineering Research Council of Canada (NSERC), Motor Coach Industries Ltd. (MCI), and the University of Manitoba announced the award of a prestigious NSERC Industrial Research Chair to Dr. Christine Wu (Mechanical and Manufacturing Engineering), with \$1,030,000 in funding over five years. Wu is the fifth such active chair holder currently at the U of M. Her chair, the NSERC/MCI Industrial Research Chair in Heavy Ground Vehicles and Transportation Equipment will find ways to reduce the laboratory testing period without sacrificing safety or data gathering integrity; the faster a new technology can leave the laboratory and enter production, the better economic news for industry. Wu will work with MCI to develop such tools to facilitate their design and analysis, focusing on vehicle roll-safety evaluation, and the development of new, faster methods for durability testing and safety evaluations.
- On January 22, 2013 the University of Manitoba launched the new 'Transformational Partnerships' approach that actively supports industry in making innovation leaps. Members of industry, government and the research enterprise in Winnipeg were on hand to hear the new approach. Minister of Innovation, Energy and Mines, Dave Chomiak, applauded the university for taking a leadership role in building partnerships with industry. Industry members who spoke about their support for the new initiative at the launch event were Anne Babineau, Director of Provincial Affairs Prairies for Rx&D and Sean McKay, CEO of Composites Innovation Centre.

The Transformational Partnerships initiative includes a new portal for industry to connect with partnership experts at <a href="umanitoba.ca/partnerships">umanitoba.ca/partnerships</a>. Other aspects of the new approach include a more proactive role for the university's Technology Transfer Office, which will visit companies to identify opportunities for collaborative research and be connect directly with researchers to get a deeper understanding of the research expertise at the university. The partnerships team will be the primary point of contact for industry to connect with expertise and, through the support of the Office of Research Services, will be matched with funding programs available.

- The Winter 2013 issue of ResearchLIFE magazine was published in mid-January. This issue features stories on Undergraduate Research Award recipients from the past summer. The awards were sponsored by the Office of the Vice-President (Research and International) and allowed students to experience research first hand with research mentors. Applications for the summer 2013 Undergraduate Research Awards closed on February 15, 2013. Another 80 students will be awarded summer mentorship placements across campus.
- High school students and teachers—160 in total—from Manitoba and Northwestern Ontario, spent February 22, 2013 at this year's Science, Engineering and Technology (SET) Day organized and sponsored by the Office of the Vice-President (Research and International), with additional sponsorship from the Province of Manitoba Ministry of Innovation, Energy and Mines, and the Association of Professional Engineers and Geoscientists of Manitoba. Participants spent their time at faculty based and hosted hands-on activities for half the day and for the other half of the day they were treated to SET Talks by Drs. Gordon Giesbrecht (Kinesiology and Recreation Management), James Blatz (Civil Engineering) and doctoral student Emily Choy (Biological Sciences).
- On February 28, the University of Manitoba played host to the Pierre Elliott Trudeau Foundation Lecture Series. The Foundation was established more than a decade ago as a living memorial to the former prime minister, supporting individuals who tackle critical issues in the humanities and social sciences by funding scholarships, fellowships, mentorships and programs aimed at engaging the public. Renowned public historian Ronald Rudin, professor of history at Concordia University and 2011 Trudeau Fellow, met with students and staff in the History Department during the day, prior to the public lecture titled: The Case for Public Knowledge, where he called for university-based researchers to use the tools at their disposal to make their research freely available to the public and gave an overview of his own digital media projects.

### **ADMINISTRATIVE MATTERS**

• Two Space Master Plan Projects for both the Fort Garry and Bannatyne campuses are well under way. The first phase for both included extensive interviews with the VP's, Senior Management and support scheduling departments within the University. Steering Committees were created for each project. Meetings were held with the steering committees on each of the campuses to introduce the consultant ECS, the Space Master Plan projects and how they would tie in with the concurrent development of the Master Plans for each location. Open discussions and feedback have been a constant element in both projects and have served as important tools in guiding and tailoring the process with the consultant.

Questionnaires were developed by the consultant to deal with both qualitative and quantitative issues relating to space. Faculties and Departments on the Bannatyne Campus have received their questionnaires and are diligently completing same, while approximately 10 Faculties and Departments on the Fort Garry Campus have received questionnaires. Extensive interviews with Deans, Department Heads and support staff have taken place with the first group on the Fort Garry Campus (Kinesiology and Management Recreation, Education and Extended Education), as well as extensive facility tours of their respective spaces.

An 'interim' space management process has been developed and is gradually being implemented for all requests for new space and any renovations that alter the function or configuration of a space. This was necessary in order to keep on top of any changes being proposed during the Space Master Plan projects timelines, which may well have implications on the final submission and recommendations made by the consultant ECS.

The Campus Planning Office will conduct a site visit of the space in question and review the request documents to ascertain whether or not there may be a conflict with current/proposed usages and/or logical functions of the space.

- In recognition of the ARTLab Building completing all of the Design Phase requirements of the Power Smart New Buildings Program Custom Design Path, the University received the first financial incentive cheque of \$32,750.00. This is a two-phase program and the final eligibility of the second incentive for the Construction Phase is expected shortly. Once complete, a recognition plaque will be provided by Manitoba Hydro for display in the building entrance.
- Confirmation has been received that the application to the Community Infrastructure Improvement
  Fund (CIIF) for the new roof at Frank Kennedy Centre/Extended Education Building was successful
  and the University will be receiving \$250,000 towards this project. The funding will be delivered
  through Western Economic Diversification (WD).
- The University's Waste Prevention Re-shop is turning 5! The Re-shop first opened on March 3, 2008 and accepted only office supplies. After such an overwhelming response the Re-shop expanded to receive surplus furniture in May 2008. Since then the Re-shop has donated over 10,000 pieces of furniture to University of Manitoba faculties, departments, schools, students and MB charities. In this year alone, 1421 people have visited the Re-shop, with an average of 40 people dropping by every Tuesday.
- The **Canadian Nuclear Safety Commission** (CNSC) performed 50 inspections over a two day period in February 2013. Overall the Inspectors said the Radiation Safety Program was 'excellent' because the responsibilities are appropriately delegated and the users conveyed confidence and were aware of their responsibilities.
- The **Human Resources Office** was reviewed by a panel of three external experts over a three day period in February as part of the Administrative Unit Review Policy and Procedures. The process involved interviews with senior administrators, faculties and units, union representatives as well as staff within Human Resources. A report is expected from the panel by the end of March.
- **EPIC, the eProcurement system** being implemented by ROSE Finance progressed from the Pilot Phase to Roll-Out during the first week of March. During Pilot, 1,500 Purchase Orders were issued and feedback from user groups was positive. Implementation across the University is expected to be complete this summer.
- Negotiations with Grand & Toy are nearing conclusion with savings on office supplies and furnishings in the 18% range. The UM agreement will be extended to other major post-secondary institutions in the Province as part of a collaborative procurement initiative.

#### **EXTERNAL MATTERS**

- As of March 1, 2013 the university has raised \$18,402,244.01 in this fiscal year.
- Significant gifts include: \$610,000 from Variety, the Children's Charity of Manitoba will go toward the Variety Children's Dental Clinic and the Children's Dental Outreach Program
- Government and Community Engagement arranged for two meetings with Minister of Children and Youth Opportunities, Kevin Chief in January. The first was with GCE and Indigenous Lead Deborah Young to discuss the university in general and Indigenous Achievement specifically and the second was with President David Barnard and Vice-President (External) John Kearsey to discuss the university's community impact
- President David Barnard, Vice-President (External) John Kearsey and former Associate Vice-President John Alho met with Winnipeg Mayor Sam Katz on January 15 to discuss the university's priorities including the Southwood development and rapid transit and funding for the Active Living Centre.
- GCE in partnership with Vice-President (Research and International) Digvir Jayas, met with Minister
  of Innovation, Energy and Mines Dave Chomiak on January 23 to discuss research priorities at the
  university including the need for greater graduate student support.
- President David Barnard met with Premier Greg Selinger on February 12 to discuss the university's plan for a \$500-million campaign to support undergraduate and graduate student success, innovation and research, teaching and learning and capital projects.
- Between February 4 6, 2013, President David Barnard met with Associate Deputy Minister of Environment Canada (and the University of Manitoba's Federal Champion), Andrea Lyon; Chief Human Resources Officer of the Treasury Board, Daniel Watson; Senator Donald Plett (Manitoba); Minister of State (Science & Technology), Gary Goodyear; and Director of Policy in the Minister's Office for Aboriginal Affairs and Northern Development Canada, Ravina Bains; and Policy Advisor for the Minister's Office, Moira Wolstenholme. At these meetings the President discussed the University of Manitoba's intervener status in the Truth and Reconciliation Commission Case against the federal government. Additionally, the President met with various Members of Parliament and House of Commons Standing Committees as part of an AUCC delegation, including the Standing Committees on Citizenship and Immigration, International Trade.
- The University of Manitoba hosted two Visionary Conversations in January and February 2013. The January event was titled 'The New West: The Economic and Political Rise of Western Canada' and featured the following panelists: Adele Perry, Canada Research Chair in Western Canadian Social History, Faculty of Arts; Paul Vogt, Alumnus and Clerk of the Executive Council, Province of Manitoba; Paul Thomas, Professor Emeritus, Political Studies, Faculty of Arts; and Ian Hudson, Associate Professor, Economics, Faculty of Arts.

- The February Visionary Conversation was titled 'Crouching Tiger, Hidden Dragon: Does the Rise of China Mean the Decline of the West?' and featured the following panelists: Tina Chen, Associate Professor, History, Faculty of Arts; George MacLean, Associate Dean, Graduate Studies; Hari Bapuji, Associate Professor, Business Administration, I.H. Asper School of Business.
- On January 29<sup>th</sup>, External Relations hosted a President's Breakfast with community leaders. The
  theme of the breakfast was focused on active living. Sixteen community members attended the
  breakfast and discussions focused on the importance of collaborating with the University of
  Manitoba to encourage healthy, active communities. A subsequent President's Breakfast, focused
  on the educational needs of today's youth, took place Tuesday, March 5<sup>th</sup>, 2013
- The University of Manitoba Board of Governors has three positions which are elected through a
  process managed by the Alumni Association Inc. Each year, one of those positions is open for
  election. Nominations closed February 1, 2013. Gwen Hatch was acclaimed by the Alumni
  Association Board for this role, and a letter has been sent to the Board of Governors regarding this
  selection.
- The Alumni Engagement and Preferences Survey was conducted between December 14, 2012 January 25, 2013. There were 5,169 participants in the survey. The data is currently being analyzed. The data received from this survey will be shared with the university and will be used to make informed decisions regarding programs, services and activities.
- The Alumni Association Inc. contributed \$2000 towards two tuition draws in January. In partnership with Career Services, a \$1000 tuition draw was held in January during Career Week. The winner was Christopher David a U1 student. In partnership with UMSU, a \$1000 tuition draw was also held in January. The winner of this draw was Salah Shammo a U1 student.
- The Alumni Association Inc. presents one award each year to a Distinguished Alumni Award recipient. Nominations closed February 15, 2013. The nominations have been referred to the Alumni Association Board Alumni Achievement Committee for review and consideration.
- Homecoming 2013 is scheduled for September 23-29. The theme of Homecoming this year is "I remember when". There are over 40 reunions scheduled. In addition to reunions, many of our faculties are celebrating milestone anniversaries. Plans for each milestone are under development. These include:
  - School of Fine Art 100 years
  - o Faculty of Architecture 100 years
  - Faculty of Nursing 70 years
  - o Faculty of Social Work 70 years
  - School of Dental Hygiene 50 years
  - o Clayton H. Riddell Faculty of Environment, Earth and Resources 10 years
- The Alumni Association Inc. Annual General Meeting will be held June 17 at University Centre, Marshall McLuhan Hall.

### CONTEXT AND BACKGROUND:

There are four University-operated student residence facilities on campus offering a variety of room and meal plan options.

- 1. Arthur V. Mauro Residence (AVM):
- 318 heds
- Two bedroom suite-style residence with shared kitchen area and washroom
- Three optional declining balance meal plan options<sup>1</sup> (not mandatory)
- 2. Mary Speechly Hall (MSH):
- 240 beds
- Dormitory-style residence with double or single rooms; communal washrooms
- Three mandatory meal plan options<sup>2</sup>
- 3. Pembina Hall Residence (PHR):
- 358 beds
- Single bedroom-style residence with private washroom
- Three mandatory meal plan options<sup>2</sup>
- 4. University College Residence (UCR):
- 256 beds
- Dormitory-style residence with double or single rooms; communal washrooms
- Three mandatory declining balance meal plan options<sup>1</sup>

<sup>1</sup> **Declining Balance Meal Plans** – (currently at Super Saver - \$2,200; Bison - \$2,400; and Premium - \$2,800) that can be used at any University Food Services outlet or the UMSU-operated Degrees Restaurant.

<sup>2</sup>Mandatory Meal Plan Options – currently 10 meals per week plus \$500 FoodBucks (declining balance), 15 meals per week plus \$500 FoodBucks (declining balance), and 7-day all-you-can-eat meals plus \$125 FoodBucks (declining balance).

### **RESOURCE REQUIREMENTS:**

### A. Proposed 2013-14 Room Rate Increases:

### Recommendation:

1. A 3.5% increase in room rates for Pembina Hall Residence:

3% increase allocated to cover utility services, etc. and a .5% increase allocated to repairs and renovations.

The Pembina Hall Residence room rate would increase from \$6,078 to \$6,290.

2. A 4.5% increase in room rates for Arthur V. Mauro Residence:

3.5% increase allocated to cover utility services, etc. and a 1% increase allocated to repairs and renovations.

The Arthur V. Mauro room rate would increase from \$6,158 to \$6,436.

3. A 5.5% increase in single and double room rates for Mary Speechly Hall and University College Residence:

3.5% increase allocated to cover utility services, etc. and a 2% increase allocated to repairs and renovations.

The Mary Speechly Hall and University College Residence single room rate would increase from \$4,216 to \$4,448; and the double room rate would increase from \$2,692 to \$2,840.

#### Rationale:

- University of Manitoba student residence room rates continue to be low and competitive for comparable properties (see attached Tables 3 – 5 for institutional comparisons).
- Current room rates do not provide sufficient revenue to support the ongoing maintenance costs of our residence buildings, especially as it relates to Mary Speechly and University College Residence. These aging facilities continue to demand an ever-increasing portion of our operating budget. Recurring maintenance expenses include, but are not limited to, upgrades to information technology infrastructure, plumbing, electrical, and mechanical systems. We anticipate this trend to continue until we can support a major retrofit of existing buildings or the development of new buildings. Until such time, further allocation of funds for repairs and renovations will continue to be an important and prudent part of facility management for these properties.

### B. Proposed 2013/2014 Meal Plan Rate Increases:

#### Recommendation:

1. A 5% increase in the 10 Meals/Week, 15 Meals/Week, and 7-day Unlimited Meal Plan rates for Mary Speechly Hall and Pembina Hall Residence. No increase in the Meal Plans at University College Residence.

### **Summary**

- For 2013/2014, the increase applies only to the Mandatory Meal Plans and does not affect the FoodBucks (Declining Balance Dollars).
- All Meal Plans will come with an option to purchase External FoodBucks any time through the year. If the student does not use these funds, they are refundable (less \$25 Administration Fee), so this feature will have minimal financial impact on the student/parent.

### **Rationale**

- Food cost increases are trending to be at approximately 6% overall.
- The cost of going "green" is increasing. ARAMARK has committed to operate food services businesses as green as possible and will continue to explore additional green options. As well, "sustainable" foods are higher in demand and given our geographical location, we are spending higher values on these products to meet student needs. We are also composting for Residence.

### **ALTERNATIVES:**

Given the condition of our older residence buildings, the additional 2% for MSH and UCR is necessary in order to mitigate escalating deferred maintenance. Without additional revenue for repairs and renovations, we risk operating funds for other core activities, such as residence life programming and security, being reallocated to cover ascending maintenance costs.

Replacement of our older residence buildings is not currently financially viable, and until such time as it is or alternative funding models are considered, the proposed rate increase is necessary to sustain our current residence inventory.



- 1.0 Reason for Policy
- 1.1 To establish an award which celebrates and recognizes public service and community building activities by individuals, groups, and organizations in the Province of Manitoba.
- 2.0 Policy Statement
- 2.1 The Distinguished Service Award is the highest honour bestowed by the Board of Governors.

  Distinguished Service Awards are awarded to individuals, groups, and organizations whose contributions improve the social or cultural well-being of the people of Manitoba. It is intended to recognize those whose service efforts build a better province for us all. The focus of the award is the recognition of distinguished community service to the University, the City of Winnipeg, and the Province of Manitoba, as opposed to individual achievements.
- 2.2 The Board of Governor shall decide the recipients of Distinguished Service Awards after considering the recommendations of the Distinguished Service Awards Selection Committee.
- 2.3 Normally, no more than two (2) Distinguished Service Awards shall be awarded in one academic year.
- 2.4 All residents of Manitoba who are not current employees of the University of Manitoba are eligible for nomination for the Distinguished Service Award.
- 2.5 Normally Distinguished Service Awards shall be presented at Convocation, but the Chair of the Board of Governors may authorize presentation at another suitable occasion.
- 2.6 Recipients of the Distinguished Service Award shall receive a University of Manitoba Distinguished Service Medal. A citation shall be read at the presentation ceremony.
- 2.7 The University will not normally offer a Distinguished Service Award to anyone who is not in a position to accept it in person.

- 3.0 Accountability
- 3.1 The University Secretary is responsible for advising the President that a formal review of the Policy is required.
- 4.0 Secondary Documents
- 4.1 The Board of Governors may approve Procedures which are secondary to and comply with this Policy.
- 5.0 Review
- 5.1 Formal Policy reviews will be conducted every ten (10) years. The next scheduled review date for this Policy is March 20, 2023.
- 5.2 In the interim, this Policy may be revised or rescinded if:
  - (a) the Approving Body deems necessary" or
  - (b) the relevant Bylaw, Regulations or Policy is revised or rescinded.
- 5.3 If this Policy is revised or rescinded, all Secondary Documents will be reviewed as soon as reasonable possible in order to ensure that they:
  - (a) comply with the revised Policy; or

### 1.0 Reason for Policy

1.1 To establish an award which celebrates and recognizes public service and community building activities by individuals, groups, and organizations in the Province of Manitoba.

### 2.0 Policy Statement

- 2.1 The Distinguished Service Award is the highest honour bestowed by the Board of Governors. Distinguished Service Awards are awarded to individuals, groups, and organizations whose contributions improve the social or cultural well-being of the people of Manitoba. It is intended to recognize those whose service efforts build a better province for us all. The focus of the award is the recognition of distinguished community service to the University, the City of Winnipeg, and the Province of Manitoba, as opposed to individual achievements.
- 2.2 The Board of Governors shall decide the recipients of Distinguished Service Awards after considering the recommendations of the Distinguished Service Awards Committee.
- 2.3 Normally no more than two (2) Distinguished Service award shall be awarded in one academic year.
- 2.4 All residents of Manitoba who are not current employees of the University of Manitoba are eligible for nomination for the Distinguished Service Award.
- 2.5 Normally Distinguished Service Awards shall be presented at Convocation, but the Chair of the Board of Governors may authorize presentation at another suitable occasion.

- 2.6 Recipients of the Distinguished Service Award shall receive a University of Manitoba Distinguished Service Medal. A citation shall be read at the presentation ceremony.
- 2.7 The University will not normally offer a Distinguished Service Award to anyone who is not in a position to accept it in person.

### 3.0 **Accountability**

3.1 The University Secretary is responsible for advising the President that a formal review of the Policy is required.

### 4.0 **Secondary Documents**

4.1 The Board of Governors may approve Procedures which are secondary to and comply with this Policy.

### 5.0 **Review**

- 5.1 Formal Policy reviews will be conducted every ten yearsThe next scheduled review date for this Policy is April 1, 2015.
- 5.2 In the interim, this Policy may be revised or rescinded if:
  - (a) the Approving Body deems necessary; or
  - (b) the relevant Bylaw, Regulations or Policy is revised or rescinded.
- (a) 5.3 If this Policy is revised or rescinded, all Secondary Documents will be reviewed as soon as reasonably possible in order to ensure that they:comply with the revised Policy; or
  - (b) are in turn rescinded.

#### 1. NEW OFFERS

#### James C.H. Anderson Memorial Actuarial Aboriginal Scholarship

In memory of James C.H. Anderson, The Actuarial Foundation (US) has established a trust fund at the University of Manitoba with a gift of \$100,000 USD. The Manitoba Scholarship and Bursary Initiative has made a contribution to the fund. Beginning in the 2013-2014 academic year, one renewable scholarship, valued at \$8,400, will be offered every year to an undergraduate student who:

- (1) is Aboriginal (Status, Non-Status, Métis, Inuit);
- (2) is enrolled full-time (minimum 24 credit hours) in any year of study in the I.H. Asper School of Business, the Faculty of Science, or University 1;
- (3) has indicated his/her intent to pursue undergraduate studies in actuarial mathematics.

Preference will be given to an Aboriginal student entering the University of Manitoba who has achieved a minimum average of 70% on those courses considered for admission.

Candidates will be required to submit an application that includes a statement of intent to pursue undergraduate studies in actuarial mathematics and a brief description of their career goals.

In years when there are no students who meet the above eligibility criteria, that year's award (valued at \$8,400) will be re-directed to the James C.H. Anderson Bursary (award # 25084), as per the donor's wish.

The scholarship is renewable, at the same value, for up to four additional years of study provided that the recipient:

- (1) remained registered in at least 24 credit hours in the previous academic year;
- (2) is enrolled full-time (minimum 24 credit hours) in the I.H. Asper School of Business or the Faculty of Science, in either a Bachelor of Commerce (Honours) or a Bachelor of Science (Honours) program, with a declared major in Actuarial Mathematics or Statistics Actuarial Mathematics;
- (3) has achieved a degree grade point average of 3.0.

Only one recipient may hold the scholarship at any one time.

In the event that a recipient does not qualify for renewal of the scholarship, the University will offer it to an Aboriginal student who meets the first set of selection criteria.


In years when a recipient does not qualify for renewal of the scholarship and there are no students who meet the first set of selection criteria, that year's award (valued at \$8,400) will be re-directed to the James C.H. Anderson Bursary (award # 25084), as per the donor's wish.

An annual update on the status of the scholarship award will be provided to The Actuarial Foundation.

The selection committee will be named by the Dean of the I.H. Asper School of Business (or designate) and will include the Director of the Warren Centre for Actuarial Studies and Research.

The Board of Governors of the University of Manitoba (in consultation with the Actuarial Foundation (US)) has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so, but keeping in line with the original intent of the scholarship. Should this award be discontinued for any reason, all remaining funds should be transferred to support the James C.H. Anderson Bursary.

The Warren Centre for Actuarial Studies and Research and the I.H. Asper School of Business strongly supports the establishment of the James C.H. Anderson Memorial Actuarial Aboriginal Scholarship. In the Fall Term 2012, our School's self-declared Aboriginal student population was 3.4% of total enrolment, 2.9% in Actuarial Mathematics, compared to the University average of about 7.7%. Hence, we are clearly under-represented compared to the University average and the general Manitoba population.

The Faculty of Science is delighted to support the establishment of the James C. H. Anderson Memorial Actuarial Aboriginal Scholarship.

Actuarial Mathematics programs are joint offerings of the Faculty of Science and the I. H. Asper School of Business. As noted in the letter from Dean Benarroch, only 2.9% of Actuarial Mathematics students self-declare as Aboriginal; within the Faculty of Science as a whole, only 4.4% of our students self-identify this way. These numbers are significantly below those for the general population in Manitoba. It is a priority of the Faculty of Science to attract more Aboriginal students and to provide them with the supports to be successful, and we welcome this scholarship as a very significant contribution towards this end.



#### SENATE COMMITTEE ON AWARDS Appendix A January 17, 2013

#### 1. NEW OFFERS

#### **Dianne Grant Memorial Scholarship**

In memory of Dianne Grant, family, friends, and the Department of Anthropology have established an endowment fund at the University of Manitoba, with an initial gift totalling more than \$15,000 in August 2010. In order to remember Dianne and her dedication to the pursuit of graduate work in anthropology, especially in the areas of gender and sexuality, exploitation, homelessness, poverty, and action-oriented research, the available annual interest from the fund will be used to offer one scholarship to a graduate student who:

- (1) is enrolled full-time in the Faculty of Graduate Studies, in the Master's or Doctoral program delivered by the Department of Anthropology;
- (2) has achieved a minimum degree grade point average of 3.5 based on the last 60 credit hours;
- (3) is planning to or has carried out thesis research in one of the following broad thematic areas: gender, race, class, or sexuality; Aboriginal issues; women's issues; gay, lesbian, queer, or transgendered persons' issues; exploitation or discrimination; homelessness; poverty; social inequity; human rights; or action-oriented research aimed at social justice;
- (4) has completed their research proposal or has largely completed the research or is writing their thesis.

Preference will be given to a single custodial parent.

Candidates will be required to submit an application that will consist of a description of their proposed research or completed research (maximum 500 words), a timeline for the completion of their thesis, and a letter of support from his or her graduate supervisor.

The Dean of the Faculty of Graduate Studies (or designate) will ask the Head of the Department of Anthropology (or designate) to name the selection committee, which will include the Chair of the Graduate Programs Committee of the Department of Anthropology.

The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modification shall conform as closely as possible to the expressed intention of the donor in establishing the award.

#### Dr. John M. Embil Publication Prize for B.Sc.(Med.) Program

Dr. John M. Embil has established an endowment fund at the University of Manitoba with a gift of \$30,000 in 2012 to offer a prize to students in the B.Sc.(Med.) Program. The purpose of this prize is to encourage and acknowledge timely completion and publication of data arising from B.Sc.(Med.) projects. Recipients will receive a plaque and a monetary award. The first prize will be offered in the 2014-2015 academic year. The available annual income from the fund will be used to offer one prize to a student who:

- (1) has successfully completed the B.Sc.(Med.) Program;
- (2) has a peer reviewed research publication arising from his/her B.Sc.(Med.) research project with the applicant as the first or second author of the manuscript;
- (3) has a manuscript published or in press no later than September 30 of the third year of the student's undergraduate medical training.

The recipient must deliver the following to the office of the B.Sc.(Med.) Program by the deadline of September 30 of the year following completion of the B.Sc.(Med.) program:

- (1) three copies of the manuscript (as published or submitted);
- (2) if applicable, a copy of the letter of acceptance;
- (3) a letter from the supervisor, indicating the role of the student in the publication and research work, as well as the importance of the research findings and the impact factor and rank of the journal in the field of study.

The selection committee will be named by the Dean of the Faculty of Medicine (or designate) and will be overseen by the B.Sc.(Med.) Awards Committee, and will include a member of the Embil family (or designate).

In the event that the B.Sc.(Med.) Program ceases to exist, the funds from the Dr. John M. Embil Publication Prize for B.Sc.(Med.) Program, shall be transferred to the Dr. John M. Embil Award for Excellence in Clinical Infectious Diseases

The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modification shall conform as closely as possible to the expressed intention of the donor in establishing the award.

#### **George Robert Donald Campbell Bursary**

In memory of Donald Campbell, family and friends will offer a one-time bursary in the 2013-2014 academic year to support a student who is a University of Manitoba Bison Basketball athlete. One bursary, valued at \$2,000 will be offered to an undergraduate student who:

- (1) has completed a minimum of 18 credit hours in the previous academic year at the University of Manitoba, in any faculty or school;
- (2) has completed a minimum of one year as a Bison student athlete on the Bison women's or men's basketball team;
- (3) has achieved a minimum degree grade point average of 2.0;
- (4) demonstrates financial need on the standard University of Manitoba bursary application form.

The selection committee shall be named by the Dean of the Faculty of Kinesiology and Recreation Management (or designate) and shall include the Athletic Director and the coaches of the Bison men's and women's basketball teams.

#### Lukasz Czarnecki Scholarship

The family and friends of Lukasz (Luke) Czarnecki have established an endowment fund at the University of Manitoba to support a memorial award in Luke's memory. Luke was a medical student in the Faculty of Medicine when he died in a tragic accident in 2003. The purpose of the fund is to honour Luke and his commitment to the service of others. He was an inspiring physician who brought compassion, integrity and an understanding towards the needs of others.

Each year the available annual income from the fund will be used to offer one convocation prize to a student who:

- (1) has completed the requirements for the Doctor of Medicine (M.D.) degree, in the Faculty of Medicine at the University of Manitoba;
- (2) has been ranked highly in the selection process for admission to the postgraduate program in Internal Medicine: \*
- (3) enrolls full-time, in the next academic session, in the Postgraduate Medical Education Program, in the Faculty of Medicine, in Internal Medicine.

\*The ranking shall be based on the advice of the Postgraduate Program Directors of the Department of Internal Medicine.

Nominations will be accepted from faculty and students and will include a statement explaining their choice (max. 250 words). Candidates may self-nominate and must submit an application that includes (i) a statement (maximum 400 words) describing their service to others and examples of their leadership; (ii) two letters of reference from faculty members who are familiar with their accomplishments; and (iii) a current *Curriculum vitae*.

The selection committee will be named by the Dean of the Faculty of Medicine (or designate) and will include a Chief Resident from the Department of Internal Medicine and the Senior Stick.

The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modification shall conform as closely as possible to the expressed intention of the donor in establishing the award.

#### Marc Hutlet Seeds Bursary - Diploma in Agriculture

Dupont Pioneer offers a one-time bursary in the 2012-2013 academic year valued at \$1,000.00 in honour of Marc Hutlet Seeds Ltd. Mr. Hutlet was recognized by the company for his dedication and focus on his customers. The purpose of the bursary is to provide financial support to a first year student in the Faculty of Agricultural and Food Sciences Diploma in Agriculture Program. One bursary, valued at \$1,000, will be provided to an undergraduate student who:

- (1) is enrolled full-time in the Faculty of Agricultural and Food Sciences in the first year of the Diploma in Agriculture program at the University of Manitoba;
- (2) has achieved a minimum degree grade point average of 2.5;
- (3) is a resident of South-East Manitoba (defined as east of Highway 75 to the Ontario border and south of Highway 44 to the U.S. border);
- (4) has demonstrated financial need on the standard University of Manitoba bursary application form.

The selection committee for this award will be the Faculty of Agricultural and Food Sciences Awards Committee.

#### **Margaret Ogrodnick Memorial Prize**

The Undergraduate Political Studies Students' Association (UPSSA) established the Margaret Ogrodnick Memorial Award to honour the contribution made by Dr. Ogrodnick to the academic careers of her students. The purpose of this award is to encourage students to pursue the intellectual rewards offered by political theory in the Great Political Thinkers course. The Undergraduate Political Studies Students' Association will contribute \$150 annually to offer one prize to an undergraduate student who:

- (1) is enrolled full-time as an undergraduate student in the Political Studies Honours, Advanced, or Major program in the Faculty of Arts at the University of Manitoba;
- (2) has achieved a minimum degree grade point average of 3.0;
- (3) has achieved the highest mark in Great Political Thinkers (POLS 2510).

The selection committee will be named by the Head of the Department of Politics (or designate).

#### MMCF - Anna Widiner B.Sc.(Med.) Scholarship

Through a bequest made by Anna Widiner, the Manitoba Medical College Foundation (MMCF) has established the MMCF – Anna Widiner B.Sc.(Med.) Scholarship at The Winnipeg Foundation. The fund will be used to support undergraduate students conducting research projects in the general field of cerebral-vascular disease. Each year The Winnipeg Foundation will report the available earnings from the

fund to Financial Aid and Awards at the University of Manitoba. The available earnings from the fund will be used to offer one scholarship to an undergraduate student who:

- (1) is enrolled in the Faculty of Medicine at the University of Manitoba in the Undergraduate Medical Education program and is in good standing;
- (2) is enrolled full-time in the Bachelor of Science (Medicine) program;
- (3) is conducting research in the general field of cerebral-vascular disease.\*

\*For the purposes of this award, the definition of cerebral-vascular disease shall be research related to the normal and abnormal functioning (e.g., trauma, stroke, dementia) of the cerebral circulation.

This scholarship may be renewed and held by the previous years' recipient provided s/he continues to meet the selection criteria listed above.

The Associate Dean of Research in the Faculty of Medicine (or designate) will have the responsibility and the authority to establish application procedures and deadlines for this award.

The selection committee will be named by the Dean of the Faculty of Medicine (or designate).

#### MMCF - B.Sc.(Med.) Student Scholarship

The MMCF – B.Sc.(Med.) Student Scholarship has been established by the Manitoba Medical College Foundation at The Winnipeg Foundation. The fund was created at the time of the dissolution of the board in 2011 with the aim of supporting undergraduate medical students participating in research projects while enrolled in the Bachelor of Science (Medicine) program in the Faculty of Medicine at the University of Manitoba. Each year The Winnipeg Foundation will report the available earnings from the fund to Financial Aid and Awards at the University of Manitoba. The available annual earnings from the fund will be used to offer one or more scholarships to undergraduate students who:

- (1) are enrolled in the Faculty of Medicine at the University of Manitoba in the Undergraduate Medical Education Program and are in good standing;
- (2) are enrolled full-time in the Bachelor of Science (Medicine) program.

The Associate Dean of Research in the Faculty of Medicine (or designate) will have the responsibility and authority to establish application procedures and deadlines for this award.

The selection committee will be named by the Dean of the Faculty of Medicine (or designate).

#### MMCF - Deer Lodge Hospital Staff Association Memorial Fund Travel Awards

Originally established by the Deer Lodge Hospital Staff Association in 1980, the MMCF – Deer Lodge Hospital Staff Association Memorial Fund Travel Awards has been established at The Winnipeg Foundation. The fund was created to support and enable continuing development for graduate students in the fields of the medical health sciences. The purpose of this travel award is to provide funding to graduate students seeking to cover the costs of attending national and/or international scientific meetings to present the results of their research. Each year, The Winnipeg Foundation will report the available earnings from the fund to Financial Aid and Awards at the University of Manitoba. The available earnings from the fund will be used to offer one or more travel awards to one or more student(s) who:

- (1) are enrolled full-time in the Faculty of Graduate Studies in a Master's or Doctoral program delivered by a department in the Faculty of Medicine at the University of Manitoba;
- (2) have a minimum degree grade point average of 3.5;
- (3) will attend a professional meeting or conference in order to present the results of his/her research (poster or oral presentation).

Evidence documenting the acceptance of a paper or poster presentation should be included with the request for funding.

Applicants cannot receive the Deer Lodge Hospital Staff Association Memorial Fund Travel Award in consecutive years. The maximum value of an award to a successful applicant will not exceed \$1,000. The number of awards available is determined on an annual basis and is subject to variability.

The Dean of the Faculty of Medicine (or designate) and the Dean of the Faculty of Graduate Studies (or designate) will jointly name the selection committee and any graduate student recipients named to receive the scholarship will be reported through the Dean of the Faculty of Graduate Studies.

#### MMCF - Dr. Lloyd William Jacobsen Memorial Scholarship

Through a bequest from Gerda Tove Jacobsen in memory of her son, Dr. Lloyd William Jacobsen, the Manitoba Medical College Foundation (MMCF) has established the MMCF – Dr. Lloyd William Jacobsen Memorial Scholarship at The Winnipeg Foundation. The fund will be used to support undergraduate students conducting research of heart and lung disease in the Faculty of Medicine. Each year The Winnipeg Foundation will report the available earnings from the fund to Financial Aid and Awards at the University of Manitoba. The available earnings from the fund will be used to offer one scholarship to an undergraduate student who:

- (1) is enrolled in the Faculty of Medicine at the University of Manitoba in the Undergraduate Medical Education program and is in good standing;
- (2) has been accepted to the Bachelor of Science (Medicine) program to conduct a research project on heart and lung disease.

The Associate Dean of Research in the Faculty of Medicine (or designate) will have the responsibility and the authority to establish application procedures and deadlines for this award.

The selection committee will be named by the Dean of the Faculty of Medicine (or designate).

#### MMCF - Dr. Walter Nakielny Research Scholarship

Originally established by Dr. Nakielny in 1998, the Manitoba Medical College Foundation (MMCF) has established the MMCF – Dr. Walter Nakielny Research Award at The Winnipeg Foundation. The fund will be used to support undergraduate students undertaking a B.Sc.(Med.) research project in Cystic Fibrosis in the Faculty of Medicine. Each year The Winnipeg Foundation will report the available earnings from the fund to Financial Aid and Awards at the University of Manitoba. The available earnings from the fund will be used to offer one scholarship to an undergraduate student who:

- (1) is enrolled in the Faculty of Medicine at the University of Manitoba in the Undergraduate Medical Education program and is in good standing;
- (2) has been accepted to the Bachelor of Science (Medicine) program to conduct a research project in Cystic Fibrosis under the direction of a member of the Faculty of Medicine at the University of Manitoba.

The Associate Dean of Research in the Faculty of Medicine (or designate) will have the responsibility and the authority to establish the application procedures and deadlines for this award.

The selection committee will have the discretion to award this scholarship to the same student for up to two consecutive years as required.

The selection committee will be named by the Dean of the Faculty of Medicine (or designate).

#### MMCF – Dr. E.S. Bryngelson Memorial Bursary

Through gifts received from family, friends, patients, and colleagues of Dr. Earl S. Bryngelson (M.D./51) in 1983, the Manitoba Medical College Foundation (MMCF) has established the MMCF – Dr. E.S. Bryngelson Memorial Fund at The Winnipeg Foundation. Dr. Bryngelson was an outstanding and beloved family physician who practiced in Kenora, Ontario for thirty-two years following his graduation

from the Faculty of Medicine at the University of Manitoba in 1951. The fund will be used to provide bursaries for undergraduate medical students in the Faculty of Medicine at the University of Manitoba. Each year, The Winnipeg Foundation will report the available earnings from the fund to Financial Aid and Awards at the University of Manitoba. The available earnings from the fund will be used to offer one or more bursaries to students who:

- (1) are enrolled full-time in any year of study in the Undergraduate Medical Education Program in the Faculty of Medicine at the University of Manitoba and are in good standing;
- (2) have demonstrated financial need on the standard University of Manitoba bursary application form

Preference will be given to students who have demonstrated an interest in rural family practice through pursuit of rural family medicine electives experiences.

The selection committee for this award will be named by the Dean of the Faculty of Medicine (or designate).

#### **MMCF – Graduate Student Travel Awards**

The MMCF – Graduate Student Travel Awards has been established by the Manitoba Medical College Foundation at The Winnipeg Foundation. The fund was created at the time of the dissolution of the board in 2011 with the aim of supporting graduate student education in the Faculty of Medicine at the University of Manitoba. The purpose of this travel award is to provide funding to graduate students to present the results of their research at scientific conferences. Each year, The Winnipeg Foundation will report the available earnings from the fund to Financial Aid and Awards at the University of Manitoba. The available earnings from the fund will be used to offer up to ten travel awards, valued at \$500 each, to graduate students who:

- (1) are enrolled full-time in the Faculty of Graduate Studies in a Master's or Doctoral program delivered by a department in the Faculty of Medicine at the University of Manitoba;
- (2) have a minimum degree grade point average of 3.5;
- (3) have a poster that is judged to be among the top ten posters in the annual Manitoba Health Research Poster Competition;
- (4) will attend a professional meeting or conference in order to present the results of his/her research (poster or oral presentation).

Evidence documenting the acceptance of a paper or poster presentation should be included with the request for funding. The intention of this award is to reimburse travel expenses for conference travel up to the available annual income generated by this fund.

The Dean of the Faculty of Medicine (or designate) and the Dean of the Faculty of Graduate Studies (or designate) will ask the Poster Judging Committee to select recipients from the pool of applicants presenting at the Manitoba Student Health Research Poster Competition. Any graduate student recipients named to receive the scholarship will be reported through the Dean of the Faculty of Graduate Studies.

#### MMCF - Medicine Class of 1949 B.Sc.(Med.) Travel Bursary

Through a gift received from members of the Medicine Class of 1949, the Manitoba Medical College Foundation (MMCF) has established the MMCF – Class of 1949 B.Sc.(Med.) Travel Fund at The Winnipeg Foundation. The Manitoba Scholarship and Bursary Initiative has made a contribution to the fund. The fund will be used to provide travel awards for students in the Bachelor of Science in Medicine program at the University of Manitoba for travel to conferences or professional meetings to present the results of their research. Each year, The Winnipeg Foundation will report the available earnings from the fund to Financial Aid and Awards at the University of Manitoba. The available earnings from the fund will be used to offer one or more bursaries to students who:

- (1) are enrolled in the Faculty of Medicine, in the Undergraduate Medical Education program and are in good standing;
- (2) have successfully completed the requirements for the Bachelor of Science in Medicine;
- (3) will be attending a conference or professional meeting to present the results of their research;
- (4) have demonstrated financial need on the standard University of Manitoba bursary application form

The selection committee will have the discretion to determine the number and value of awards offered each year based on the available funding.

Candidates will be required to submit an application that includes the abstract of their presentation and a copy of their paid registration, with details of the meeting including the date and location.

Recipients must submit receipts for travel, registration, hotel and/or food expenses (based on current UM *per diem* rates). Expenses will be reimbursed up to the maximum value of the recipient's award. Travel must be completed prior to graduation from the Undergraduate Medical Education program.

The selection committee will be named by the Dean, Faculty of Medicine (or designate).

#### MMCF - Paul Nehra Convocation Prize in Family Medicine

Through gifts received from Dr. Paul Nehra, the Manitoba Medical College Foundation (MMCF) has established the MMCF – Paul Nehra Convocation Prize in Family Medicine at The Winnipeg Foundation. The fund will be used to provide a prize to a student who has demonstrated excellence in his or her performance during the Family Medicine/Community Medicine Clerkship rotation and who has been accepted to post-graduate resident training in Family Medicine. Each year, The Winnipeg Foundation will report the available earnings from the fund to Financial Aid and Awards at the University of Manitoba. In addition, the annual available earnings from the Parkland Family Medicine Trust, also held at The Winnipeg Foundation, will be used to augment the MMCF – Paul Nehra Convocation Prize in Family Medicine every year. The available earnings from the two funds will be used to offer one prize to a student who:

- (1) is enrolled full-time in their final year of study in the Undergraduate Medical Education Program in the Faculty of Medicine at the University of Manitoba and is in good standing;
- (2) has demonstrated a high degree of involvement in the practice of family medicine;
- (3) has demonstrated a good understanding and use of psychosocial skills.

The selection committee for this award will be named by the Dean of the Faculty of Medicine (or designate) and consist of a Family Medicine Resident, a part-time preceptor, and the Director of the Undergraduate Program, Department of Family Medicine (or designate).

#### MMCF - Robin Krause Human Values Convocation Prize

The Manitoba Medical College Foundation (MMCF) has established the MMCF – Robin Krause Human Values Convocation Prize at The Winnipeg Foundation. The purpose of the fund is to support the work of the Human Values Program of the Faculty of Medicine at the University of Manitoba. The aim of this program is to promote the attitudes and skills necessary for the practice of total patient care including the promotion of health and well-being to undergraduate, graduate and practicing physicians in Manitoba. Each year, The Winnipeg Foundation will report the available earnings from the fund to Financial Aid and Awards at the University of Manitoba. In addition, the annual available earnings from the Family Physician Wives Memorial Fund, also held at The Winnipeg Foundation, will be used to augment the MMCF – Robin Krause Human Values Convocation Prize every year. The available earnings from the two funds will be used to offer one prize to a student who:

(1) is enrolled full-time in their final year of study in the Undergraduate Medical Education (UGME)

Program in the Faculty of Medicine at the University of Manitoba and is in good standing;

- (2) is graduating from the UGME Program in the year the prize is tenable;
- (3) demonstrates an understanding of, and leadership in, total patient well-being including:
  - (a) the doctor-patient relationship and, through that, a physician's responsibility to society as a whole;
  - (b) the ethical and legal aspects of practicing good clinical medicine;
  - (c) the non-biomedical issues that affect the quality of patient care;
  - (d) that the physician is a member of a team relieving illness and promoting health;
  - (e) the broader organizational, economic, cultural and political issues which influence individual ethical decisions:
- (4) has demonstrated a good understanding and use of psychosocial skills.

The selection committee for this award will be named by the Dean of the Faculty of Medicine (or designate) and consist of a Family Medicine Resident, a part-time preceptor, and the Director of the Undergraduate Program, Department of Family Medicine (or designate).

#### MMCF - W & F & D Waite Memorial Bursary

Through a gift received from Miss Doris Maud Waite, the Manitoba Medical College Foundation (MMCF) has established the MMCF – W & F & D Waite Memorial Bursary fund at The Winnipeg Foundation. The fund will be used to provide bursaries to assist students in their final year of undergraduate medical studies at the University of Manitoba. Each year, The Winnipeg Foundation will report the available earnings from the fund to Financial Aid and Awards at the University of Manitoba. The available earnings from the fund will be used to offer one or more bursaries to students who:

- (1) are enrolled full-time in the final year of study in the Undergraduate Medical Education Program in the Faculty of Medicine at the University of Manitoba and are in good standing;
- (2) have demonstrated financial need on the standard University of Manitoba bursary application form.

The selection committee for this award will be named by the Dean of the Faculty of Medicine (or designate).

#### Mr. Perry Ross Bursaries

A new general bursary has been established through a bequest of approximately \$1,000,000 received from Mr. Perry Ross in 2013. The available annual income from the fund will support students in any faculty or school at the University of Manitoba. Each year, bursaries will be offered to students who:

- (1) are enrolled as part-time or full-time students in any degree or diploma program at the University of Manitoba;
- (2) have a record of satisfactory academic achievement which is defined as;
  - a. for first year students, a minimum entering average of 70 percent on those courses used for admission into the University of Manitoba;
  - b. for continuing students, a minimum degree grade point average of 2.0;
- (3) have demonstrated financial need on the standard University of Manitoba bursary application form.

The number and value of the bursaries will be determined by the selection committee.

The selection committee shall be named by the Director of Financial Aid and Awards (or designate).

#### 2. AMENDMENTS

#### Leslie F. Buggey Graduate Scholarship in Pharmacy

The following amendments have been made to the terms of reference for the Leslie F. Buggey Graduate Scholarship in Pharmacy:

- The preamble was amended to indicate that an endowment fund was established. The purpose of the fund was also added to the preamble.
- The paragraph describing the eligibility criteria was deleted and it now reads:
  - (1) is enrolled as a full-time Master's or Ph.D. student in any year of study in the Faculty of Graduate Studies and whose research project is conducted exclusively in the Faculty of Pharmacy at the University of Manitoba;
  - (2) has achieved a minimum cumulative grade point average of 3.5 (or equivalent) in the last 60 credit hours of courses.
- The sentence that limits the tenability of this award to be held in conjunction with other awards of \$15,000 or more is now in a separate standalone sentence after the numbered order of preference section.
- Two sentences after the numbered order of preference section is a standalone sentence that prohibits students from receiving this award more than once unless the donor provides consent.
- The following sentence has been added just before the selection committee paragraph: "The Faculty of Pharmacy will offer a commemorative medallion for this scholarship which will be presented to the recipient at the annual Faculty of Pharmacy Graduate Ceremony."
- The description of the selection committee has been changed to read: "The Dean of the Faculty of Graduate Studies (or designate) will ask the Graduate Studies Chair of the Faculty of Pharmacy to name the selection committee for this award."
- The standard Board of Governors paragraph has been added.
- Many editorial changes have been made.

#### Manitoba Law School Foundation Entrance Scholarship

The following amendments have been made to the terms of reference for the Manitoba Law School Foundation Entrance Scholarship:

- The deadline date listed in criterion (2) was removed and it now reads: "has accepted the offer of early admission;"
- The description of the selection committee has been changed to read: "The selection committee will be named by Dean of the Faculty of Law (or designate).
- The standard Board of Governors paragraph has been added.

#### Mary Hamilton Johnston Memorial Bursary

The following amendments have been made to the terms of reference for the Mary Hamilton Johnston Memorial Burary:

- The fund type was added to the preamble as was a sentence describing the purpose of the fund.
- The bursary is now supported by a trust fund and each year the available annual income from the fund will be used to offer a bursary to an undergraduate student.
- The eligibility criteria have been amended to now read:

- (1) has completed a minimum of 30 credit hours in the Faculty of Social Work;
- (2) enrols full-time (minimum of 80 percent course load) in the next academic year in the Faculty of Social Work;
- (3) has a record of community service;
- (4) has demonstrated financial need on the standard University of Manitoba bursary application form
- The sentence that states that the status of the fund will be reviewed from time to time has been removed.
- The description of the selection committee has been changed to read: "The selection committee will be the Faculty of Social Work Awards Committee."
- The standard Board of Governors paragraph has been added.
- Several editorial changes have been made.

#### **Preamble**

Terms of reference for the Senate Committee on Awards include the following responsibility:

On behalf of Senate, to approve and inform Senate of all new offers and amended offers of awards that meet the published guidelines presented to Senate on November 3, 1999, and as thereafter amended by Senate. Where, in the opinion of the Committee, acceptance is recommended for new offers and amended offers which do not meet the published guidelines or which otherwise appear to be discriminatory under the policy on the *Non-Acceptance of Discriminatory Awards*, such offers shall be submitted to Senate for approval. (Senate, October 7, 2009)

#### **Observations**

At its meeting of December 12, 2012 the Senate Committee on Awards approved seven new offers and two amended offers as set out in Appendix A of the *Report of the Senate Committee on Awards – Part A* (dated December 12, 2012).

#### 1. NEW OFFERS

#### **Donald and Shirley McQueen Bursary**

In memory of Don McQueen (C.A./55), his wife Shirley McQueen has established an endowment fund at the University of Manitoba with a gift of \$28,258.04 in 2011. The Manitoba Scholarship and Bursary Initiative has made a contribution to the fund. The fund will be used to provide bursaries for students enrolled in the I.H. Asper School of Business. The available annual income from the fund will be used to offer one bursary to an undergraduate student who:

- (1) is enrolled full-time in the I.H. Asper School of Business at the University of Manitoba, in any year of the Bachelor of Commerce program;
- (2) has achieved a minimum degree grade point average of 2.0;
- (3) has demonstrated financial need on the standard University of Manitoba bursary application form.

The selection committee will be named by the Dean of the I.H. Asper School of Business.

The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modification shall conform as closely as possible to the expressed intention of the donor in establishing the award.

#### Florence and Robert Brownridge Bursary

In 2012, Florence Brownridge, (B.A. 49/, B.SW/51) established an endowment fund with a gift of \$25,000 at the University of Manitoba. The purpose of the fund is to provide financial support to undergraduate students in the Faculty of Social Work. Each year, the available annual interest will be offered to an undergraduate student who:

- (1) is enrolled full-time in either the third or fourth year of study in the Faculty of Social Work at the University of Manitoba;
- (2) has achieved a minimum degree grade point average of 2.5;
- (3) has demonstrated financial need on the standard University of Manitoba bursary application form.

The selection committee shall be named by the Dean of the Faculty of Social Work (or designate).

The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modification shall conform as closely as possible to the expressed intention of the donor in establishing the award.

#### North American Caribou Workshop Graduate Fellowship in Wildlife Management

The North American Caribou Workshop and the Clayton H. Riddell Faculty of Environment, Earth, and Resources have established an endowment fund valued at \$30,000 in 2012. The purpose of the fellowship is to support students at the University of Manitoba pursuing graduate studies in wildlife management with a particular emphasis on the management of caribou and northern ecosystems. Beginning in 2014-2015, the available annual income from the fund will be used to offer one fellowship to a graduate student each October who:

(1) is enrolled full-time in the Faculty of Graduate Studies at the University of Manitoba in a Master's or Doctoral program delivered by the Clayton H. Riddell Faculty of Environment, Earth,

- and Resources, including the Natural Resources Institute;
- (2) has achieved a minimum degree grade point average of 3.5;
- (3) demonstrates an interest in aspects of caribou research, monitoring or management and who considers different disciplines or sub-disciplines such as ecology, economy, governance, resource management and land use planning.

Students applying for the fellowship will be required to complete an application including (a) a short essay (500 words maximum) explaining how different disciplines contribute to caribou research, monitoring or management as well as listing any relevant project(s) and/or experience in wildlife management in Manitoba and Canada; (b) an official transcript(s); (c) two letters of recommendation.

No award will be made if, in a given year, the selection committee cannot identify a candidate of sufficient merit.

The Dean of the Faculty of Graduate Studies (or designate) will ask the Dean of the Clayton H. Riddell Faculty of Environment, Earth, and Resources (or designate) to name the selection committee for this award.

#### **Olga Anderson Bursaries**

Mrs. Olga Anderson has bequeathed \$2,000 to the University of Manitoba in 2012. The purpose of the gift will be to provide financial support to students in the Department of Human Nutritional Sciences. This gift will be used to offer two bursaries, valued at \$1,000 each, in 2012-2013 only. The bursaries will be offered to undergraduate students who:

- (1) are enrolled full-time in any year of study in the Department of Human Nutritional Sciences at the University of Manitoba;
- (2) have achieved a minimum degree grade point average of 2.5;
- (3) have demonstrated financial need on the standard University of Manitoba bursary application form.

The selection committee will be named by the Head of the Department of Human Nutritional Sciences (or designate).

#### Ratuski Memorial Bursary

In 2012, the Ratuski Family established an endowment fund with an initial value of \$10,000, in memory of their parents Anne and Peter Ratuski, as well as their siblings Gregory Ratuski (LL.B/56) and William Ratuski (C.A./62). The Manitoba Scholarship and Bursary Initiative has made a contribution to the fund. In keeping with the family's heritage and cultural background, the bursary will be awarded to an undergraduate student enrolled in the Faculty of Arts and majoring in Slavic Studies. Each year, the available annual interest will be awarded to an undergraduate student who:

- (1) is enrolled full-time majoring in Slavic Studies in the Faculty of Arts (may include coursework in Ukrainian language, Ukrainian literature and/or Ukrainian cultural studies);
- (2) has a minimum degree grade point average of 2.0;
- (3) demonstrates financial need on the standard University of Manitoba bursary application form.

The selection committee will be named by the Department Head (or designate) of the Department of Slavic Studies in the Faculty of Arts

The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modification shall conform as closely as possible to the expressed intention of the donor in establishing the award.

#### Wilding-McLean Entrance Scholarship in Arts

In celebration of the 70<sup>th</sup> anniversary of her graduation from the University of Manitoba in 1942, Marjory McLean has established an endowment fund with an initial gift of \$42,000. The fund will be used to provide an entrance scholarship for high-achieving students entering their first year in the Faculty of Arts under the Direct Entry Program Option. Each year, the available annual interest from the fund will be used to offer one scholarship to an undergraduate student who:

- (1) has graduated from a high school in the province of Manitoba;
- (2) is admitted to the University of Manitoba under the Direct Entry Program Option to the Faculty of Arts with a minimum average of 85% on those courses considered for admission to the University of Manitoba;
- (3) is enrolled as a full-time (minimum 80% course load) undergraduate student in the year in which the scholarship is tenable;
- (4) is registered for a 1000 level course in English Literature in the Department of English, Film, and Theatre.

Preference will be given to students from rural Manitoba.

The Dean of the Faculty of Arts (or designate) will name the selection committee for this award.

The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modifications shall conform as closely as possible to the expressed intention of the donor in establishing the award.

#### **Youth Mentorship Bursary**

A trust fund has been established at the University of Manitoba in 2012. The purpose of the fund is to support access to post-secondary education for youth from disadvantaged social and/or economic backgrounds. The fund will be used to offer entrance bursaries for students who have participated in the Let's Talk Science Youth Mentorship Program offered through the Faculty of Science at the University of Manitoba and subsequently enter post-secondary study at the University of Manitoba. Each year, the interest and the accumulated revenue of the fund will be used to offer one or more bursaries, valued at \$500 each, to undergraduate students who:

- (1) have participated in the Let's Talk Science Mentorship Program at the University of Manitoba through a Manitoba High School;
- (2) have qualified for admission and subsequently are enrolled full-time (minimum 18 credit hours) in any faculty or school at the University of Manitoba;
- (3) have demonstrated financial need based on the standard University of Manitoba bursary application form.

The Let's Talk Science Coordinators in the Faculty of Science will provide a complete listing of the previous years' Let's Talk Science participants to the Awards Selection Coordinator by no later than October 1 every year.

The selection committee will be named by the Director, Financial Aid and Awards (or designate).

The Board of Governors of the University of Manitoba has the right to modify the terms of this award if, because of changed conditions, it becomes necessary to do so. Such modification shall conform as closely as possible to the expressed intention of the donor in establishing the award.

Dear Dr. Kuhn,

I am writing in support of a minor amendment to the Christine Egan Memorial Scholarship, which is administered by the University of Manitoba. This scholarship supports the study of Nunavut nursing students. As the scholarship is open only to Inuit people from Nunavut, it is considered a discriminatory award. It has previously been granted an exemption to the University policy on non-acceptance of discriminatory awards, as it addresses the socioeconomic and health disadvantages faced by the Inuit people of Nunavut, which have been well documented.

The proposed amendment is a small technical one, that formalizes a mechanism put in place last year to help stabilize the amount of funding awarded following the transit of the scholarship from the MMCF to the University of Manitoba. Apart from that, there have been no changes in the circumstances and justification for the scholarship, as presented to the Senate Committee on Awards in April 2011. On behalf of the Department of Community Health Sciences, I fully support the continuance of this award, as amended. I would be pleased to provide any additional information or clarifications.

Please accept this letter as formal support for the amendment proposed to the Christine Egan Memorial Scholarship. I understand that t is the wishes of the family that her Memorial Scholarship specifically benefit and assist Inuit students pursuing a Nursing degree because of Ms. Egan's 'love of Nursing and her commitment to the health and education in Nunavut'. Indigenous students are still very much under-represented at the University of Manitoba and in all faculties, including Nursing but it is the Inuit population specifically that is the most under-represented\*.

As the Director of the Aboriginal Student Centre, I continue to voice the concern, and can verify, that financial strain is the leading cause for Indigenous students leaving school before graduation. It is common knowledge that many Aboriginal peoples live in poverty and whereas a university education can help rectify this, most cannot afford to do so and few have the privilege of obtaining financial support from their families. Bursaries and scholarships are a major component of a successful retention plan.

The number of Aboriginal students attending the University of Manitoba continues to increase and, I believe, is partially due to the financial assistance made available through scholarships such as this. The Christine Egan Memorial Scholarship will provide assistance specifically for Inuit students from Nunavut and thereby assist with increasing the Inuit representation at the University of Manitoba.

\*As of November, 2012 there were 2087 self declared Aboriginal students attending the University of Manitoba with only 11 self declared as Inuit. 143 self declared Aboriginal students are in the Faculty of Nursing, or 6.9% of the program (Office of Institutional Analysis, 2011) but given there are only 11 self declared Inuit students overall the percentage in any faculty would be minimal at best.

Dear Dr. Barnard:

In accordance with the Student Discipline By-Law, I hereby submit the Annual Report of the University Discipline Committee (UDC) for the period September 1, 2011 to August 31, 2012. The attached Report on University Discipline cases summarizes all offenses and dispositions reported to me. I wish to thank all those offices who responded quickly to my request for submissions.

The UDC has continued to produce its report in chart format, and we have maintained the two major divisions, the first dealing with varying forms of "Academic Dishonesty" and the second addressing disciplinary matters which involve "Inappropriate Behaviour". Within each of the two major categories, like disciplinary matters have been grouped together for easier reference. Further, we have provided two graphs which offer a visual overview of disciplinary matters. The graphs span a five-year period.

I would make the following observations concerning the report's contents:

- 1) The overall numbers of incidents increased this year in relation to last year, both in raw numbers and as a percentage of the student body. The numbers remain generally consistent in most categories compared to last year's results with the exception of:
  - a. increases in reported incidents of:
    - Part 1: Contravention of examination regulations and plagiarism;
    - Part 2: Disorderly conduct and unprofessional conduct; and
  - b. decreases in reported incidents of:
    - Part 1: Cheating on mid-term tests, copying from other student's/own previous work; and
    - Part 2: Computer-related incidents and vandalism.

The University undertakes many worthwhile efforts to increase awareness about plagiarism and yet reported incidents continue to rise. It would appear that the university community needs to continue our collective efforts in this area.

2) There are six incidents that were carried over from last year as all appeals had not been exhausted in the previous reporting period. These incidents are not included in the final numbers as they were counted in last year's annual report.





## Report of the Senate Planning and Priorities Committee on Undergraduate Enrolment Targets (for information and discussion)

#### **Preamble:**

- The terms of reference of the Senate Planning and Priorities Committee (SPPC) are found on the website at <a href="http://umanitoba.ca/admin/governance/governing\_documents/governance/sen\_committees/510.html">http://umanitoba.ca/admin/governance/governing\_documents/governance/sen\_committees/510.html</a> wherein SPPC is charged with advising and making recommendations to the President on any matter which the President may refer to the Committee.
- 2. The Board policy on Enrolment Limitation specifies that, "...it is the President who approves changes to, or the introduction of, enrolment limits following consultation and discussion with the dean or director and with Senate. Prior to approving any changes, the President reviews the proposed changes with the Board."

- 3. The Committee met on the date noted above to consider proposed undergraduate enrolment targets.

### **Observations**:

- 1. The Committee received an update on plans to establish a Strategic Enrolment Management (SEM) Planning Framework, as presented to Senate at its meeting on January 9, 2013. The Committee had previously received a presentation on SEM planning at its meeting on April 30, 2012.
- 2. The Committee considered undergraduate enrolment targets, as set out in the attachment to this report. The proposed targets have been established in consultation with the Deans and Directors of each Faculty and School and reflect current enrolment levels in undergraduate programs over the past five years.
- 3. The proposed undergraduate enrolment targets would replace existing enrolment quotas (i.e. targets), which may have been established as early as 1970 for some units, as well as admission targets currently used by Enrolment Services and/or the Office of Institutional Analysis (OIA). It was noted that existing targets: are outdated; sometimes differ between the Faculties/Schools, Enrolment Services, and the OIA; in some cases, are unclear with respect to whether they apply to a Faculty/School or to a particular program.
- 4. The proposal anticipates the development and approval of a Strategic Enrolment Management Planning Framework at the University. The purpose of establishing up-to-date and clear undergraduate enrolment targets that reflect the current enrolment situation in each Faculty and School, is to establish a baseline that subsequently can be used in SEM Planning.

- 5. It was noted that the proposed targets are currently being used by Deans and Directors in strategic resource planning for the coming year. Moving forward, undergraduate enrolment targets would be reviewed on an annual basis, as a normal aspect of SEM Planning activities.
- 6. The proposed undergraduate enrolment targets are to be forwarded to the Senate and the Board of Governors for consultation and discussion prior to approval by the President.
