

The student and advisor/co-advisor may request in writing that the Dean of the Faculty of Graduate Studies restrict access after submission of the digital version of a thesis or practicum to The University of Manitoba for a period of up to two years. The Dean shall determine for what period, if any, access will be restricted based on the presented information.

The embargo of a thesis is an exception, not the norm. Students are encouraged to seek guidance on publishing options that allow the thesis to be publicly available. Permanent restriction of a thesis is not allowed. All requests should be emailed to <u>graduate.programs@umanitoba.ca</u> once all signatures have been obtained. You do not need to wait for permission to be granted. Please proceed with uploading your thesis to MSpace when you are ready to do so and enter the embargo end date. You will be notified by email if additional information is required.
