### **Funding for Indigenous research students**

MSc students are eligible for up to \$20,000 (CAD) per year for the first two years of study, while PhD students are eligible for up to \$40,000 (CAD) per year for the first four years of study.

### Low tuition fees

Pay approximately \$14,000 (CAD) per year for the first year (for MSc) or first two years (for PhD), plus approximately \$3,000 (CAD) total for the remaining years of study.

### **GMAT** preparation assistance

Through funding from Canadian Western Bank, eligible prospective students may receive assistance to help prepare to write the GMAT exam, required for admission.

## Supportive and diverse community

Among our faculty members you will find supportive professors who are committed to your success through your graduate research program.

Many of our professors are current and former members of our Committee for Indigenous Business Scholarship.



Fellowships will be offered to Indigenous graduate research students who have also become members of Indigenous Business Education Partners.

# **ADMISSION REQUIREMENTS**

GMAT — a minimum score of 600 (or equivalent GRE score). Must not be older than five years.
Bachelor's degree — from a recognized university with a minimum GPA of 3.0 (on 4.5 scale) in last two years of study.

- Three letters of recommendation from previous professors
- A statement of goals and interests
