#### **Brian Bowman**

Vice President of sustainability and social impact, Canada Life

Brian Bowman was born and raised in Winnipeg, Manitoba. Having served as Winnipeg's 43rd Mayor, he is one of Manitoba's best known and respected political figures.

Brian earned his Bachelor of Arts (Advanced) from the University of Manitoba in 1996 and his Juris Doctor from the University of Toronto in 1999. He was Called to the Manitoba Bar in 2000. Brian then worked in private practice with two prominent Winnipeg law firms from 2000 – 2014, during which time he specialized in the areas of privacy, access to information and social media law. He has been acknowledged by The Canadian Privacy Law Review as one of Canada's "leading privacy law authorities" and has been a frequent legal speaker, media commentator and author. Brian has served as Chairperson of the Canadian Bar Association's National Privacy and Access Law Section as well as the Manitoba Bar Association's Technology and Intellectual Property Law Section.

Brian is Métis and a proud citizen of the Manitoba Métis Federation. In 2014, he was first elected Mayor of Winnipeg (Canada's 6th largest municipality) in a landslide victory, becoming the first Indigenous Mayor of a major Canadian city. In 2018, he was re-elected for a second term in office with an increased plurality and number of votes.

Under his leadership, Mayor Bowman guided the City's response to the global pandemic, transformed its reconciliation and human rights efforts, while delivering more than \$2.5 billion in tri-level government funding for infrastructure to support Winnipeg's steady population growth. He spearheaded new accountability measures - including the creation of the City's first Integrity Commissioner position - and Open Data/Open Government initiatives, which were recognized by the Intelligent Community Forum when Winnipeg was named the "World's Most Intelligent Community". Mayor Bowman delivered eight (8) balanced budgets and oversaw the creation of the City's first ever four (4) year multi-year balanced budget process and Asset Management Plan. He founded Winnipeg's One Million Tree Challenge, with the goal of planting one million new trees before Winnipeg's population reaches one million residents. He was an active member of the Federation of Canadian Municipalities (FCM) Big City Mayor's Caucus and served as lead inter-governmental representative for the City of Winnipeg, which included regular dialogue and collaboration with the Prime Minister of Canada, Premier of Manitoba and Indigenous government leaders. His legacy includes national leadership for reconciliation, providing a steady hand during the global pandemic, restoring trust and integrity in Winnipeg's municipal government and successfully building the foundation for a more inclusive city of one million residents.

More recently, Brian has been serving as Vice-President, Sustainability and Social Impact for Great-West Lifeco, where he is providing leadership to increase collaboration and coordination in global operations in Canada, the U.S. and Europe. He is developing a global sustainability and social impact strategy, working on reconciliation efforts in Canada and addressing similar challenges in the United States and Europe, while strengthening and building relationships with community partners.

Brian has lived and worked in Australia and Mexico City. He is a recipient of Queen Elizabeth II's Platinum Jubilee Medal and the Manitoba Bar Association's Community Involvement Award. He has volunteered for numerous organizations and has served as Chairperson for the Winnipeg Art Gallery, the Winnipeg Chamber of Commerce and the University of Manitoba's Alumni Association.

Brian is married to Tracy Bowman. Together, they are raising their two sons, Hayden and Austin.





#### **Charles Henaire**

Deputy CFO and Chief Accounting & Control Officer, Great-West Lifeco

Charles is the Deputy CFO, Chief Accounting & Control Officer, Great-West Lifeco. Graduating from the University of Manitoba with a Bachelor of Commerce Degree with Distinction, and a designated Chartered Professional Accountant, Chartered Accountant – Charles Henaire was one of the youngest CAs in Manitoba to receive his FCPA, FCA designation.

Charles joined Great-West in 1994 and worked on the Confederation Life Due Diligence in March 1994. He has participated in the following acquisitions: London Life – 1997, IGM of MFC in 2001, Canada Life – 2003, Putnam in 2007, Irish Life - 2013.

Charles exemplifies a commitment to excellence and encourages innovation, not only in business, but also within the community & volunteer work. He continues to be involved in his community and profession and was the first recipient of the Early Achievement Award from the Institute of Chartered Accountants of Manitoba and the Deloitte Alumni Leadership Award. While at The University of Winnipeg, he served as president of the Students' Association and his achievements included creating a new home for the Indigenous Students' Centre.

Chris is currently Vice President, Policy and Engagement with the Winnipeg Chamber of Commerce. In this role, he is responsible for developing the Chamber's policies and advocacy priorities, as well as the government relations and community engagement strategy. Previous to this, Chris held the role of Associate Vice-President, External Relations at the University of Winnipeg for seven years, where he worked extensively with community organizations, businesses, and governments to strengthen partnerships and relationships.

Minaker's professional career began at Volunteer Manitoba where he helped to establish the Leadership Winnipeg program in partnership with the Winnipeg Chamber of Commerce. Chris also worked with the Manitoba government for close to nine years as a Project Director in the ministries of Agriculture, the Civil Service Commission, Families and Housing, Federal-Provincial Relations, and Executive Council, which is a key link between the political side of government and the professional civil service.

Diane is a key pacesetter in the creation of a robust Indigenous Innovation ecosystem in Canada and holds many influential roles including; Chair of the Indigenous Innovation Initiative Council with Grand Challenges Canada; member of the inaugural Indigenous Innovation Advisory Council with Saskatchewan Indian Institute of Technologies; and member of the inaugural Council of Aunties for the Fireweed Fellowship, the first national Indigenous Entrepreneurship Accelerator.

Her Board of Directors commitments are geared toward forging new ground and include: The Winnipeg Foundation where she seeks to create space for Indigenous philanthropy; the Winnipeg Art Gallery that hosts Quamajuq, the largest public collection of Inuit art in the world; North Forge Technology Exchange, Canadas largest non-profit fabrication lab; and Animikii Inc., a leading Indigenous technology company.

Diane is a TEDx speaker on the topic of Indigenous Social Innovation and is recipient of the Governor General's Meritorious Service Medal, recognized for Outstanding Indigenous Leadership. She is a recipient of the Manitoba Women Trailblazers Award by the Nellie McClung Foundation. Diane holds both Bachelor of Arts and Bachelor of Social Work Degrees
