Graduate Student Shared Study Space

The Faculty of Education is committed to providing a shared study space as a support for Faculty of Education graduate students. The Associate Dean (ADGR), the Facilities Coordinator, and EdGSA collaborate to establish the procedures for the use of the study space.

Access

All graduate students are eligible to access the study space. To access the space the student will submit the Study Space Usage Agreement form (below) to the Graduate and Research Office adgr.education@umanitoba.ca

Once approved, the Facilities Coordinator will:

- a) facilitate an appointment for the student with the Physical Plant Office to activate the student ID card for building access;
- b) provide the student with the door access code for the study space, room 316;

General Guidelines & Conditions for Use

The study space (currently room 316) is a shared space that normally has spaces for 16 students at one time. Masks must continue to be worn in all indoor spaces on UM campuses. Beginning May 4, KN95 masks are highly recommended, but 3-ply medical masks (minimum ASTM Grade 2) will also be acceptable. **Please stay home when you are sick.**

Students must have their student ID card with building access and their door access code to enter the building and must not allow others into the building or the study space.

In order to keep the study space welcoming, clean and safe, students are responsible for:

- being respectful of others while in the space;
- cleaning up and sanitizing all items used;
- removing all items when leaving the room (the University and Faculty of Education are not responsible for lost or damaged items).

In regards to access, please note that:

- students can access the study space during the faculty's open hours (Monday-Sunday 8:30am-8:30pm).
- the study space will be closed during statutory holidays including Winter Break closure. UM holiday closures can be found here: <https://umanitoba.ca/registrar/important-dates-deadlines>

- sometimes the study space will be closed during maintenance or service disruptions. Students will be emailed when building closures occur. UM service disruptions can be found here: https://umanitoba.ca/admin/vp_admin/ofp/ohrcm/accessibility/service-disruptions.html
- students must exit the building during a fire alarm and cannot re-enter until cleared by Emergency Fire personnel or UM Fire wardens.

COVID-19 Safety Measures
