1. GENERAL INFORMATION

The selection of students for admission to the Master of Physical Therapy (MPT) program follows the Academic Guide of the Faculty of Graduate Studies and the Physical Therapy Supplemental Regulations. The selection process is the responsibility of the Selections Committee, a standing committee of the Master of Physical Therapy Program Committee of the College of Rehabilitation Sciences. Successful applicants are admitted to the Faculty of Graduate Studies.

This guide provides information to applicants holding a previous undergraduate degree who are seeking admission to the Master of Physical Therapy program for 2024-2025. Admission requirements for entrance into the Master of Physical Therapy program can be found on this website and in this applicant guide.

2. STATEMENT OF QUOTA

In the academic year 2024–2025, the University of Manitoba will accept 50 students into the MPT program.

3. ELIGIBILITY REQUIREMENTS

All applicants to the MPT program must meet the following eligibility requirements:

- a) Canadian citizenship or permanent resident status at the time of application.
- b) Successful completion of an accredited 3- or 4-year undergraduate degree recognized by the University of Manitoba. For 2024 admission, degrees must be conferred by the Fall of 2024.
- c) A minimum grade point average (GPA) of 3.25 in the last 60 credit hours of study at the time of application. Information on GPA calculations and equivalency tables can be found [here](#) on the Faculty of Graduate Studies website.

For MPT admission interview offers and the overall score used in selections, the grades from university courses completed by the MPT application deadline (November 15, 2023) will be used in the last 60 credit hour GPA calculation. If a student is recommended for admission to the MPT program with outstanding coursework, final official transcripts will be required showing that all coursework has been successfully

completed and that the GPA in the most recent 60 credit hours has remained at a 3.25 or higher.

- d) A minimum grade of 'B' in each prerequisite course or approved alternate course by December 31, 2023. For a listing of approved prerequisite courses and information on how to request a prerequisite review **see page 13 of this guide**.

The required courses from the **University of Manitoba** are:

- **Anatomy of the Human Body** (BIOL 1410 *Anatomy of the Human Body* or KPER 2320 *Human Anatomy* with KIN 3320 *Advanced Human Anatomy*)
- **Physiology of the Human Body** (BIOL 1412 *Physiology of the Human Body* or BIOL 2410 *Human Physiology 1* with BIOL 2420 *Human Physiology 2*)
- **Introductory Statistics** (STAT 1000 *Basic Statistical Analysis 1* or STAT 1150 *Introduction to Statistics and Computing*). Research Methods courses from departments other than statistics may be used in lieu of statistics (e.g. PSYC 2250 *Introduction to Psychological Research*).
- Minimum 3 credit hours in **Psychology** (PSYC 1200 *Introduction to Psychology*) Applicants with a grade lower than a 'B' in Introductory Psychology may use a higher-level Department of Psychology course towards this requirement (with the exception of Research Methods courses). Psychology related courses from other departments do not typically meet this requirement.
- Minimum 3 credit hours in **English Literature**. (ENGL 1200 or ENGL 1300 or ENGL 1310 or ENGL 1340 or ENGL 1400) Courses from a Department of English with a significant amount of written work will be accepted.

NOTE: New beginning in 2025-2026 the MPT program is introducing a 3 credit hour Indigenous Studies prerequisite requirement. Accepted courses include INDG 1200, INDG 1220, INDG 1240, INDG/HIST 2010, INDG/HIST 2020, INDG 2080 and their equivalencies from other institutions.

Prerequisite review requests must be received by the MPT Chair of Admissions no later than **October 1st** in order for pre-assessment prior to the November 15th application deadline.

Potential applicants with course work not previously reviewed by October 1st are encouraged to submit an application before the November 15th deadline and email their course syllabi to CORS.PTprogram@umanitoba.ca at the time of application. If course work is found not equivalent there will be no refund of the application fee.

- e) The prerequisite of Physiology must be completed within **5 years** of application (no earlier than 2019). All other prerequisite courses must be completed within **10 years** of application (no earlier than 2014).

Where evidence of application of the knowledge can be demonstrated, exceptions to the time limit may be considered on a case-by-case basis by the MPT Chair of Admissions. A written request and supporting documentation (e.g., transcripts, resume) must be submitted by email to the MPT Chair of Admissions at CORS.PTprogram@umanitoba.ca.

f) Completion of the **CASPer** test

All applicants to the MPT program at the University of Manitoba for 2024-2025 are required to complete an online assessment, [CASPer](#).

Master of Physical Therapy, University of Manitoba test dates can be located for the Canadian Professional Health Sciences (**CSP-10201-Canadian Professional Health Sciences test**) on the Acuity Insights website here: <https://acuityinsights.app/>.

CASPer test dates for applicants to the MPT program for fall 2024 are available from July 2023 until November 2023 (November 23, 2023 is the last available test date). Applicants must select the *option Masters in Physical Therapy at the University of Manitoba* before the posted Distribution Deadline (December 6, 2023) on the Acuity Insights website. Please contact Acuity Insights directly to request accommodations or financial assistance (financial and or disability accommodations). Applicants to the MPT program are not required to complete the duet assessment.

g) Where required, written evidence of English language proficiency scores in keeping with the [Canadian Alliance of Physiotherapy Regulators](#) and the [College of Physiotherapists of Manitoba](#). Students whose education was not in English are required to provide written evidence of English language proficiency scores in keeping with the [Canadian Alliance of Physiotherapy Regulators](#), the administrators of the national Physiotherapy Competency Examination required of all graduates in order to practice in Canada.

Please note that Physical Therapy requires scores above the FGS minimum requirements, as follows:

TEST	Minimum Score required
TOEFL – internet-based	92 with no sub-score < 21
IELTS (academic version)	7, must include all 4 components

4. SELECTION CRITERIA AND PROCEDURES

The criterion for selection shall be an **Overall Score** that considers an applicant's academic standing (based on the last 60 credit hour GPA) and interview performance. Academic standing will constitute 60% of the overall score, while the interview score will account for 40% of the overall score. Students will be rank ordered in accordance with the Overall Score.

4.1 Calculation of Student Ranking

4.1.1 Academic Standing:

A last 60 credit hour GPA will be calculated including courses completed by the application deadline (November 15, 2023). The last 60 credit hour GPA calculation will not include courses completed after the application deadline.

NOTES REGARDING CALCULATING THE LAST 60 CREDIT HOUR GPA:

- i. Should an applicant repeat a course, the higher grade will be considered in calculating the grade point average.
- ii. The last 60 credit hours will include all university level courses that fall within the last 60 credit hours. Courses will be considered:
 - Regardless of whether they are part of a degree (i.e. if courses are taken after the degree is completed)
 - Regardless of the academic session (i.e. regular or spring/summer sessions)
 - Regardless of whether they were taken part-time or full-time.
- iii. If a semester is reached that has more credit hours available than are needed to reach 60 credit hours the highest level courses will be used first then courses with the highest grades.

Applicants have until **December 31, 2023** to complete the required MPT prerequisite courses with the minimum grade of a 'B'.

Prerequisite courses will only be reviewed for applicants in a competitive range for a Multiple Mini Interview offer. If a prerequisite course has not previously been reviewed for equivalency, our office will be in contact with the applicant to request a detailed course syllabus. If course work is found not equivalent there will be no refund of the application fee. Applicants missing prerequisite courses or with grades below the minimum requirement of a 'B' will not be considered for Multiple Mini Interview offers.

Prerequisite courses for applicants not found to be in the competitive range for an interview offer *will not be* reviewed in detail.

4.1.2 Interview:

Applicants with the potential for admission will be interviewed as part of the admissions process. Eligibility alone does not guarantee an interview. Interviews are generally held in early or mid-March every year and take the form of the Multiple Mini-Interview, whereby the applicant will move between six 10-minute-long stations. The applicant is expected to respond to questions about themselves, the profession, the University of Manitoba Physical Therapy program and specific scenarios.

The interviewers represent the College of Rehabilitation Sciences and the physical therapy clinical community. Interviewers will not have access to academic information. Applicants will be assessed and an interview score calculated based on responses to a standard set of interview questions. All applicants must pass the interview process to be considered for admission. For more information on the MPT MMI please visit the Physical Therapy website [here](#). 4.1.3 Overall Score:

The last 60 credit hour GPA and the interview score will be converted to standardized z-scores before combining scores (60% Last 60 credit hour GPA: 40% Interview Score) to yield an Overall Score using the following formula:
 $(\text{Last 60 credit hour GPA} \times 0.6) + (\text{Interview Score} \times 0.4) = \text{Overall Score}$

Note: Standardization into a z-score is not shown as this calculation depends upon the remainder of the applicant pool.

4.2 Priority for Selection

The Admissions and Selection Committees will consider applicants in the following priority groups.

Canadian Indigenous Peoples Category:

Canadian Indigenous peoples who meet all entry requirements will be given priority for up to 20% of the admission seats. Canadian Indigenous Peoples include First Nations, Métis and Inuit. Proof of Indigenous ancestry is required, such as a photocopy of a Treaty card, a membership card with the Manitoba Métis Federation or a letter of verification from a Band Council.

First Priority: Manitobans

Graduates of the universities within Manitoba who are Canadian citizens or permanent residents and Manitoba residents who are graduates of out-of-province universities will be given first priority.

Second Priority: Canadians Who Reside in Other Provinces or Territories

Up to five spots will be held for competitive out-of-province candidates who are Canadian citizens or permanent residents, who are graduates of universities recognized by the University of Manitoba and who are residents of Canadian provinces or territories other than Manitoba.

5. ADDITIONAL INFORMATION REGARDING THE CANADIAN INDIGENOUS APPLICANT CATEGORY

The intent of the Canadian Indigenous priority category is to ensure that Indigenous peoples of Canada have access to health professional education. This priority category is one response to the Reconciliation Call to Action #23, which is to increase the number of Indigenous professionals working in the health-care field, and ensure the retention of Indigenous health-care providers in Indigenous communities. Further, the Department of Physical Therapy recognizes the positive ripple effects of having First Nations, Métis and Inuit rehabilitation professionals directly care for people in their own communities or any health facility in Canada.

First Nations, Métis and Inuit people face large health gaps in accessing health services when compared to the mainstream populations. This is rooted, partly, in historic and current systemic marginalization and disadvantage. The Department of Physical Therapy is committed to addressing disparity in higher education, as well as in the health and social professions.

The Department of Physical Therapy is committed to supporting First Nations, Métis and Inuit students. Most importantly, the Department recognizes positive ripple effects as First Nations, Métis and Inuit students inspire family and community members to pursue their dreams and contribute positively to the health of our province and country. At the same time, First Nations, Métis and Inuit cultures highly value reciprocation of opportunity.

The intent of this stream is to ensure that First Nations, Métis and Inuit students have an opportunity to become rehabilitation professionals and to support students to maintain long-term cultural and social linkages with First Nations, Métis and Inuit communities within this principle of reciprocity.

Applicants who self-identify as First Nations, Métis or Inuit will have their contact information shared with the Senior Lead Indigenous Health Student Affairs, Ongomiizwin Education. The Senior Lead will contact all applicants to begin to develop a relationship that will be a source of support throughout their learning journey.

6. ADVISING OF APPLICANTS TO THE MASTER OF PHYSICAL THERAPY PROGRAM

The Department of Physical Therapy will assist all applicants who seek advising regarding admission to the Master of Physical Therapy program. However, it is the department's policy not to instruct applicants as to the specific course of action that they should follow, but rather to provide the information needed for applicants to make their own decisions. The following points should be noted:

- a) Applicants are encouraged to discuss their plans with all who can usefully advise them, but they should be aware that second-hand information about the department's admissions policies is not considered reliable.
- b) No faculty member of the College of Rehabilitation Sciences can guarantee admission of any applicant.
- c) Applicants are advised to make inquiries in writing to the Chair of Physical Therapy Admissions so that an official written response can be provided.

7. CRIMINAL RECORD, CHILD ABUSE AND ADULT ABUSE REGISTRY CHECKS: THE TWO-STEP PROCESS

Physiotherapy is a self-regulated profession with a mandate to protect the public. These checks are necessary to facilitate completion of the MPT program, they are required for student registration with the College of Physiotherapists of Manitoba (CPM) and to engage in clinical placements throughout Canada during the program. The presence of a positive record check could impact a student's ability to complete the program and/or work as a fully licensed Physiotherapist upon completion of the MPT program.

7.1 On application to the MPT program:

All applicants to the MPT program must self-declare prior adult criminal convictions and listing as an offender on the Child Abuse Registry or Adult Abuse Registry in the application process. Any communications regarding these self-declarations will be kept in a secure and locked location, where only the Chair of the Admissions and Selections Committees will have access. Such communications will be subsequently destroyed for those applicants not admitted. Any fraudulent claims made on the self-declaration will result in immediate dismissal from the program.

7.2 Following admission to the MPT program:

For those applicants admitted to the program, the self-declaration communications will be destroyed upon the applicant's submission of original, current, official versions of their (a) Criminal Record Check with Vulnerable Sector Search, (b) Child Abuse Registry Check and (c) Adult Abuse Registry Check to the Academic Coordinator of Clinical Education of the MPT program. Documents procured by the student will remain the property of the student. ***It is essential that successful applicants obtain and submit each of these documents in strict accordance with the processes and timelines provided by the Department of Physical Therapy. Information on these requirements will be emailed to incoming students near the end of June 2023.***

The implications for MPT students who have an adult criminal record or who are on the Child Abuse or Adult Abuse Registries as an offender are as follows:

- Individuals identified as offenders on the Child Abuse Registry and/or Adult Abuse Registry are ineligible for admission.
- Individuals with a criminal record:
 - may not be able to complete the MPT program because of denied access to required clinical education components of the program; or
 - may have conditions placed on their registration status post-graduation or be prevented from registering and working as a physical therapist;

It is important to note that having an adult criminal record will not necessarily result in denial of admission to the MPT program. We encourage any individual who is planning to apply to the MPT program and who has an adult criminal record to:

- a) Contact the Head of the Department of Physical Therapy at the University of Manitoba to discuss potential issues related to their individual situation.
- b) Seek information from the regulatory organization in the jurisdiction where they plan to practise upon graduation. For Manitoba, the regulatory organization is the [College of Physiotherapists of Manitoba](#) (CPM).

Once a successful applicant is admitted into the MPT program, the Department of Physical Therapy has a process in place to review, within the context of our professional mandate to protect the public, on a case-by-case basis, the situation of any student who has a criminal record.

The review process by the Department of Physical Therapy is independent of any review processes conducted by clinical sites, regulatory colleges or future employers.

8. ADDITIONAL REQUIRED DOCUMENTS FOR SUCCESSFUL APPLICANTS FOLLOWING ADMISSION TO THE MPT PROGRAM

In addition to the (a) Criminal Record Check with Vulnerable Sector Search, (b) Child Abuse Registry Check and (c) Adult Abuse Registry Check referred to in Section 7 of this guide, successful applicants to the MPT program are also required to submit (d) a completed Immunization Package to ensure all mandatory vaccinations are current for participation in clinical placements, (e) Cardiopulmonary Resuscitation (CPR) certification at the Basic Life Saver (BLS) for Healthcare Provider level (or higher) provided by an instructor certified through the Heart & Stroke Foundation, and (f) N95 mask-fit certification, in order to participate in clinical placements.

Note that the College of Rehabilitation Sciences may provide assistance with the application process and costs associated with the Child and Adult Abuse Registry checks and N95 mask-fit testing. ***It is therefore essential that successful applicants carefully read the information provided by the Department of Physical Therapy to ensure they obtain and submit each document in strict accordance with the processes and timelines indicated.***

9. SELECTION COMMITTEE

The Selection Committee consists of:

- The Chairperson of the Committee (shall be a MPT faculty member)
- The Head of the Department of Physical Therapy
- Two faculty representatives from the Department of Physical Therapy
- One student representative from the Department of Physical Therapy
- One representative from the College of Physiotherapists of Manitoba
- One representative from Ongomiizwin
- Such other persons who, from time to time, are deemed appropriate
- The Dean of the College of Rehabilitation Sciences (Ex-Officio)

Once Selections Committee decisions have been made, applicants will receive an email from the Faculty of Graduate Studies notifying them to log into their application portal to view the decision. Students that are offered admission will be required to accept or decline within 14 days from the date on the letter of offer. If a response is not provided within 14 days of the date on the letter, the offer will lapse. Lapsed offers will be considered a declined response. It is imperative that emails and application portals are checked regularly.

Please ensure that your email account remains current and will accept emails from the University of Manitoba (check your filters).

10. APPEALS

Individuals who wish to appeal decisions of the Selection Committee should refer to The Faculty of Graduate Studies Academic Guide and the University of Manitoba Policy on [Admission Appeals Procedures and Guidelines](#).

Generally, these policies advise individuals who wish to have their applications reconsidered by the committee to submit their request in writing to the Chair of the Selection Committee within ten days of the committee decision.

Any appeal of a reconsidered decision should be submitted within ten days following the emailing of the reconsidered decision to the University Secretariat, Room 312 Administration Building, for transmission to the University of Manitoba's Senate Committee on Admission Appeals.

Applicants are advised that appeals of the reconsidered decisions by the Senate Committee on Admission Appeals focus on questions of correct adherence to published policies and procedures by Selection Committees, and not on substantive issues or the relative merit of applications. 11. APPLICATION FORM AND SUPPORTING DOCUMENTATION

Students applying to the Master of Physical Therapy program may start their on-line application with the Faculty of Graduate Studies [here](#).

Applications are not considered received until the on-line application is submitted and the application is paid. The application fee of \$100.00 CDN must be paid by the November 15, 2023 deadline.

It is recommended that all supporting documentation be uploaded in the on-line application in order to meet the documentation deadline of November 15, 2023. An application is considered incomplete until all supporting documentation is received.

SUPPORTING DOCUMENTATION:

- **Unofficial transcripts from all universities/colleges** attended other than the University of Manitoba. All post-secondary institutions attended **must** be disclosed in the application. Transcripts and proof of enrolment in current courses is required as part of the application.

It is the applicant's responsibility to provide updated transcripts and inform the Admissions office at CORS.PTprogram@umanitoba.ca of any deferred exams or grade changes. All final fall 2023 grades, including grade changes must be uploaded through the application portal by the interim transcript deadline of January 31, 2024 in order for them to be included in the selection process.

University of Manitoba transcripts are not required as we can obtain them confidentially via Aurora. University of Manitoba students with a grade change in Aurora must provide notification to our office prior to the January 31, 2024 deadline.

Official documents will only be required by the Faculty of Graduate Studies from applicants offered admission.

- Proof of **Indigenous descent** if applying under the Canadian Indigenous Peoples Category.
- Evidence of **English language proficiency** where applicable.
- Upload relevant **written correspondence from the MPT Chair of Admissions** or CoRS Admissions Officer in support of your application if a special request has been granted (e.g., permission for an alternate prerequisite course or time limit waiver).

12. DEADLINE DATES

November 15, 2023: Deadline for receipt of all applications and supporting documentation

November 23, 2023: The last available CASPer test date for MPT 2024-2025 applicants

December 31, 2023: Deadline for the completion of MPT prerequisite courses

January 31, 2024: Deadline for interim transcripts including fall 2023 grades

Updated transcripts including Fall 2023 grades are to be uploaded through the application portal. It is the responsibility of the applicant to submit Fall 2023 marks prior to the interim transcript deadline.

Updated transcripts are not required for courses completed at the University of Manitoba. UM fall 2023 grades can be accessed internally through Aurora.

March 9 & 10, 2024: MPT Multiple Mini Interview (MMI) dates

June 20, 2024: Deadline for submission of complete and official university transcripts from admitted applicants. Official transcripts are to be mailed to the Faculty of Graduate Studies at:
