

# Extended Education Grant for Displaced Ukrainian Citizens

Extended Education wants to provide support to prospective international students who are citizens of Ukraine who have been displaced due to war. These students will be seeking to continue their education in Canada in the 2022/23 academic year.

Extended Education will offer up to two (2) grants starting in the 2022/23 academic year to cover full program fees for international students from Ukraine (who are Ukrainian citizens) admitted to Extended Education and registered in a certificate program.

## Criteria:

1. Students are from Ukraine (Ukrainian citizens approved to study in Canada under the Canada-Ukraine Authorization for Emergency Travel measures) who are displaced by war, and are seeking to continue their education in certificate program in Extended Education at the University of Manitoba;
2. have met the minimum admission criteria and have been admitted to an Extended Education program;
3. will be enrolled in the first year of study in Extended Education at the University of Manitoba for the fall or winter term of the 2022/23 academic year;
4. has not received any other U of M funding.

1. A completed Extended Education Grant Application form (page 1 & 2 of this form)
2. A brief letter outlining how this funding is required for you to study at the UM in the Fall/Winter 2022/23 academic year. Your comments will be very helpful in assessing eligibility or special needs. Please attach a one-page (maximum) letter to your email submission
3. A copy of your visa documentation (ex. foil-less visa for Ukrainian nationals or other IRCC document)
