# **Course Description and Delivery**

This course examines food consumption and production issues as discussed in current scholarship in geography and allied disciplines. It emphasizes that food is inherently geographical; all food is produced and consumed somewhere. Geographical insights on food issues centre on food production and consumption as they vary across space, in place, and at scales of human-environment interaction from the personal to the global. Students are challenged to build their own understanding of the complex relations between people, what they eat, where and why they eat it, where it is grown and how it travels to their plate.

# **Course Objectives**

- Increase student understanding of geographic relationships in food issues, patterns and practices
- Increase student understanding of food as a nexus for evolving local-to-global economic, social, cultural, political and environmental relations
- · Improve student skills in critical thinking, reading, and writing

## **Student Evaluation**

# Quizzes - 3x10% (30%)

Reading and critically evaluating the assigned readings are central to your success in the course and will feature prominently in quiz questions. Videos, films and lecture material are also 'fair game'. Quizzes will be held 3 times through the term. The dates will be:

- February 9<sup>th</sup>, 2017
- March 16<sup>th</sup>, 2017
- April 6, 2017

The quizzes are designed to ensure familiarity with course materials, and to potentially guide your choice of assignments and prepare you for the final examination.

\*\*\*Missed quizzes *generally* cannot be made up and students will normally receive a zero on any missed quiz.

You will have 30 minutes to complete a quiz.

Students who may need accommodations to complete their quizzes are encouraged to speak to the instructor as soon as possible.

# Assignments – 2 x 15% (30%)

Students are required to submit 2 independent assignment reports via UMLearn Dropbox. The reports are due:

- March 2, 2017
- April 6, 2017.

Students are to select a broad topic area from a list for each assignment (see below). Students will then refine the topic area in order to **effectively argue a position** in their assignment.

Assignments will be a maximum of 5000 words, follow APA format for any references used, including the citation of all figures, statistics, or images.

### Topics: Assignment 1

- Food ways, cooking, and the settlement of immigrants into communities
- The gendering of food and/or foodways
- National foods and food nationalism
- Identity, food, and cultural appropriation vs. cultural exchange
- Origins and evolution of a specific food crop, farmed livestock or food type (food history)

### Topics: Assignment 2

- Food safety: 'fake' and contaminated foods
- Effects of climate change on key or iconic food crops
- Traditional and/or wild food harvesting trends/issues
- Food insecurity and food bank use trends
- Alternatives to the mainstream food system: pro or con?

# Final Examination - 40%: To be scheduled by the Registrar's Office during the winter term final examination period

This will be a 2-hour, comprehensive examination of the entire course. Emphasis will be on the main themes presented throughout the course.

#### What Does the Grade Mean?

All quizzes and assignments will be returned to students in a timely manner, with the grade clearly noted, and with some relevant commentary from the instructor.

Penalties for engaging in academic dishonesty can include F-grades on assignments or the course, suspension for a period of up to five years from registration in courses taught in a particular department or from all courses taught in a Faculty. Faculty members have the right to submit student work that is suspected of being plagiarized to programs and sites designed to detect plagiarism.

# Writing and Learning Support
