Distinguished Professor Information

<u>Purpose</u>

Distinguished Professors are appointed by the Board of Governors on the recommendation of the Distinguished Professors Selection Committee. The title, Distinguished Professor, is conferred on academic staff members who have demonstrated outstanding distinction in research, scholarship, creative endeavours, professional service and teaching.

Eligibility

All active members of the academic staff of the University of Manitoba holding full-time appointments are eligible for nomination. Up to three people may receive the honour each year, and not more than twenty-five professors may hold the title at one time.

Criteria

The following general criteria are used as a basis for evaluating nominations:

- a) outstanding distinction in research or scholarship or, for nominations from units such as Fine Arts and Music, in creative professional activity;
- b) a significant record in teaching;
- c) some indication of the Nominee's standing in his/her field, not only from a national perspective but also from an international perspective.

Process

The Distinguished Professors Selection Committee considers nominations, letters of support, and evaluations from referees, and makes recommendations to the Board of Governors on appropriate candidates for the title. The committee is comprised of five members representing the health sciences, humanities, natural sciences, and social sciences, plus a distinguished scholar from any discipline, and is chaired by the President.

Citations

The citation is a statement of the significance of the candidate's work as prepared by one of the nominators. It is intended to state very briefly why a candidate should be elected, and is essentially a summary of the nomination. The citation should establish that the candidate has achieved such distinction as described in the relevant policies. Those preparing citations are asked to respect the limitation of length of 200 words. The citation should concentrate on the candidate's original contributions to research and scholarship and service.

The citation should be as readable as possible while sufficiently detailed in content to allow those considering the nominations to make a confident assessment of the candidate's work for voting purposes. When a candidate is selected by the Distinguished Professors Selection Committee, the citation is the only document that will be circulated to the Board of Governors to assist in the voting. If a nominee is approved, the citation may be used to inform and assist in the preparation of an official citation for all related publications. The citation is therefore an important document which should be carefully written and should contain as much useful information as possible.
