

Re-Registrations FAQs – Fall 2022-Winter 2023

Do I have to register for Fall 2022 term?

If you are not on an exceptional/parental leave of absence in Fall 2022 term, yes.

What do I register in for Fall 2022 term?

If you are a Ph.D. student: GRAD 8020 Doctoral Re-Registration CRN 10232

If you are a Master's student: GRAD 7020 Master's Re-Registration CRN 10218

If you are an MBA or MPA student, contact your departmental/unit graduate program assistant.

Do I have to register for Winter 2023 term?

If you are not on an exceptional/parental leave of absence in Winter 2023 term, yes.

What do I register in for Winter 2023 term?

If you are a Ph.D. student: GRAD 8020 Doctoral Re-Registration CRN 50198

If you are a Master's student: GRAD 7020 Master's Re-Registration CRN 50187

If you are an MBA or MPA student, contact your departmental/unit graduate program assistant.

Do I have to register in a Re-Registration every term?

Yes. This helps the Registrar's Office ensure you are assessed the appropriate fees.

If you are on an approved exceptional/parental leave of absence for a given term, you do not have to register in anything for that term.

I am planning to graduate in October 2022. Do I have to register?

No.

However, if there is a chance you may not graduate in October, please register. There is no harm in registering just in case your graduation is delayed.

I am planning to graduate in February 2023. Do I have to register?

Yes, in Fall 2022 term only. Make sure you register in your final Thesis/Practicum/Comprehensive Exam/Project or the final course specific to your program.

I will be on an approved exceptional/parental leave of absence in Winter 2023. Do I have to register?

Only for Fall 2022 term.

I am on a regular leave of absence in Fall 2022 and/or Winter 2023. Do I have to register?

Yes.

I was on an exceptional/parental leave of absence in Summer 2022 and am returning to studies in Fall 2022, do I have to register?

Yes. You may have to complete a Progress Report prior to being able to register. Please check your account for any potential holds.

I already completed GRAD 7500 and GRAD 7300 and have a PASS for each on my transcript. Do I have to register in them again?

No.

The only exception is if you have a break in your program(s) of greater than one term. See the [FGS Academic Guide](#) for more details.

I was admitted in Summer 2022. What [FGS BFAR](#) do I need to complete this term?

You need to successfully complete GRAD 7500 Academic Integrity Tutorial in your first term of registration (Summer 2022). If you have not yet done so and your Aurora shows you are registered in GRAD 7500, go to UMLearn now to complete it. If your Aurora does not show you are registered, contact your home department/unit and ask them to complete a registration revision form. If you do not successfully complete GRAD 7500, your student account will be placed on hold.

I was admitted in Fall 2021 or earlier. What [FGS BFAR](#) do I need to complete this term?

You need to successfully complete GRAD 7300 Academic Integrity Tutorial before August 31, 2022.

Please ensure you are registered in GRAD 7300 in Aurora, then go to UMLearn to complete the tutorial. If you do not successfully complete GRAD 7300, your student account will be placed on hold.

Do I have to complete GRAD 7500 and GRAD 7300 more than once?

No. However, there are a few exceptions: please see the [FGS Academic Guide](#) for more information.

I am a Pre-Master's student. Do I have to complete GRAD 7500 and GRAD 7300?

Yes.

This is all so confusing, what do I need to register in?

In general terms:

Re-Registration course EVERY TERM.

GRAD 7500 Academic Integrity Tutorial ONLY ONCE within the *first term* of your program.

GRAD 7300 Research Integrity Tutorial ONLY ONCE within the *first year* of your program.
