4. Program Expansion- Update

Overview of the potential to expand health student annual intake in the Rady Faculty provided (Nurse Practitioner, Master of Physician Assistant, International Medical Graduates, PGME, UGME and Rehabilitation Sciences). Focus will include primary care (especially rural/northern), mental health services and general specialty services. Approval required by February 2023 for the 2023/2024 CaRMS Match. Further expansion of UGME in 2023 would require a formal Brandon Satellite campus. Expansion of Bachelor of Nursing, midwifery, and Occupational Therapy submissions already submitted and underway.

Proposals submitted end of 2022. The clarifications required from Advance Education Skills and Immigration (AESI) have been submitted. Next to Treasury for consideration, next for cabinet discussion. The programs that need to go through AESI, are also required to go through University process; these are expansions to existing programs for advice, as opposed to approval. This is a two-step process, first, internal process of university advice from the Provost and President's offices, next from government receiving the proposal for consideration.
