FORMAL COMPLAINT

Hello,

I, Jane Doe, am writing to make a Formal Complaint under the Respectful Work and Learning Environment Policy. I allege Charles Xavier has harassed me based on the Human Rights Code protected characteristic of religious belief, as listed in the policy.

By way of background, I was speaking with several colleagues in the staff lounge of our department (room 9999, Shiny Building) between 12 and 1 pm, on Thursday, June 30, 2022. Mr. Xavier was present. We have been co-workers in the same department for roughly 9 years (I began my time in the office in October 2010; Mr. Xavier was already employed in the department).

The topic of the Canada Day celebrations of the following day emerged. Mr. Xavier asked everyone present what their plans were. I replied, "I don't have any plans." He persisted and asked why I wasn't celebrating Canada Day. I explained that my religious beliefs prohibited the celebration of nation states on such holidays as Canada Day. In reply to this comment, he laughed loudly and said to the group "Get a load of Jane everyone! She hates Canada, the greatest nation on earth! Can you believe this person? Pathetic."

This encounter left me feeling embarrassed and angry. I did not respond and instead left the staff lounge immediately. When I returned to work on Monday, July 4, I arrived at my office door to see a yellow piece of paper taped to it (attached). In red marker the page depicted a drawing of the maple leaf, and the words "No one's god is better than a democratic, secular nation, not even yours!"

I took the page immediately to our unit director, Dr. Morgan Sawyer. They explained that the caretaker (Frank Smith) had reported to them that at roughly 7:00 am on July 4, Frank witnessed Mr. Xavier tape the yellow page to my office door. Dr. Sawyer advised me to immediately seek the support of the Office of Human Rights and Conflict Management with this matter.

I have not approached Mr. Xavier about the incidents. Based on the behavior described above, I find him intimidating and hostile to my religious belief. I have made this complaint to hopefully prevent Mr. Xavier's behavior in the future.
