1. (A) Full-time staff is defined by Statistics Canada to include:

- i) Staff appointed to a full-time position for the academic year.
- ii) Staff appointed on a full-time basis, whose term of appointment is less than one year.

(B) Staff members not included: Administrators (whether classified as academic or not), such as the president, vice-presidents, etc.; librarians; post-doctoral fellows; graduate teaching assistants; markers, demonstrators, lab assistants, etc.; academic staff who have been hired as researchers rather than teachers; and support staff.

(C) Instructors are excluded from this analysis.

2. Effective Fall Term 2014, the Department of Human Nutritional Sciences moved from the Faculty of Human Ecology to the Faculty of Agricultural and Food Sciences.

3. The Asper School of Business was formerly reported as the Faculty of Management.

4. Effective November 2014, the Faculties of Dentistry, Medicine, Nursing, and Pharmacy became colleges in the Faculty of Health Sciences. The College of Rehabilitation Sciences (formerly, the School of Medical Rehabilitation) and the School of Dental Hygiene also became part of the new faculty.

5. For comparative purposes, figures for the School of Dental Hygiene are included in Dentistry.

6. For comparative purposes, figures for the College of Rehabilitation Sciences are included in Medicine.

7. The Faculty of Physical Education and Recreation Studies was renamed the Faculty of Kinesiology and Recreation Management in July 2007.

8. The Faculty of Music changed its name to the Marcel A. Desautels Faculty of Music in 2008.

9. "Others" includes heads of colleges and institutes.

10. Excluded teaching staff are not included in counts and are defined by Statistics Canada to include:

- (a) Religious and other staff paid according to salary scales lower than those applying to lay staff.
- (b) Staff on leave without pay.
- (c) Visiting staff.
- (d) Deans and Directors.
