RULES AND REGULATIONS

I.—Entrance Qualifications

Every student entering First Year must have successfully completed at least two years of the new Arts and Science curriculum of the University of Manitoba or an acceptable equivalent thereof. Such students will no longer be required to have studied a foreign language. It must be stressed that, although it is not compulsory, it is highly desirable that students obtain a prior degree before enrolling in Law.

Application forms may be obtained from either the Registrar's Office, University of Manitoba, or the Recorder's Office, Faculty of Law, and filed with the Registrar of the University of Manitoba on or before the 15th of June, 1969.

Under certain circumstances the Faculty of Law may admit certain applicants on a mature student basis. Candidates contemplating mature admission to the Faculty of Law can obtain the appropriate application form from the Registrar's Office, University of Manitoba, and they must file an application with the Registrar of the University of Manitoba on or before the 2nd of May, 1969, and should, prior to this date, obtain from the Dean or the Recorder of the Faculty of Law the general requirements for admission to the Faculty.

NOTE ALSO THAT EACH APPLICANT MUST WRITE THE LAW SCHOOL ADMISSION TEST AS A PREREQUISITE TO HIS OR HER APPLICATION BEING CONSIDERED. DETAILS OF THE DATES ON AND THE PLACES AT WHICH THE TEST MAY BE WRITTEN ARE OBTAINABLE FROM THE REGISTRAR'S OFFICE, UNIVERSITY OF MANITOBA. PLEASE BE ADVISED TO ACT IMMEDIATELY IN THIS REGARD.

It is pointed out that there is restricted enrolment in Law, so that applications for admission should regard the satisfying of the above entrance qualifications as meaning only that they are eligible for selection, and that such selection shall be solely within the discretion of the Faculty of Law.

II.—Registration

Every student must register, annually. Law School registration commences Thursday, August 28th, 1969 and closes Wednesday, September 3rd, 1969 at 12 o'clock noon. Students registering after September 3rd, 1969 must pay late registration fees. No registration will be permitted after September 27th, 1969, except in special cases. All students registered and in attendance in Law must pay, to the Recorder, an annual Students' Organization fee of \$31.00 at the time of registration.

III.—Attendance at Lectures

In every case where attendance at the lectures of the Faculty is compulsory, such attendance must be for at least eighty per cent. of the lectures given in each subject during the year.

Students who are absent from classes on account of illness must present a certificate from a physician, on the prescribed form, immediately on their return to classes.

Lectures at the Law School for the Session 1969-70 commence Tuesday, September 2, 1969 and close Friday, April 10, 1970.

IV.—Examinations

A grading system similar to that to be used in the Faculties of Arts and Science is employed. (See Letter Grade System).

Examinations are held once a year only, in each of the three years of the course. The regular yearly examinations for the Session 1969-70 commence Monday, April 13th, 1970.

No student shall be permitted to write any examination unless all fees required to be paid by him have been paid.

No student shall be permitted to continue the course of instruction in Law who has failed on two occasions to pass on the final yearly examinations in any year of the course.

In the first year of the course only those students who fail in not more than three subjects, and are not repeaters, will be allowed to apply for readmission to the Faculty to be considered by the Selection Committee along with new applicants.

V.—Fees, 1969-70

The following fees are required to be paid to the Comptroller:

Students are of course required to purchase their own text books and case-books and should budget a sum of between \$75.00 to \$100.00 per year in this regard.

Library

The Faculty of Law Library is intended to serve not only as the primary library for students attending the Faculty of Law, but also as the reference library for legal research in Manitoba.

The collection is comprised of textbooks, judicial reports, statutes, legal periodicals and related government publications from Canada, Britain, other Commonwealth countries and the U.S.A.

During the Session, library hours are from 8:30 a.m. to 11:00 p.m. Monday through Friday; 9:00 to 5:00 p.m. Saturday; and 1:00 to 5:00 Sunday. During the holidays, library hours are from 8:30 a.m. to 4:30 p.m. Monday to Friday.

CURRICULUM

Note:

- (1) In all cases where English text-books are referred to, the points of divergence between the English law and the corresponding Canadian law must be carefully observed.
- (2) The student will be required to have a knowledge of the subject rather than of any particular text-book on the subject, and is liable to examination accordingly.
- (3) In all cases where statutes are referred to, these are to be taken as including all amendments thereto.
- (4) All students follow a three-year programme leading to a Bachelor of Laws Degree of the University of Manitoba. A period or articles of clerkship will be served thereafter and a Bar Admission course taken by such of those students who desire to be admitted to the Law Society of Manitoba as Attorneys-at-Law and to be called to the Bar of the Province of Manitoba. All enquiries should be made to the Secretary or the Director of the Bar Admission Course of the Law Society of Manitoba, Law Courts, Winnipeg, concerning the rules relating to such admissions.

2. The marks given in each subject will be weighted according to the number of hours that the subject is taught. The **weighted grade point** for a course is the product of the hours of credit for that course and the grade point obtained by the student. The **hours of credit** for a course is a number associated with the course which indicates the course's relative weight.

3. A student will be required to pass his year before proceeding to the next year.

4. In order to pass his year a student will have to obtain a grade point average of 2 (Grade letter C), for all subjects taken, provided he obtains a grade point of at least 1 (Grade Letter D) in each individual subject.

5. Although supplemental examinations will not be set as has been done in the past, the Faculty will have a discretion, if the circumstances warrant it, to allow a student who fails to meet the requirements of section 4, to proceed to his next year (i.e. to be treated as if he has met the requirements of section 4) after a satisfactory written or viva voce examination, or in exceptional circumstances without further examination.

6. If a student fails to meet the requirements of section 4, and the Faculty discretion under section 5 is not exercised in his favour, he will still be eligible to apply to repeat his year, provided that in the case of a First or Second Year student he has not failed in more than three subjects in the year in question.

7. In the case of a First Year student wishing to take advantage of section 6, he will have to apply for admission in the same way as a new student wishing to take the course.

8. A student who has failed two years during his University courses will be classed as a permanent withdrawal and will not be considered for re-admission. (For this purpose a period of probation will be treated as a failed year. However, a student will only acquire one failed year in this way).

9. To qualify for honours a student must obtain a grade point average of at least 3.2.

First Year

45.110. Contracts. Three hours per week, both terms. A general introduction to the law of contracts.

45.111. Torts. Three hours per week, both terms. A general introduction to the law of torts.

45.114. Criminal Law and Procedure. Three hours per week one term, and two hours a week the other term. A general introduction to criminal law and procedure dealing with principles of criminal liability, common defences to criminal charges, selected specific offences and the basic procedures to be followed in the administration of criminal justice in Canada.

45.125. Legal Institutions. Three hours per week one term and two hours a week the other term. A general introduction to the study of law and to the historical development of the legal and judicial system, including the elements of procedure.

45.126. Property (Real and Personal). Three hours per week one term, and two hours a week the other term. The general principles of property law, real and personal, including a study of the Torrens system of land registration.

45.128. Legal Research and Writing. The purpose of the course is to acquaint the student with the range and relevance of legal research materials, to introduce him to the technique of discovering and applying these materials to the solution of legal problems, and to assist him in the development of the expressive skills demanded of the lawyer. Instruction is given by way of seminars and individual interviews. During the year students are required to complete a number of written assignments.

45.129. Agency. Rights and duties arising from the relationship of principal and agent, master and servant. Two hours per week, second term.

Second Year

All students of the Second Year must take the following subjects.

45.214. Evidence. Two hours a week one term, one hour a week the other. A study of the rules relating to the admissibility and weight of evidence in judicial proceedings.

45.222. Constitutional Law. Two hours a week. An examination of the legal problems arising from the nature of the Canadian political structure and, in particular, the distribution of legislative powers between the Federal Parliament and the Provincial Legislatures.

45.226. Wills & Trusts. Three hours a week. Disposition of property including intervivos transfers, such as revocable and irrevocable trusts or non-trust gifts, powers of appointment and wills; the settlement of life insurance proceeds and employee death benefits; introduction to and the development of the principles of equity; construction; future interests including class gifts and the Rule against Perpetuities; the law of wills, intestate succession; administration of estates.

45.228. Business Organization Law. Two hours a week. The structure and characteristics of the sole proprietorship, the partnership and the corporation; the promotion and structure of business organizations; authority and fiduciary obligations of management; shareholders' rights and remedies.

45.229. Mercantile Law. Three hours a week. A discussion of sale of goods, negotiable instruments, banking, and personal property transactions, and the related statutes, patents, trademarks, copyright.

45.230. Family Law. Two hours a week. A consideration of the nature of the marriage "contract", breach of promise to marry; void and voidable marriages, dissolution of marriage, separation by agreement and by judicial decree; provincial legislation regarding maintenance, general family provision; and the rights of spouses inter se and against third parties: custody.

Elective Courses

Each second year student must elect, subject to faculty approval, to take one of the following subjects. Students are required to make their selections and to notify the Recorder by April 1st preceding their next year's studies.

45.220. Insurance Law. Two hours a week one term. A general introduction to the principles of the law of insurance.

45.232. Litigation. Two hours a week one term. A specialized course in developing courtroom technique with a more detailed study of procedure.

45.233. Creditors Rights. Two hours a week one term. Remedies of the unsecured creditor, enforcement of judgments, fraudulent conveyances and preferences, general assignments and bankruptcy, Mechanic's Lien and Builders' and Workmen's legislation.

Third Year

For the 1969-70 Session only

All students of the third year must take the following subjects:

45.311. Taxation. Two hours per week, one term, one hour per week, other term. Introduction to the principles of taxation with reference to income, estate and gift taxes.

45.314. Jurisprudence. Two hours per week, one term, one hour per week, other term. Philosophy of law and general legal concepts.

45.315. Conflict of Laws. Two hours per week, both terms. The circumstances in which a Manitoba court will apply non-Manitoba law and recognize and enforce a non-Manitoba judgment.

45.318. Civil Procedure (Remedies). One hour per week, both terms. A study of motions and evidence thereon; attachments of debts; attachments of goods, interpleader; replevin; references, proceedings in the master's office; proceedings in chambers; and such other matters as may be prescribed by the lecturer.

45.320. Business Organization Law. Two hours per week, both terms. The structure and characteristics of the sole proprietorship, the partnership and the corporation; the promotion and organization of business corporations; authority and fiduciary obligation of management; shareholders' rights and remedies.

45.327. Legislation and Administrative Law. Two hours per week, both terms. A general study of the interpretation of statutes and the judicial review of the exercise of statutory authorities; and such other related matters as may be prescribed by the lecturer.

Elective Courses*

Each student must elect, subject to faculty approval, to take two of the following subjects. Students are required to make their selections and to notify the Recorder by April 1st preceding their final year studies.

45.308. International Law. Two hours per week, both terms. An introduction to the nature, sources and some of the fundamental concepts of International Law.

45.316. Labour Management Relations. Two hours per week, both terms. A survey of the development of trade unions; and of their present status, under both federal and provincial legislation, as regards the right of association, collective bargaining and the settlement of disputes.

45.321. Local Government Law. Two hours per week, both terms. A general course on municipal law including the nature, structure, function and power of the units of local government; validity of by-laws; land use control and planning; assessment and taxation; expropriation and compensation; and other related matters.

45.322. Criminology. Two hours per week, both terms. A study of the causes, treatment, and prevention of crime. Incidence and measurement of delinquency; the problem of causality; theories and purposes of the criminal law; police administration and criminal procedure; treatment of juvenile and adult offenders; prevention of crime; problems of civil liberties. Visits will be made to agencies and institutions.

45.323. Comparative Law. Two hours per week, both terms. An introduction to the Civil Law, its main substantive principles, court structure, distinctive judicial philosophy with special reference to the French Civil Code.

45.324. Transportation and Communication Law. Two hours per week, both terms. The study of the law applicable to the various methods of transportation and communication including a discussion of the various constitutional problems involved, the rights and liabilities of transportation authorities, and the procedure before the appropriate transportation Boards.

45.326. Insurance Law II. Two hours a week, both terms. A more detailed study of the different kinds of insurance contracts; analysis of the standard clauses found in fire, automobile, liability, health and accident, and life insurance agents and adjusters, waiver and estoppel, non-waiver agreements and other related matters, recent developments in the law of insurance.

Seminar-Assignment and Moot Court Programme

Seminars and Assignments—Selected problems, to be solved by the students and discussed in class.

Moot Courts—A Practice Court, involving research into selected problems and practice in some aspects of the conduct of trial and appeals. The courts will be conducted in groups, supervised by professors.

This programme will be compulsory for first and second year students, and elective for Third Year students.

DEGREE OF MASTER OF LAWS

The Faculty of Law offers a Master of Laws degree based primarily on research and thesis. A candidate, who may be required to audit specific courses in the Faculty of Law or any other Faculty, is expected to arrange his programme by agreement with the Faculties of Law and Graduate Studies.

THE LEGAL RESEARCH INSTITUTE OF THE UNIVERSITY OF MANITOBA

The Legal Research Institute of the University of Manitoba came into existence in the Spring of 1968, after a committee, which included members representing the Faculty of Law of the University of Manitoba, the Government of Manitoba and the Law Society of Manitoba, had considered the desirability and the practicability of such a body.

The Institute, which not only co-ordinates legal research projects initiated within the Faculty of Law, but also works on specific problems referred to it by public and private bodies outside the University, published its first research report on "Privacy and the Law" in October, 1968.

Each project started within the Institute is headed by a professor with the research assistance of senior students. At present a member of Faculty acts as honorary Director; a full-time appointment is envisaged for the future. It is further envisaged that candidates for the LL.M. degree may, where appropriate, work in close co-operation with the Institute.

Any enquiries relating to the work of the Institute should be directed to the Director.

C. L. ATKINSON Bequest. Bursaries varying in number and amount and totalling approximately \$1,500.00, to students in any of the University Faculties.

Viscount BENNETT Trust Fund Scholarship. Approximately \$1,000.00 for a graduate of any approved law school in Canada to pursue postgraduate study.

Frank BILLINKOFF Loan Fund. Available under certain circumstances to assist students in the pursuance of their studies.

BIRKS Family Foundation Award Plan. Payment by the Birks Family Foundation of tuition fees for sons or daughters of Birks' employees.

BOARD of Governors' Bursaries varying in number to students of superior academic ability entering or already enrolled in the University.

J. J. BOKOFSKY Memorial Prize. \$50.00 for the best creative original writing in prose or poetry by any undergraduate student in the University.

CANADA Law Book Company Prizes. Three prizes, each consisting of books to the value of \$50.00, one for highest standing in Torts, Domestic Relations and Taxation.

CANADA Permanent Trust Company Prize. \$100.00 for highest standing in a subject to be determined.

CANADIAN Federation of University Women's Fellowships to Women Graduates. Travelling Fellowship \$2,500.00, Junior Fellowship \$1,500.00, Professional Fellowship \$1,500.00, Margaret McWilliams Fellowship \$2,000.00. The Federation is also responsible for selecting Canadian women as candidates for a large number of Fellowships offered by the International Federation of University Women.

CARSWELL Company Prizes. Three prizes consisting of books to the value of \$30.00, one in each of first, second and third years, for highest aggregate in the final examinations of the year.

CARSWELL-Sweet Maxwell Law Scholarship. \$2,000.00 plus cost of travel to Great Britain and return, for postgraduate work in Anglo-Canadian Law. Open to all final-year and postgraduate law students in Canada.

J. A. CHERNIACK B.A., LL.B. Prize. \$50.00 to the student attaining the highest standing in Canadian Constitutional Law.

CHEVRON Standard Scholarship. \$500.00 for highest aggregate attained on the courses of the first two years taken consecutively on condition student is returning for third year.

The CHILDREN of War Dead Act provides fees and monthly allowances for children of veterans whose deaths were attributable to military service.

Charles Gray CHOWN Loan Fund. Maximum \$300.00 to undergraduates who have attended the University for at least one academic session.

COMINCO Diamond Jubilee Higher Education Awards. A varying number of Class I awards of \$500.00 and Class II awards of \$350.00 each, to children or wards of a Cominco employee or a Cominco pensioner, or his widow.

H. I. CORNE Prize. \$50.00 for highest standing in Contracts.

The Margaret Hypatia CRAWFORD Scholarship. \$250.00 for the highest standing in the third year, tenable only by a student who enrolls for the Bar Admission course of the Law Society of Manitoba next beginning after the date of the award.

DELTA DELTA DELTA Bursary. \$100.00 to a women student completing the second year of any University Faculty.

Anthony DRAPER Prize for the highest standing in Civil Procedure (Remedies).

FEDERATED Co-operatives Bursaries. Three bursaries, each of \$250.00 in any year of any Faculty.

FORT Garry Unit, Army, Navy and Air Force Veterans in Canada, Bursary. Two of \$200.00 each (renewable) for children and wards of members of Unit Number 60, tenable in any degree course in the University.

Aif FRANCIS Memorial Prizes. For third highest standing in third year Law.

GENERAL Motors Scholarship. One scholarship of \$1,000.00 (renewable) to an entering student in any degree course in the University.

GLOBELITE Batteries Limited Bursary. \$500.00 preferably to the son or daughter of a Globelite Batteries Limited employee entering the University.

GREATER Winnipeg Gas Company Bursary. One bursary of \$500.00 (renewable) to the son or daughter of a Greater Winnipeg Gas Company employee entering the University.

Solomon GREENBERG Prize. \$50.00 for the best student in the Moot Court Competition.

Gilbert GREGORY Memorial Prize. To the student with a grade point average of 3.0 and the highest standing in Property.

The Hon. Mr. Justice HUDSON Prize. \$100.00 for the highest standing in Jurisprudence.

Harley M. HUGHES, Q.C. Memorial Prize. \$50.00 for highest standing in Evidence.

IBM—Thomas J. Watson Memorial Bursaries. Varying numbers and amounts, totalling \$1,000.00 to needy undergraduates of any faculty or year who are of good academic standing.

INDEPENDENT Order of Foresters Court Atomic Bursary. One bursary of \$100.00 tenable in any degree course in the University.

INTERPROVINCIAL Pipe Line Company Bursaries, varying numbers and amounts, totalling \$1,500.00 to students who have completed at least one year in any of the University Faculties or Schools.

ISBISTER Entrance Scholarships. Twelve First Isbister Scholarships of \$155.00 and twelve Second Isbister Scholarships of \$105.00 will be offered in the Grade XII senior matriculation course.

ISBISTER Undergraduate Scholarships. Two of \$150.00 each offered for highest average standings irrespective of year (except the graduating year). Minimum average of 3.0 grade point average.

KHAKI University of Canada and Y.M.C.A. Memorial Bursaries, varying in number and value, preference to veterans or their sons or daughters.

LAW SOCIETY Prizes. \$200.00, \$175.00 and \$150.00, respectively, to the students attaining the second, third and fourth highest standings, with a grade point average of 3.0, at the final examination. These prizes are only tenable by students who enrol for the Bar Admission Course of the Law Society of Manitoba next beginning after the date of the award.

MANITOBA Alumni (Toronto Branch) Loan Fund. Loans up to \$300.00 may be made to students at the undergraduate or graduate level.
