# Valedictory

# Phillip Cramer

. . . Lawyers are supposed to strive for truth. Yet, much of what lawyers do is to try to downplay facts which are antithetical to their client's interest. They live to serve their clients and share their wealth of knowledge with those who request it, provided they are able to pay. Lawyers are sometimes parasites: they feed off the misfortunes of others by serving an adversarial system that does not right wrongs but fuels dissension and favours rich over poor. Lawyers manipulate blind justice to serve the ends of the rich and the ends of evil.

Lawyers, like all other humans, are capable of good and evil. Although they generally produce nothing of value, merely writ, dicta and obscure minutiae, lawyers sometimes do the right

thing. However, notwithstanding all the profession's claims of altruism, all that rot about a noble profession and a glorious tradition, when lawyers advance good over evil, they do so by adhering to humanistic values and neglecting institutional legal values.

The only people fooled by the legal profession's claims of nobility and wisdom are lawyers. Real people don't believe that line of nonsense. I am not saying that lawyers are bad people and I am not saying that they are anti-human. In fact, they are human, all too human. As normal human beings, of no particular distinction, they are capable of both great generosity and petty spitefulness. They are capable of both divine vision and earth-bound greed.

I enjoin you not to adopt legalistic values. Legalistic values are shallow and are based on the absurd notion that human ills can be solved by manipulation of neutral principles and abstract rule-sanctions. Legalistic values are organized into a set of canons which I call the religion of law. The religion of law says that those in authority merit their exalted rank. The religion of law enjoins its adherents to bend their knees in displays of supine fealty in the temple of the law, before the altar of the statute book and precedent.

I say that people only deserve respect when they earn it. Fools and knaves never deserve respect, whether they are senior partners in prestigious law firms, jurists, or even ensconced beyond the impact of all reality in the Arcadian realm fulsomely referred to as "academia".

Don't get me wrong, there are good lawyers, wise judges and noble academics, but their nobility is a function of their humanity: it has nothing to do with their legal training or adherence to the religion of law. I would say most judges are relatively competent, but that is because they fall within the normal curve of human virtue and intelligence.

A few weeks ago, I read in *The Globe and Mail* a story about a black woman who defied the odds and graduated as a lawyer and got a job with a top Toronto law firm. She was quoted as saying that she was initially interested in criminal law but now says she doesn't have the stomach to represent criminals.

Why does she think her prospective commercial and industrial clients are better? I fail to see how Union Carbide, the asbestos industry, or the land development industry are any more palatable than criminal clients. The big boys hurt more people, more effectively, over a greater timespan, but at least they give to the arts: when was the last time a mugger sponsored PBS's "Great Performances"?

If you think that there is something inherently laudable about representing the powerful and shutting out the weak, about funnelling money to avaricious politicians who champion the interests of the development community at the expense of community welfare, I can only say, to quote our droll, but absent, colleague, Den Valdron, "Congratulations!"

The consequence of development projects is often destructive to the lives of those who eke out a meagre existence in the city's central core. Developers create suburbs. They ignore the inner city. As the suburbs expand with each peripheral housing development, the inner city decays further. The result is a weakened inner city tax base, reduced political power for inner city residents and sub-standard inner city housing, services and schools.

One result of developer greed is that many American inner city children are, for all intents and purposes, illiterate. Jonathon Kozol wrote about his experiences in the schools of a major American city. I read his Death at an Early Age about fifteen years ago, but it has stayed with me. My contempt for the politicians that Kozol described and the system that they perpetuated and the lawyers who served them was probably largely shaped by that book. I will remember that book long after I have forgotten the largely irrelevant curriculum we have endured in law school — you know what I am talking about, chimney sweeps and brooches, domesticated camel bites, the rule against perpetuities, the importance of precedent and the sanctity of the courts.

The point is that lawyers are the servants of the developers. The fruit of developers' efforts is the destruction of the city and the impoverishment of the people. If that is your cup of tea, you are going to find it bitter brew.

I suppose lawyers are sometimes on the side of the angels. But not very often. I wouldn't have any complaints with the legal profession if for every lawyer who represents developers there was one who helped residents of neighbourhoods. But the ratio is lop-sided. I would like to remind you that on every front, society is headed for disaster. One out of every six Canadian children today lives in poverty. Their ranks will spawn tomorrow's criminals. Their parents lead quiet lives of desperation and their children will lead lives of desperation — but maybe not so quietly. But we are not just screwing the poor. We are also destroying the environment, poisoning our workers, and obliterating our children's inheritance.


So get your VCRs and BMWs. Buy your fancy Tuxedo homes. Take your vacations in Europe. Aspire to lofty positions in the Bar Association and on the Bench, but remember your wealth will taste of dust once we have exhausted our human and natural resources.

I direct your attention to the world beyond our borders. I direct your attention to Africa. I direct your attention to Central America. I direct your attention to the Middle East. I remind you of Michael Harrington's charge that Western wealth is largely dependent on Third World squalor. We exploit our

people, but it is nothing compared to what we do to the people of the Third World. One day, the people of the Third World are going to tell us we can't steal their natural resources and feed off their labour. What will happen when they say 'enough'? I'll tell you. We will suffer a terrible crash. Your big house won't mean much then. We won't have the energy to heat it. We won't have the food to feed your children.

In conclusion, I enjoin you to admire the courageous and not the rich. I enjoin you to award your respect to the meritorious and not the privileged. I enjoin you to refuse to do dirty work for powerful clients. I enjoin you to look to the long run. I enjoin you to make personal sacrifice. I enjoin you to look out for those who are least able to look out for themselves.

You have a choice. You can buck the system — provided enough of you share a vision of social justice. You can take a leap of faith and transcend the institutional value system favoured by the guardians of the legal tradition. Or, you can adopt the sanctimonious, self-righteous, self-congratulatory attitude of the legal profession, ignore social inequity and descend into hell. The choice is yours, but the consequences will be shared by all.

































# Yearbook Committee Editor's Message
