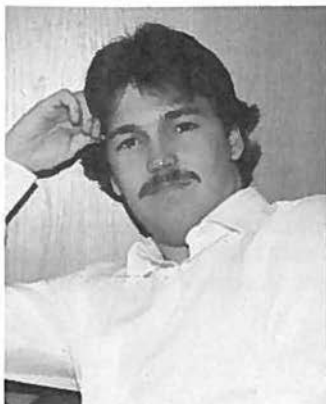

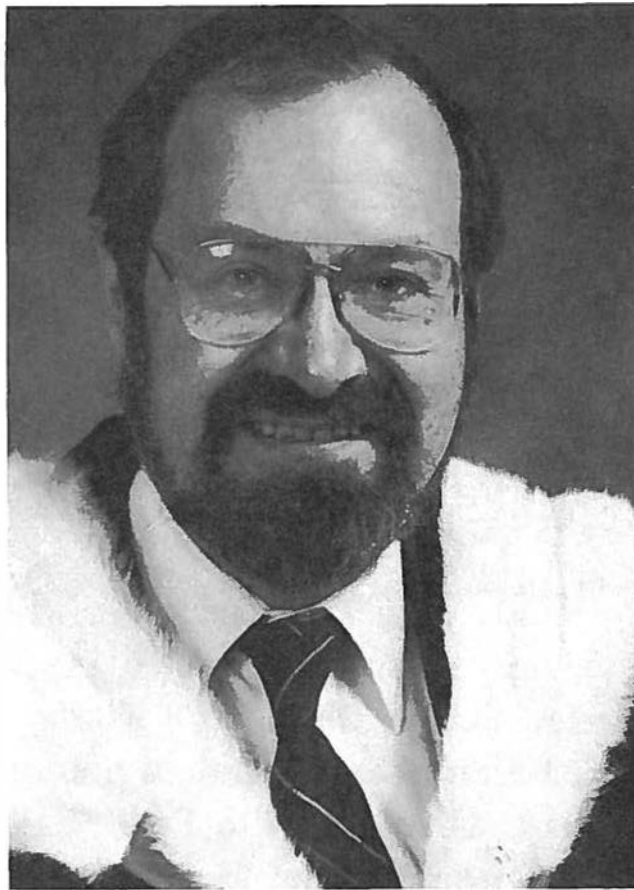

Dean's Message

These past few years in which you have earned your degrees have passed swiftly. It seems but only yesterday that we were welcoming you to Robson Hall and to the study of law.

Even since then, the range and complexity of the law has increased and legal issues and resort to legal processes have become still more prominent in modern life. Every day more seems to be expected of the law and legal institutions; perhaps, indeed, too much, for they cannot be the unique and universal solvent of every problem in human relations.

All this reinforces what we told you in your first days here and what your own study and experience will have confirmed. A law school does not exist to cram into its students' minds some fixed and known commodity called "the law", as petrol is dispensed from a pump into a tank. It may — if students are receptive and responsible, as you have been — achieve something rather different and of greater and more lasting value. It may help students to develop their own capacities, understanding and values. You leave us, I think, with some framework for critical appreciation of the legal order, some disposition to take part in its improvement, some sense of professional tradition and obligations and a reasoned basis for commitment to the highest standards and ideals of service in the public profession of the law, and with a sturdy foundation in learning and skill — and, I hope, in intent — for the never-ending process of self-education and personal development that will be required (and, happily, is allowed and fostered) in a life in the law.

As you prepare to graduate and I to leave the office of dean, I look back appreciatively on our time together. These have not always been easy years for the School. You will have noticed at times the stresses on our programme and on the Library of serious financial constraints. Nonetheless, in sometimes discouraging circumstances, our able and committed faculty have continued to strengthen and develop the Faculty of Law in every aspect. At the same time, we have kept the distinctive quality of Robson Hall as a close and cooperative community. We value your contribution to these achievements and expect you will play a like part, as builders and leaders, in the larger professional and other communities in which you will serve.

Convocation is a time to bid farewell, but not to say goodbye. We look forward to a continuing close association with you, wherever your work and interests may take you. We hope you will keep in touch and come back often to visit. For now, from all of us at Robson Hall, congratulations and best wishes.

Grad Social



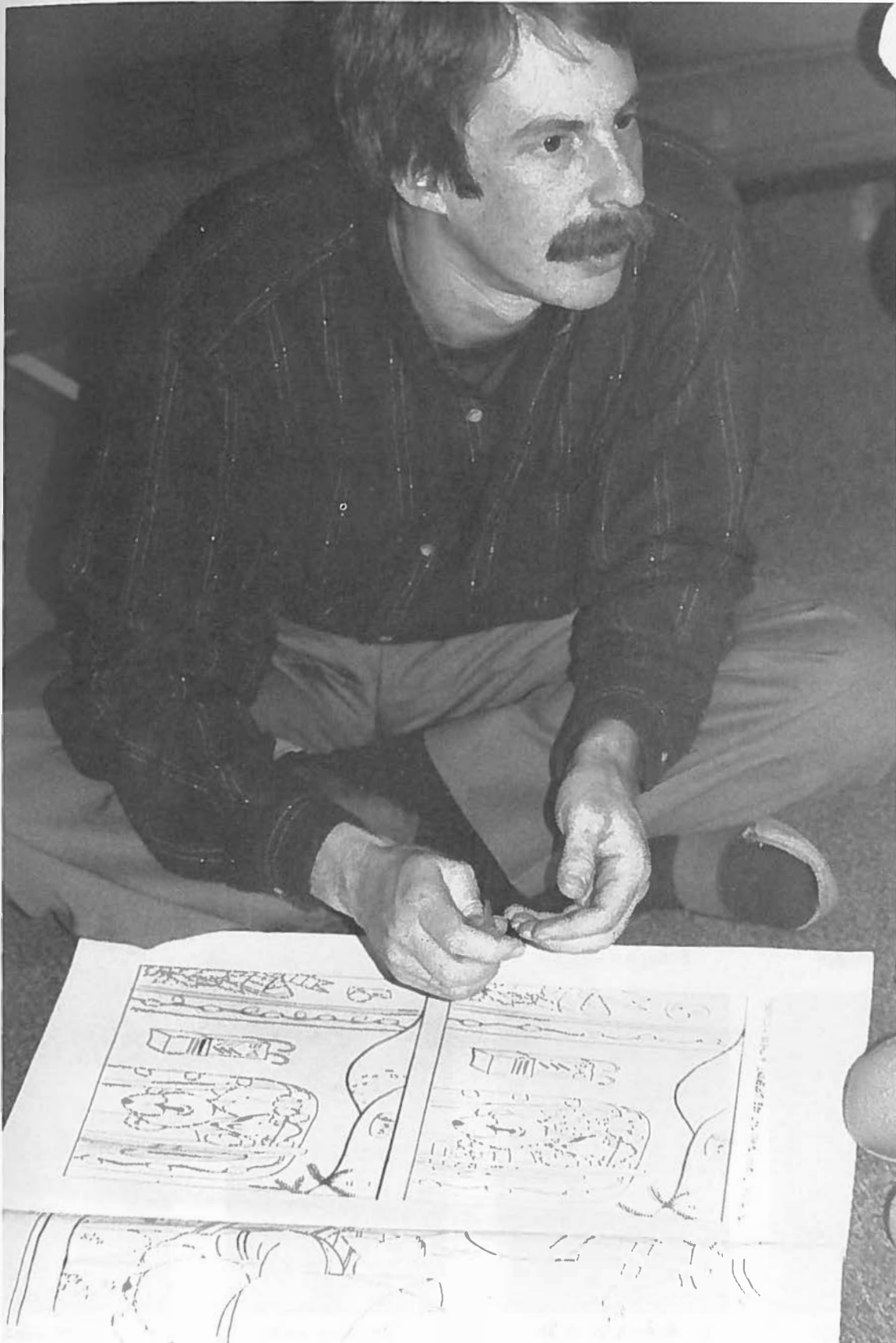

First Week Social

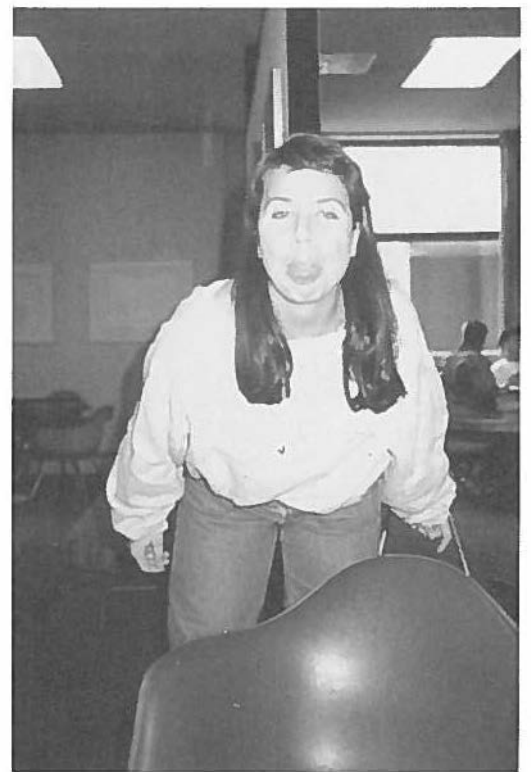

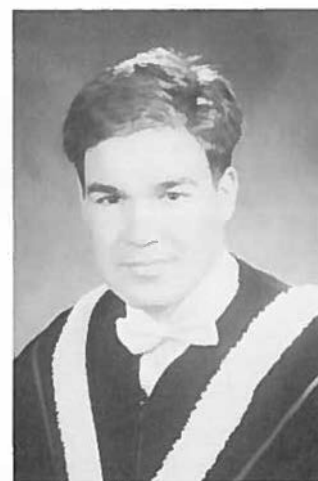
Arthur Chapman — Arthur, Arthur, Arthur!!!

Distinguished guests, members of the Faculty, fellow classmates, ladies and gentlemen;

I plan on keeping my remarks as brief as possible. I am reminded of an old saying that you may have heard; "A speech on an occasion like this should be similar to a ladies dress: long enough to cover the important parts but short enough to be interesting."

I've tried to keep the 'inside' humour to a minimum, there will inevitably be times when you will have no idea of what I'm talking about. Don't feel bad though, as I've felt that way for the last three years and I was in the law school.

As I was preparing this speech, I was thinking back to the first month of our law school careers, back to when Prof. Edwards was trying to explain that the medieval Trial by Ordeal, with the process of "Pain; Strong and Hard", had been abolished many centuries ago. Well, after the last three years of law school, I must differ with Prof. Edwards. This has been a long grind.

Could you imagine getting up every morning to go to work knowing full well that you had to face us and some of our questions? That alone makes you appreciate their task.

Also, practicing lawyers who came out to the law school to help us deserve our thanks. It means a lot to us students to get a look at the practical parts of this profession — we need all the help we can get.

Further deserving our thanks are those students who gave their time on the various committees and in organizing all the activities that enriched our time spent at Robson Hall. Many were thankless tasks but they should not go unnoticed.

While I'm at it, I should also include all of our spouses, spousal equivalents, friends and families who had to put up with our crankiness during those times when we were bogged down at school. Their understanding deserves appreciation as well.
