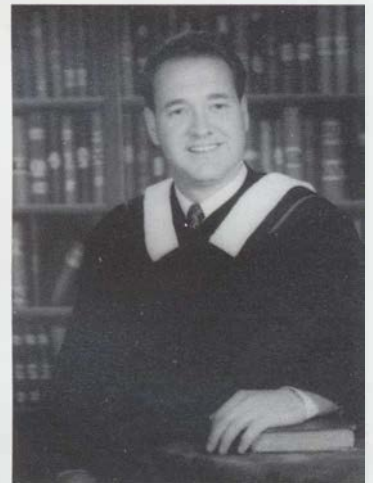
The past three years have meant a lot to each and every one of our graduates. Exams were written, romances flourished but most importantly, friendships were formed.

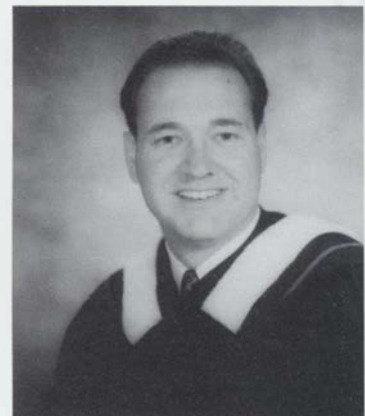
David Badilotti

Brad Blisner

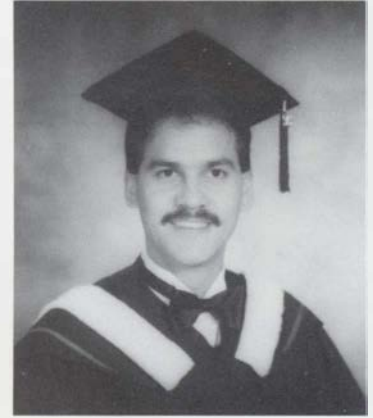

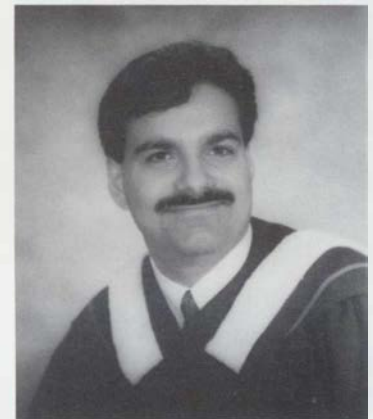
Sharon Cartmill

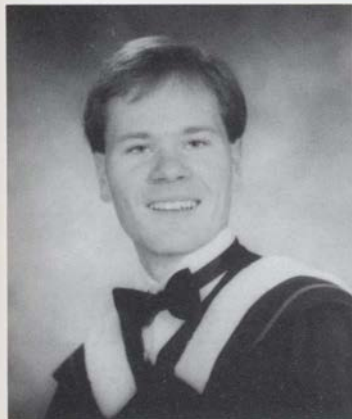
Paul Claire

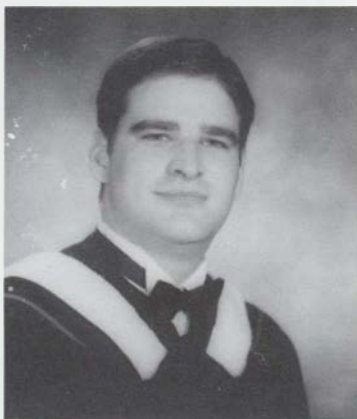


Susanne Dandenault

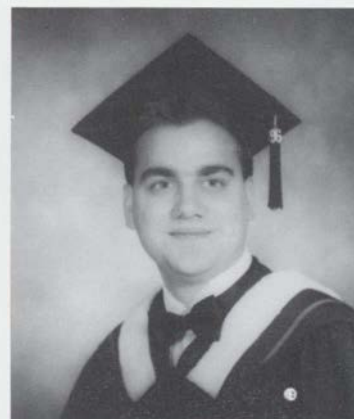


Patrick Easton

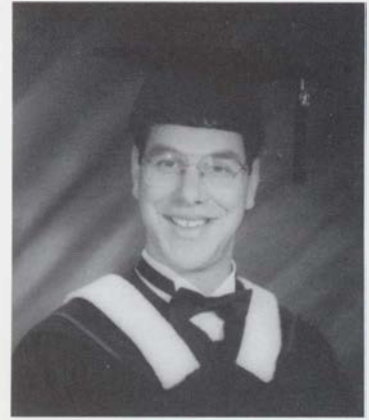
Scott Elson

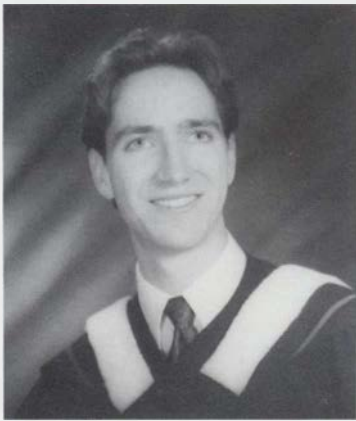

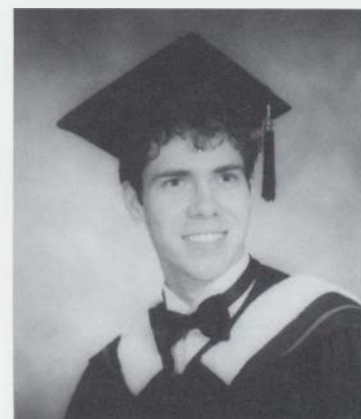


Simon Helm

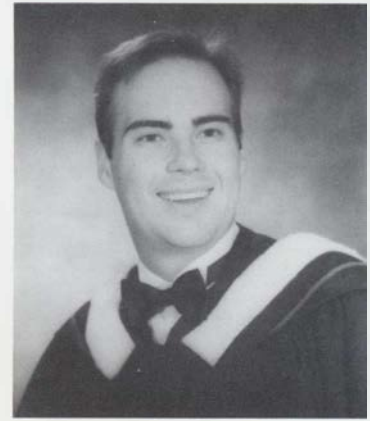
Scott Homenick

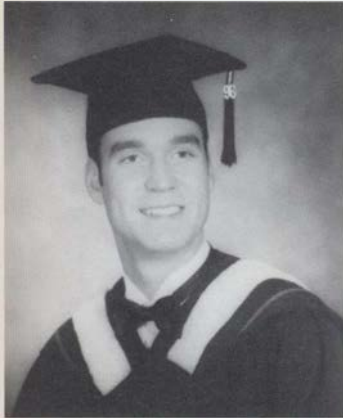
Brad Janzen

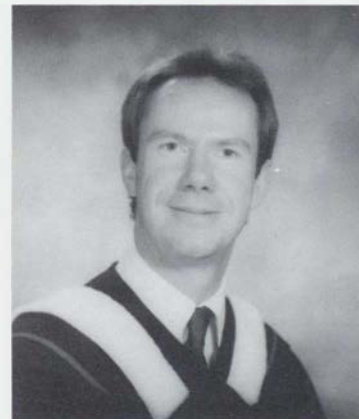


Mark LaClare

Second only to D.S. - Mark is known for his amazingly immaculate handwriting that never deteriorated - how do you do it Mark?!? Good luck Mark!

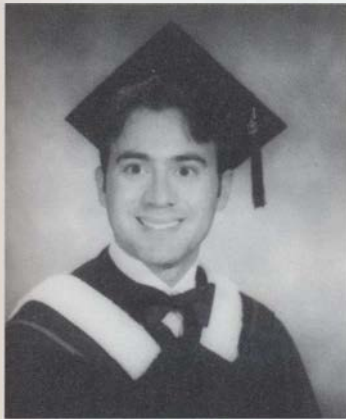
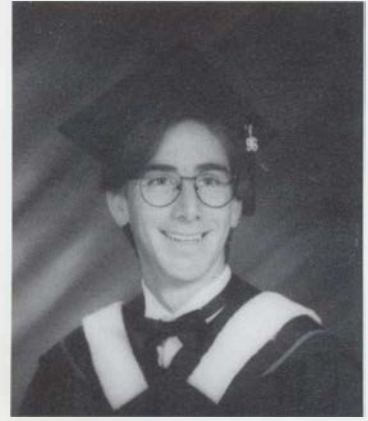
Alan Ladyka

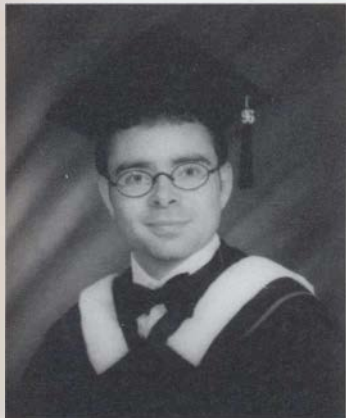
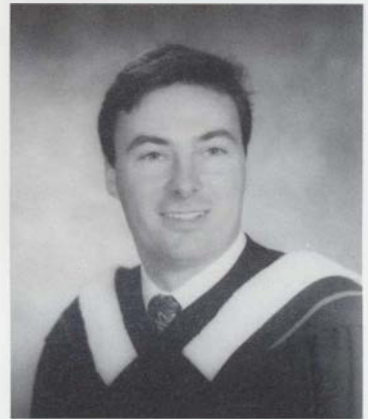


Steven London

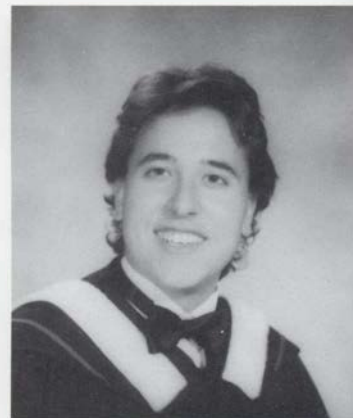


Dave Mann

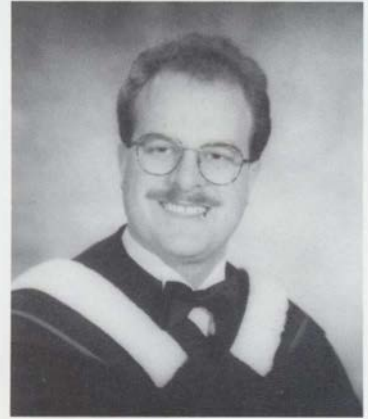

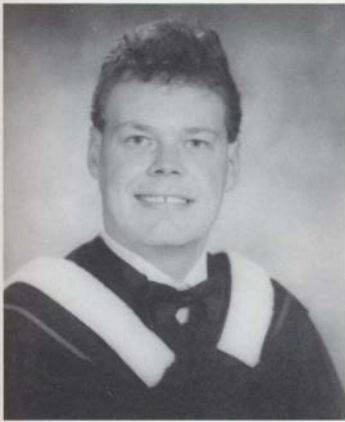
Mark Mercier

Scott Paler

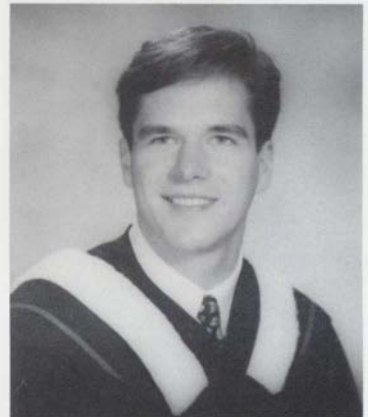

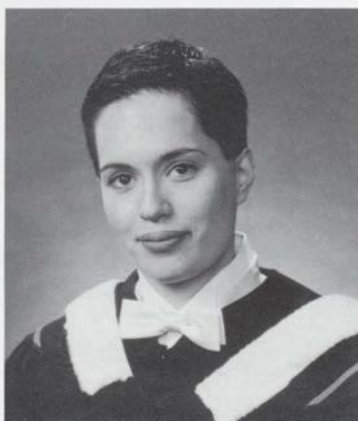


Beth Asher

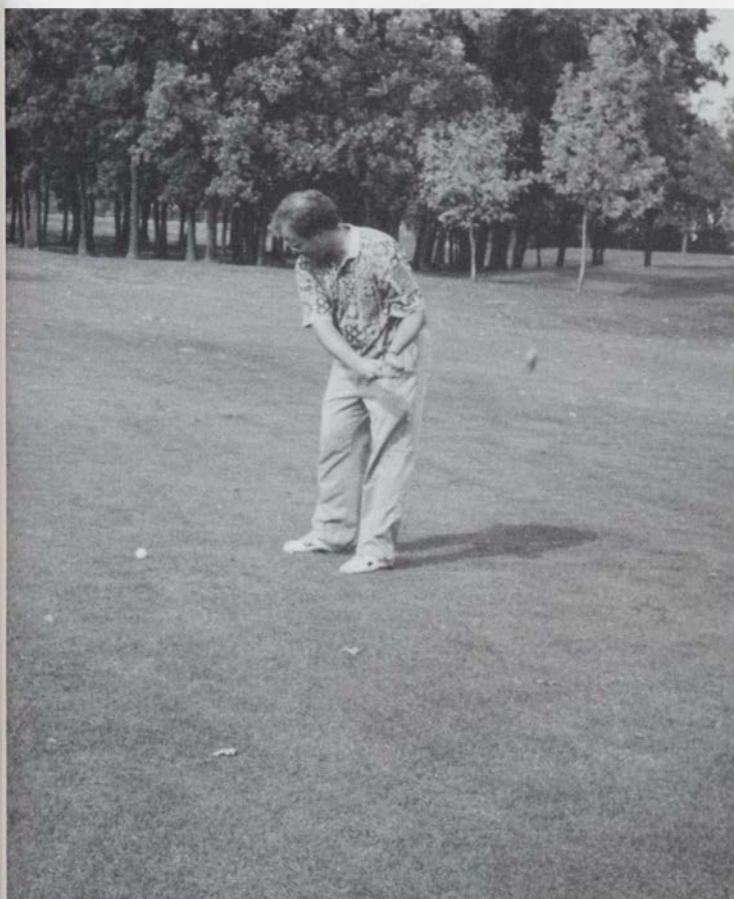
