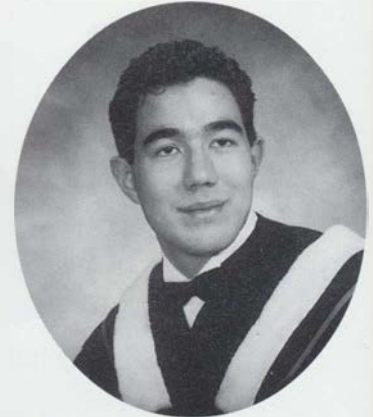


David Ardern

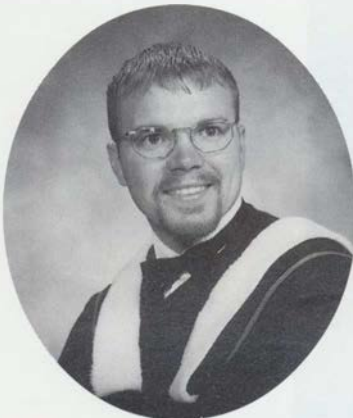
Darren Baccus

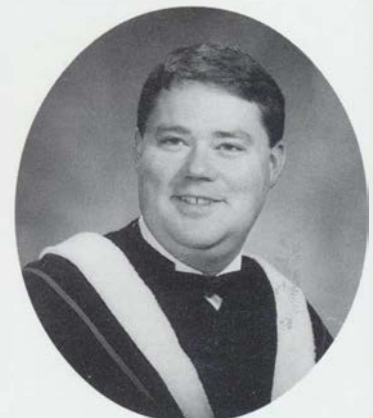

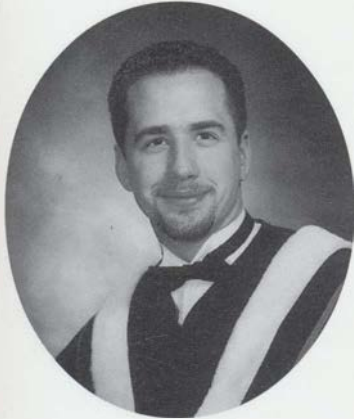
Gay Benns

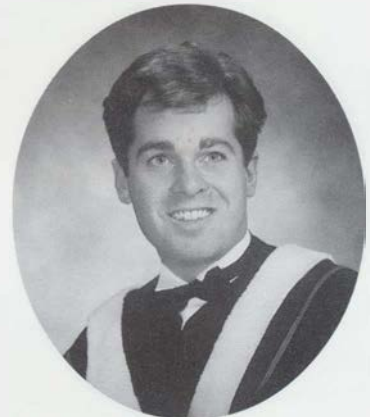
John-Paul Bogden

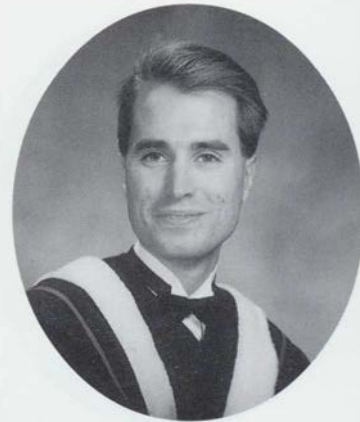


Kristi Burns

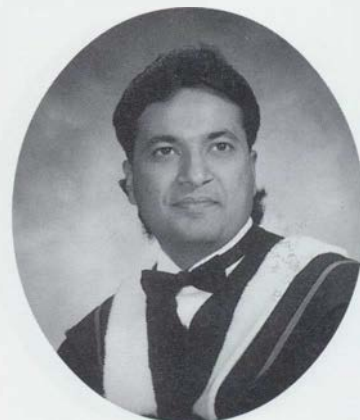


Connie Chartrand

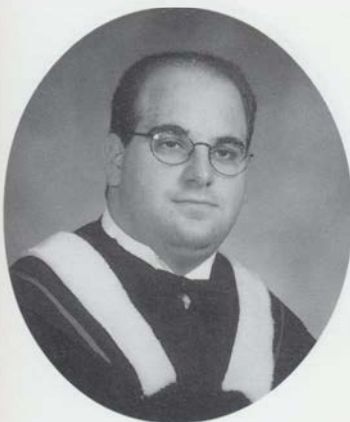
Amanda Chester

Kara Crawford

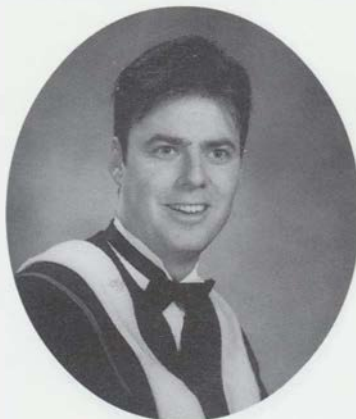

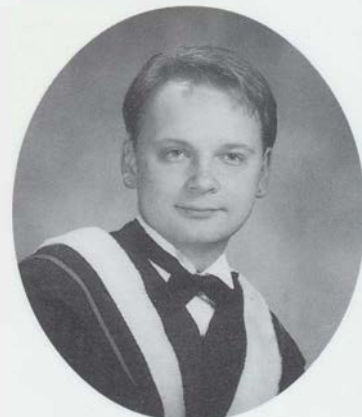
Arish Khoorshed

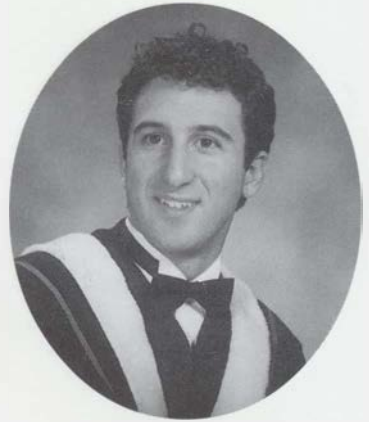

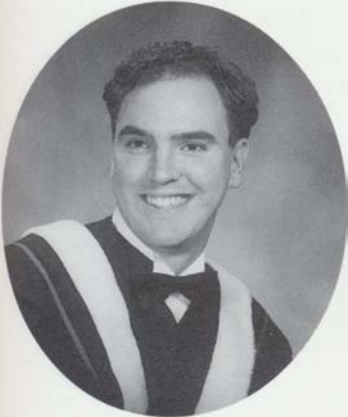
Matthew Klug

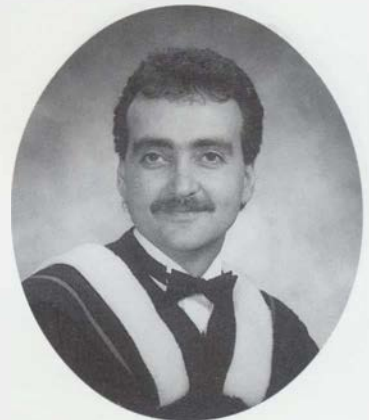
Jean Millar Usiskin

DISCO THE NIGHT AWAY!

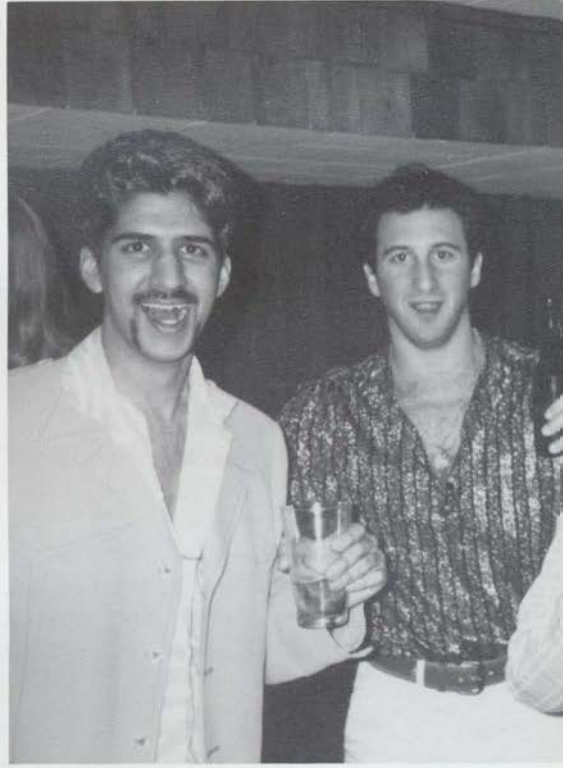

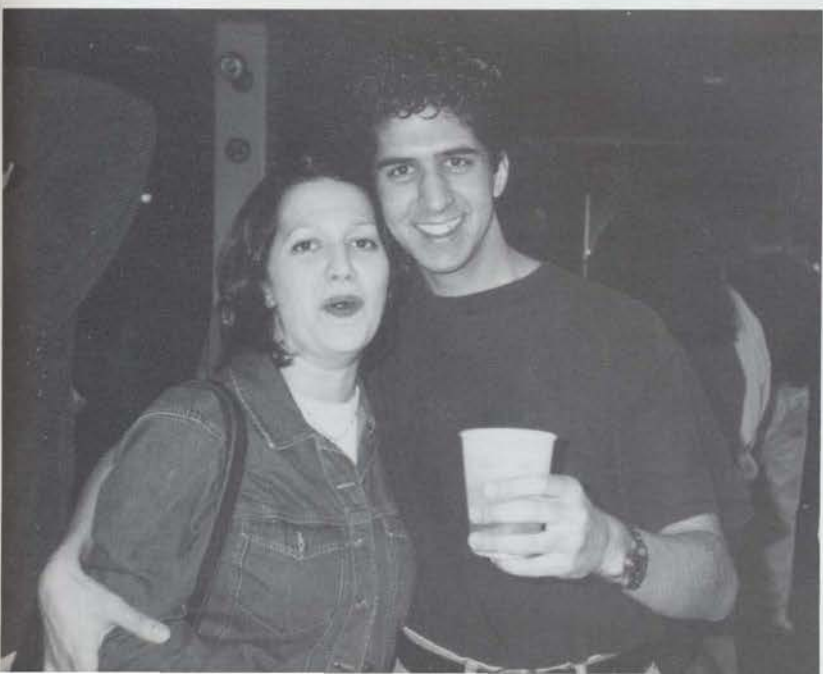
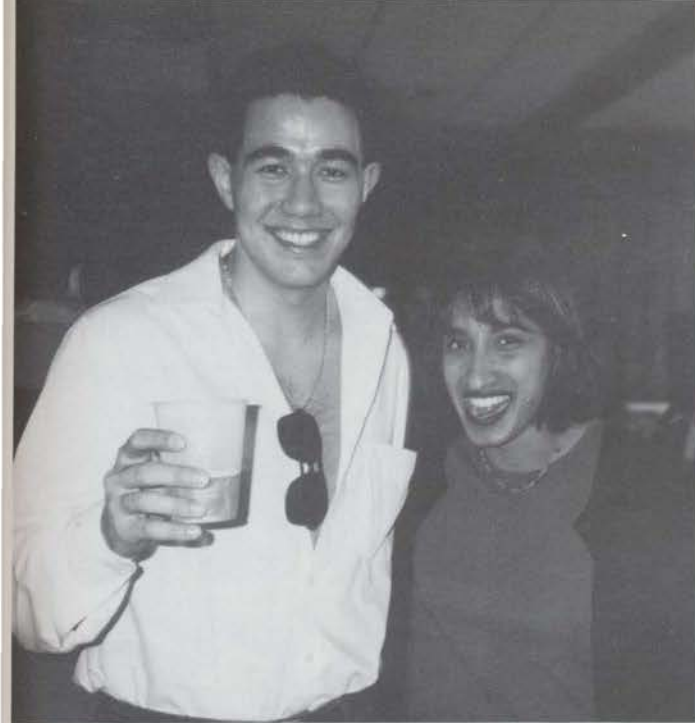

LEVENE v. ROBSON HALL

Manitoba Moot Court, Lipsett J. Judgment - November 7, 1996

Negligence - Duty of Care - Vicarious Liability - Contributory Negligence - Duty of law School to cover hole in Moot Court room - Duty of law student to watch where the hell he is going - Negligence Found - Contributory Negligence Found.

The plaintiff, Adam Levene, a law student at the defendant institution, fell into a hole in one of the defendant's classrooms. The plaintiff claimed damages in the quantum of \$1 million Cdn. for grievous physical and mental damages arising from the law school's negligence to cover a deep crevasse at the *locus in quo*. Alternatively, the plaintiff pleaded that the doctrine of vicarious liability between student and institution was applicable. As a result of the fall, the plaintiff's left leg and ankle were severely strained and the plaintiff's condition additionally, "cramped (his) Mondetta style." A Ms. Marla Singer testified as a witness for the plaintiff. **Held** - For the plaintiff in part; defendant negligent, plaintiff one half contributorily negligent.

Mr. Braid, Dean of the law school and chief defense counsel denied any negligence on the defendant's part, asserting that the "gap" in question was merely a natural feature of the Robson Hall landscape and was something of which all reasonable persons were aware. In the alternative, the defense pleaded that the plaintiff was contributorily negligent in his heedless ambulence. The defendant also denied the applicability of the doctrine of *respondent superior* as it did not apply to the situation at bar. Additionally, co-counsel for the defendant, Mr. Steusser,

asked the court to extend the evidentiary principle of spousal competency to exclude the testimony of Ms. Singer.

First noting that Mr. Levene was certainly renowned in the common law realm for his treatise, *Levene on Torts* (1st Ed., 1996), Lipsett J. accepted the plaintiff's claim in part. The learned judge also mentioned that the tome was excellent for boosting up small children at the dinner table. While on the subject of colossal legal texts, Lipsett J. declined to accept Mr. Stuesser's argument on the inadmissibility of Ms. Singer's testimony, remarking "they ain't married yet." Continuing, the court found that the defendant law school did have a duty to cover the 2.5 m. deep hole and had consequently failed in said duty. The defendant's resultant negligence created the hazard to which the hapless Mr. Levene ultimately succumbed.

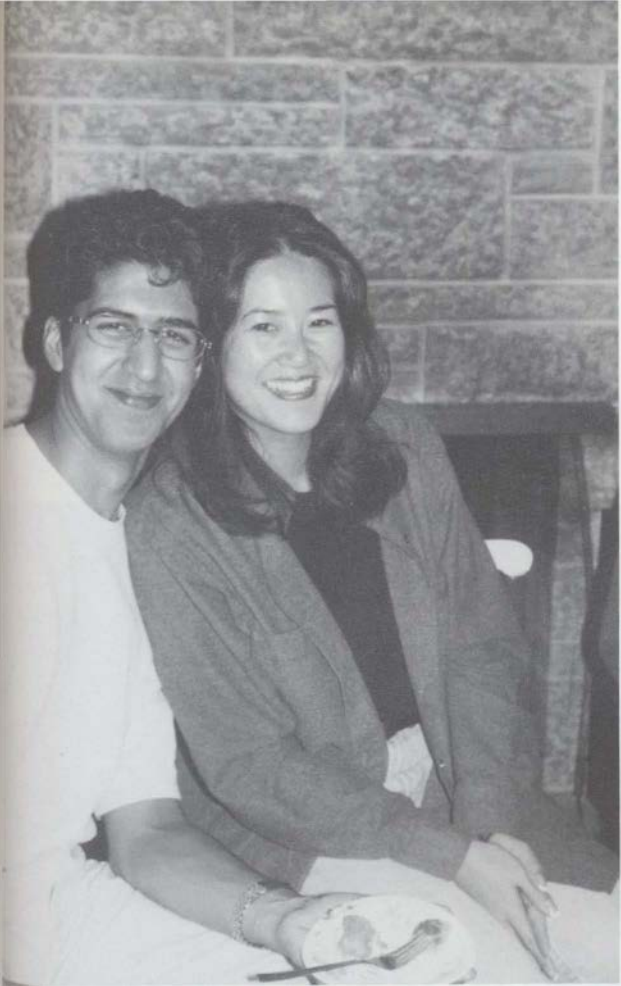
However, Lipsett J. equally concluded that the plaintiff's foolish inadvertence made him contributorily negligent to the degree of 50 percent. The learned judge aptly made his point by quoting Denning M.R. in the *locus classicus* of cases involving law students falling down holes at law schools; *Anderson v. Cambridge* (1945), All Loopy R. (C.A.), where the eminent jurist stated "What kind of silly arse falls down a hole?" Curiously, Lipsett J. also applied the ancient maxim *qui molitur insidias in parriam id quod insanus nauta perforans navem in qua vehitur* in his decision.

In his determination of damages, the learned judge acknowledged the defen-

dant counsel's impassioned plea that Robson Hall was hopelessly impecunious and would be unable to pay its Faculty this semester, let alone the damages claimed. In consideration of this most unfortunate reality, Lipsett J. applied the equitable remedy of restitution, awarding Mr. Levene guaranteed straight A's for the rest of his academic career and free lifetime "L" lot parking passes.

Peels - A light beer curlers smuggle in from the States.

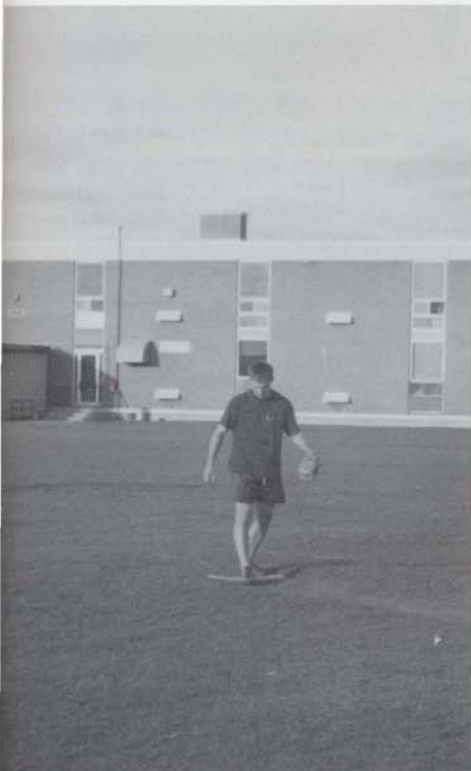
