


DEAN'S MESSAGE

Writing this message on a beautiful summer day at the end of July, in the quiet precincts of Robson Hall, it is hard to visualize the feverish activity which usually marks this Faculty and which will be upon us again in little more than a month's time. However, having just completed the unenviable task of chairing a committee which had to select 125 new students for this Faculty out of a record application list of nearly 500, I am very conscious that this year will see our new building (occupied only $2-\frac{1}{2}$ years ago) a hive of activity, filled to capacity with both students and faculty. One feature of this which I am sure will delight the hearts of all the male students (and perhaps some of the male faculty!) is the influx of nearly 30 ladies into First Year.

As I have watched this increasing demand over the last few years for a legal education I have perceived on the part of a great number of our students the feeling that now and in the immediate future "law is where the action is". 
DOUGLAS NICHOL ABRA


RICHARD HENRY ADAMS

JOSEPH DAVID BARNSLEY






BARRY GORDON BERGH


ARNOLD BRUCE DETTMAN






JOHN DAVID GEORGE


BRIAN DALE GIESBRECHT



IRVIN GOLDMAN




ERRICK G. HARRISON






HOWARD CONAN LAWRENCE

EDWARD H. LIPSETT






ALEXANDER J. MACIVER




ROBERT H. MAXWELL



DONALD MURRAY MCCARTNEY



RICHARD DANIEL MCCLELLAND








MOOT COURT COMPETITION

Among the purposes of this "Festival" were the examination of certain social problems and public issues from an interdisciplinary approach; and the creation of awareness in the University and general community of how each faculty sees its own role in relation to the interests of society.
