# CHRISTMAS EXAMS

The DEFERRAL SEASON is nearly upon us. Those planning on deferrals this Xmas should begin preparation now so we can avoid some of the past confusion we've had in this area. Those in first year should be particularly interested in the following suggestions. THE T.B. COUGH: If possible develop a hacking T.B. cough. This should run for several weeks and be utilized several times in each class. Don't worry about disrupting classes. Your fellow students know the procedure and are all for you. If you are using the T.B. cough, it is a good idea to simulate some blood dripping from your mouth in the morning. Water down some catsup. It's very














### VALEDICTORY ADDRESS

Well, we finally made it. Fellow graduates and Honoured Guests, We made it! Tonight in this massive and huge hall that pays judicious tribute to the achievements of the past and the aspirations for the future, we here tonight mark a death and a birth, an end and a beginning - we have, as it were, finished one book and have gone on to another, finished the soup and gone on to the main course, got off the freeway and onto the byeway, left Mary Jane for Johnnie Walker, in short, got off the ladder of higher learning and alighted on to the bow of that great ship of life sailing on the turbulent ocean of chance.

By now, some of you may be wondering how I became the benefactor of this year's valedictory honours. There were two criteria which had to be fulfilled; clean-cut ivy league good looks, and with Garth Steek out of town, I was a natural; but more importantly, Jack London insisted that he be taller than the valedictorian, and I was the only choice. The only problem was that I didn't want to attend any graduation that wanted me as a speaker. It offended my sense of good taste. However, I should inform you, that due to an overwhelming response, I will be giving this speech again at this year's Supplemental Grad's Farewell; I understand that to restrict numbers, a note signed by your mother is required. Which conveniently gets me on the topic of mothers, which is the reason many of us are in law school anyway, this speech is being taped for my mother's benefit, and even if you don't like me think of her feelings; she still considers me a punishment from God.

In listening to the eloquent remarks of our Chief Justice, I am reminded that his eloquence finds literary expression in many of his written judgments. In the case of LEVIN v. AC-TIVE BUILDERS, a landlord and tenant case, the Chief Justice critically examined the legal issues involved and relying on Canadian and British jurisprudence, began his judgment by noting that, "This case concerns mice. They made their appearance - in what numbers of course, could not be established - in the suite of the plaintiff." Perhaps the judicial implications of such dicta is better left unsaid, but I understand that it is forming the cornerstone of an article by Cam Harvey on the Manitoba Court of Appeal, entitled "Blind Mice - See How They Run" or "The Role of the Fairy Tale in the Judicial Process."

To the Dean, I would like again to say hello. I can recall that when the Dean would lament, as he was often fond of doing, "There's nothing new under the sun", he had never

experienced a class like ours before. His unfailing objectivity, his untiring devotion of fair play rivals that of Lord MacNaughten, in LLOYD v. GRACE SMITH, where the learned Law Lord was faced with the liability of a principal for the fraud of his agent, and began his judgment thusly; "My Lords, in the office of Grace, Smith and Co., a firm of solicitors in Liverpool, of long standing and good repute, the appellant, Emily Lloyd, a widow woman in humble circumstances, was ROBBED of her property." There's nothing like a good smattering of English justice to set things right. I understand that Paul Thomas is leaving for Dalhousie which only goes to show you that our loss is no one's gain, is no one's gain, is no one's gain.

I have just learned that the Standard Desk Company is coming out with a new model - the Jerry Nemiroff desk. It has short legs and rough Italian features. For a small fee Paul Stunt will deliver to you and talk dirty to it for five minutes. Rumour has it that next year Butch Nepon and Birdie Bass will be giving a course entitled "Topics in Legal Humour". The first class will consist of Joe E. 
butter for the purpose.



But this is not meant as a lament of the past or a sermon for the future. When it comes right down to it, it was a good three years. Each of us has made a friend or two; each of us have learned a little about law, probably a little more about life. But, in a way, we've been forced to co-habitate. To make the best out of, what at times appeared to be an unbearable situation. I know I owe a lot to a great many people, as I am sure we all do. So in concluding, my hope for us all is good cheer, good fortune and long life never forgetting, of course, of that old equitable doctrine, wash

your hands before you step to the bar.



or sad - each according to his nature.



## MARVIN BRAUN






### TIMOTHY BUZZA

### MURRAY HOWELL




### **ELDON IVERSON**




### BRIAN KELSH


### MARTIN KOVNATS

### PAUL LASKO



### HENRY LEW




### TERENCE MacKEAN





### GLENN McFETRIDGE



### GAIL MILDREN





### THEODORE THOMAS MUDRY




### DANIEL NOWASAD


### FRANK PALMER



### ARNOLD PELTZ






### NORMAN PROMISLOW





### IOHN SCURFIELD




### LARRY SELBY


### LAURIE SHAPIRO


### RICHARD WILSON







### KENNETH ZAIFMAN
