Dean's Message



The Class of 1986 will be long and agreeably remembered at Robson Hall. You worked hard but also had a special sense of fun, a notable esprit de corps, and an awareness of issues and events beyond the immediate bounds of timetable and curriculum. In your time, the traditional activities of the School have flourished and there have been new ventures (such as the — occasionally melodious! — Glee Club) left as legacies to following Years. It may confidently be expected, not only that you will do well in the practice of the profession of law or whatever careers you may later follow, but that we shall find you active in a wide range of professional and public good works.

Beyond that, it may be hazardous in these changing and uncertain times to venture predictions. However, I would dare three forecasts. One is that the law and its institutions and processes will become even more prominent in the lives of our community and citizens, even though perhaps even now we expect too much from them and too little from other guides to good conduct and relations. However, the law's potential for good will not be realized, and its capacity to do harm may appear, if those of us engaged in the law in all our various capacities do not constantly strive to make the law rational and clear, to keep legal processes accessible and affordable to all when needed, and to encourage in the existing system and by new measures, expeditious and acceptable settlement of contentions.

The second is that lawyers will fall into grave disfavour and difficulty if we do not keep alive and bright, as a beacon and goal for ourselves and as a visible assurance to the public, the ideal of a profession committed to public service and the highest standard of ethical conduct. There seems to me to be a world of difference between the unfortunately common statement that law is a business and saying that law is a profession that ought to be conducted in a well-organized and unwasteful fashion in the clients' interest.


My third note is that you will find very soon that your education is now but just commenced and must continue to be augmented and enriched forever after; and that in the world of your future, there will be little so important to you and the law as effective legal research and teaching. The law schools, whose mandate these are, will increasingly be seen to be not something apart, at the threshold or periphery of the profession and the legal system, but as standing at their very core as regenerating sources of energy and light. That may sound pretentious or overvaulting, but I state it only as a prediction, not a self-aggrandizing claim. We are intimidated, as well as excited, by this challenge to our responsibilities and capacity; but we know that in our work we shall have, in you, an understanding and supportive constituency, indeed, colleagues engaged with us as partners in a great enterprise.

And so, now, we do not so much say to you 'Farewell' as 'Welcome' — welcome to a new and lasting relationship in which we may work cordially and closely together on these important matters.




Sheila Beatt v


Carol Blankstein


Alan Borger


Brian Bowman




Marilyn Pilon

Valedictory Address


Dean Anderson, Distinguished guests, members of the faculty and fellow graduates . . .

Well we finally made it
To the fork in the road
To the end of a chapter
To the verge of a new beginning
Time to say goodbye to the past
And look to the future

For those of you who are not able to discern the theme of our address from these tremendously novel platitudes, let me explain. Traditionally the valedictory address concentrates on the pleasures and pains of a recently terminated law school career as well as the anxieties and aspirations of future endeavours.

Now as for the past . . ., there's really not a great deal I want to remember about Law School, unfortunately for me this is not a matter of choice. The only things I have attained from my legal education that I will strive to preserve are the

many friendships and my detailed knowledge of the family law cases of M. v M.



Our apprehensions regarding these themes are evident. However, my complete lack of creativity and the fact that some might frown on my alternative approach entitled, "Law School and Grain Farming — Do the Two Really Mix" — dictates that this is the formula we should pursue.

So let us talk about Law School. Who could forget the first day? To me it was similar to the first day of grade school. However, the analogy was shattered when I overheard a conversation between Don Mackinnon, Ralph Glass, and Glen Joyal. They had to deal with the changes in us . . . changes in our stress level . . . in our language . . . and worst of all in our thought process. We started to think like lawyers — an affliction that can carry a certain amount of arrogance. They put up with it and most importantly they helped us keep our perspective and for that we owe them our sanity.

These three years have given us a law degree, a key to success (and sportscars). But hopefully they have also instilled in us, or rather strengthened in us an enduring sense of justice. How to keep true to that when faced with the basic inequalities built into life and law where the wealthy and powerful have readier access to the benefits of the legal system shall be a challenge to us. We have an opportunity to work within that system now, to better it, and to use our skill and knowledge to help all.

Lastly and most importantly we want to turn our remarks to you our classmates. When people are thrown together for three long years, it is inevitable that friendships will result. Despite many differences, we have all become quite close. Part of the reason for our comradary has been the love of fun shown by our class. In fact, we have been called the fun but dumb year. I am sure that while most of us would argue against the latter, the former is definitely true. We really did have a lot of fun. There were the parties in Ray and John's Party house, in the Law Journal office, in the elevator and in the back row of almost every class. The fact that we are the Robson Hall Beer Drinking Champs is an indication of our partying prowess. But this fun was not restricted to students. I can still remember a party at Al Borger's in first year after litigation. We were all downstairs partying, and at about 4:30 in the morning there was a knock at the door. Al's father, who was sleeping upstairs, made it to the door first. As he opened the door, expecting another noisy car load of law students, we all heard a gruff professional voice ask "Hi, is Alan home?"

The other thing that made our class special was the great degree of co-operation. It has been said that only one encompassing LLB should be given to our entire year because of the universal sharing of study notes. And on the point, who of us would be here if it were not for the organizational talents of Al Borger.

The co-operation and intense love of fun made our class unique, but what I truly hope will stay with us are the friendships. After tonite it will be a long time before we can all get together again (and Deb Poskar has informed us that she willnot be organizing any reunion). Therefore, we must say farewell to all our classmates who are leaving the province to make real money. We will miss you and drink to you often . . . so please send cash.

I doubt very much if I could have survived the emotional ups and downs of Law School without all of you. You have made Law School an experience that I will look back upon with much happiness and it is my sincere hope that I will be graced with your friendship and support in the years that follow.






