Valedictory

Madam Justice Krindle, Dean Anderson, distinguished guests, faculty members, spouses, invited guests and fellow students:

I would firstly like to take this opportunity to thank you — my classmates — for the honour and the privilege you have bestowed upon me in having chosen me as your valedictorian. Before I go on I should let you know that this probably does **not** qualify as a valedictory address. You see, I looked up 'valedictory' in the dictionary and found it defined as "A farewell address . . . delivered by a valedictorian." Since I hope to stay in touch with many of you, I won't be saying farewell. Further, the definition of "valedictorian" contains the phrase "a student . . . usually of the highest scholastic standing . . ." Well, that's certainly not a description of me!

Thomas Jefferson said "It is the trade of lawyers to question everything, yield nothing, and to talk by the hour." I'll do my best to keep this short.

We survived the 'law school experience'. Three years ago we first set foot in Robson Hall. Remember how foreign everything seemed to us then? Like that room with all those strange things in frames hanging on the walls. You know—the Transcona room! There were few, if any, familiar faces. Now, three years later, that building has become like a second home. You can walk in just about anytime and find a friendly face, someone to chat with . . . anything to avoid studying!

What happened in that three year span? What is the overall result of the anxieties, the boredom, the laughter, the uncertainties and the hard labour that we shared? First: we have received an introduction to the law. A firm foundation has been set, upon which we can build our knowledge and understanding not only of the law and the legal system, but also our knowledge and understanding of people and the human condition. It is, after all, human events which form and shape the law. With the growth of such knowledge and understanding we can hope to make the world a better place.

Let us thank the professors of Robson Hall. Without their patience, their willingness to assist, their ridiculously long exams . . . without their special efforts, we would not be the people who we are today — the ones developing ulcers, greying prematurely, and suffering from high blood pressure!

Our thanks also to the 'behind-the-scenes' people who helped get us to where we are today. Thank you to the library staff, who thought that recarpeting the Library during first year April exams would dissuade us from carrying on. We persevered! Thank you to the administrative and secretarial staff who got things done and kept things running smoothly — usually. Little do we appreciate the time and energy required to co-ordinate various schedules and activities such as Squash Club parties . . . right, Linda? Thank you to Rosario, the friendly, smiling guardian of the night who kept an eye on the night-owls who liked to study late at Robson Hall. All of these people supported and helped us get here today. And lest we forget, we must also thank the spouses, spousal equivalents (don't you love that term?), friends, and family members who were behind us all the way. We thank them all.

So, we've acquired knowledge and skills. Though some of us may feel that we are not adequately prepared to be loosed on an unsuspecting world, we can take strength from the words of Oscar Wilde who wrote "You know more than you think you know, and want to know more than you do know."

Think of the revelations made to us as early as first year: a "tort(e)" is not merely a fattening European cake; a memo is not a short note; Latin is not a dead language; you know, "Nemo dat quod non habet"... and thanks to Dale Gibson, I'll always remember "Raise the hips and lock the door" (Res ipsa loquitur).

Aside from the education we received, something really special happened at law school. An

amazing assortment of talented, intelligent, hard-working and fun-loving people were thrown together to struggle through the trials and tribulations of a three year sentence. Those people formed a family, our own special family: the class of '87. I know that each one of us has formed special bonds with certain members of our class. We've developed friendships that will last a lifetime. But along with those special friendships, there are things that we — as a class — shared. There are the events and experiences which have now become part of our common history.

How would we have survived without each other? Who else could empathize with the feelings of panic and terror leading up to our first set of law school exams? How does one convey the emotion of utter dread, that 'empty pit' feeling in one's stomach which comes with having memorized only 300 tort cases? How do you make your mother understand that feeling? It's not possible. Our friends and family members out there in the real world just could not relate to what was happening to us. But thank God, we had each other to depend upon. We commiserated together, shared our anxieties and survived the ordeals!

When we came back for second year there were some changes in our family structure. Some people had moved on, others had transferred in. Do these names bring back memories? Warren Holmes, Shirley Forsyth, Ken Malenko, Wayne Morrow. They weren't around to share the terrifying experience of Litigation. Why didn't we believe the third year students who told us all we had to do was show up, stand up and speak up?

Some of us took the opportunity to escape from the books for a short period and take a glimpse of reality by signing up for a duty day at Legal Aid. Unfortunately, there's nothing in the manual about how

to handle a client that shows up slightly intoxicated. Right, Leanne?

Through the difficult and sometimes painful experience there were always the terrific people! I remember an acquaintance asking me sometime during second year whether I was enjoying law school. I informed the person that law school is **not** an experience which a normal, sane person 'enjoys'. It is rather an ordeal which one undergoes or endures — something like having a cavity in a tooth filled. I did, however, mention the best thing about law school: the people! Our class of '87 really is a mixture, isn't it? What variety! Not only backgrounds and ages, but life experiences. We have a physiotherapist in our midst, and a registered nurse, and an airline pilot . . . not to mention the manager of a Dutch Maid ice cream parlour! We've shared three of the toughest years of our educational life with some of the nice'st people we can ever hope to meet.

In thanking our professors for their assistance with our legal education, I neglected to thank them for their friendship. I feel, as do probably most of you who took a class with Butch Nepon, that he drew us closer by sharing with us his very personal experiences of woofing his cookies before every law school

exam.


Let's try and remember with clarity the good times we had at Robson Hall. The unpleasant memories we should allow to fade with time.




