

## **Dr. John Embil Award for Excellence in Clinical Infectious Diseases (*Self-Nomination*)**

**The purpose of this fund is to encourage interest in, and to recognize excellence in, the study of infectious disease.**

- The award is presented to the graduating student, who:
  - Has demonstrated a commitment to the field of infectious diseases and is judged by the Selection Committee to have future potential in this field.
  
- Examples of the applicant's commitment may include, but are not limited to:
  - Research and preparation of case reports for review articles (maybe BSc Med or non-BSc Med related research);
  - Clinical activities locally, nationally, internationally and/or overseas elective.

### **Required Documentation:**

- Signed statement/Letter describing commitment to the area of infectious diseases to support self-nomination (maximum 500 words);
- Two reference letters from Faculty Members that are familiar with applicant's accomplishments in the field of infectious diseases;
- One page summary of 5 most relevant achievements with a brief description of each achievement;
- Curriculum Vitae.

**Fairgrieve McBane Award (*Classmate or Faculty*)**

**The purpose of this convocation prize is to recognize the academic achievements of graduating students in the Max Rady College of Medicine.**

- This prize is presented to the graduating student who has demonstrated the most genuine compassion and profound interest in caring for those in need of medical assistance.

**Required Documentation:**

- Classmate or Faculty submits a nomination letter with a brief description outlining why nominee is a suitable candidate to receive this award.
- Nominee submits Letter of Suitability (maximum 250 words) and
- Curriculum Vitae.

**James Walker Wood, M.D. Convocation Prize in Family Medicine**  
***(Self-Nomination, Classmate, or Faculty)***

**This is a prize for a student who has demonstrated excellence in his or her performance during the Family Medicine rotation and has been accepted to the Family Medicine program (any stream) at the University of Manitoba.**

This prize is presented to the graduating student who:

- Is a Canadian citizen;
  - Has demonstrated leadership qualities and involvement in extra-curricular activities such as medical research, community participation, music, drama, etc.
  - Has demonstrated interest and leadership in the field of family medicine which could include participation in the SWEAT program, the Northern Summer Student Work Program, rural family medicine interest groups, etc.;
  - Has excelled in core and elective Family Medicine rotations.
- ❖ **Preference will be given to a candidate who is from a rural community and/or has expressed interest in rural family medicine.**

**Required Documentation:**

- Self-Nominee, Classmate or Faculty submits a letter explaining why nominee is a suitable candidate to receive this prize.
- Nominee submits statement describing accomplishments and interest in the field of family medicine (maximum 500 words);
- Letter of Support from a practicing family physician and
- Curriculum Vitae.

## **Katherine Klassen Memorial Award (*Classmate or Faculty Member/Instructor*)**

**This is an award offered in remembrance of Katherine Klassen, who was an undergraduate student in the Faculty of Medicine from September 2005 to the time of her death, July 14, 2008. This award's intention is to carry on the legacy of Katherine Klassen, which was to treat every patient with compassion and dignity and to take a patient-centered approach to the provision of care.**

- Presented to the graduating student who is recognized by their peers and instructors as having demonstrated a high level of compassion, humanism, and as having modeled a patient-centred approach to care.

### **Required Documentation:**

- Classmate or Faculty submits a Nomination Letter outlining why nominee is a suitable candidate to receive this award.
- Nominee submits Letter of Suitability;
- Letter of support from non-physician (in addition to Nomination Letter);
- Curriculum Vitae.

## Lukasz Czarnecki Memorial Award (*Self-Nomination, Classmate, or Faculty*)

**This is an award in memory of Lukasz Czarnecki. Luke was a medical student in the Faculty of Medicine when he died in a tragic accident in 2003. He was an inspiring physician who brought commitment, compassion, integrity and an understanding towards the needs of others.**

- This award is presented to the graduating student who:
  - Has been ranked highly during the Internal Medicine Selection process;
  - has shown commitment to the service of others through compassion, integrity and understanding towards their needs;
  - Enrolls full-time in the next academic session in PGME, Internal Medicine at the University of Manitoba.

### **Required Documentation:**

- Self-Nominee, Classmate or Faculty submits a statement describing why nominee is a suitable candidate to receive this award (250 words maximum).
- Nominee provides statement (400 words maximum) describing service to others that includes examples of leadership qualities;
- 2 reference letters from Faculty that are familiar with nominee's accomplishments;
- One page summary of 5 most relevant achievements with a brief description of each achievement;
- Curriculum Vitae.

**MMCF – Jack Hildes Memorial Convocation Prize (*Self-Nomination or Classmate*)**

**This convocation prize is presented to a graduating student who best demonstrates the qualities of humanity, personal discipline, keen curiosity, scientific inquiry, social responsibility, and good citizenship, which enhance a career in Medicine and advance the health of the community.**

**Required Documentation:**

- Self-Nominee or Classmate submits nomination Letter explaining how nominee meets the qualities listed above.
- Nominee submits Letter of Suitability (maximum 500 words) and
- Curriculum Vitae.

**MMCF - Robin Krause Human Values Convocation Prize (*Self-Nomination, Classmate or Faculty*)**

**This fund is offered to support the work of the Human Values Program of the Faculty of Medicine at the University of Manitoba. The aim of this program is to promote the attitudes and skills necessary for the practice of total patient care including the promotion of health and well-being to undergraduate, graduate and practicing physicians in Manitoba.**

- **This prize is presented to the graduating student who best exhibits:**
  1. The traits inherent in the Mission Statement and goals of the Human Values Program:
    - a) Demonstrates an understanding of, and leadership in, total patient well-being including;
      - The doctor-patient relationship as well as a physician's responsibility to society as a whole;
      - The ethical and legal aspects of practicing good clinical medicine;
      - The non-biomedical issues that affect quality of patient care;
      - That the physician is a member of a team relieving illness and promoting health;
      - The broader organizational, economic, cultural and political issues which influence individual ethical decisions.
  2. Has demonstrated a good understanding and use of psychosocial skills.

**Required Documentation:**

- Self-Nominee, Classmate or Faculty submits Nomination Letter;
- Nominee submits Letter of Suitability;
- 2 Reference Letters - 1 from Faculty, 1 from non-Physician;
- One page summary of 5 most relevant achievements with a brief description of each one and
- Curriculum Vitae.

## Doctors Manitoba Student Leadership Prize (*Self-Nomination*)

This fund is offered to support a student who is actively engaged in supporting undergraduate medical students as member of Manitoba's medical profession.

- **This prize is presented to the graduating student who best exhibits:**

1. Student Leadership:

### **Required Documentation:**

- Self-Nominee;
- Nominee submits a statement (max. 500 words) describing their accomplishments in the area of student leadership, which may include one or more of the following: (a) how they have nurtured unity of the student body by promoting activities or peer support, (b) how they have promoted initiatives that enhance medical student health and wellness, (c) how they have advocated for improved access to or raising awareness of significant health issues, and/or (d) how they have contributed to the professional and political bodies that have a positive impact on student life, such as the MMSA, the CFMS or the like.
- Candidates may be required to participate in a panel interview if necessary.



## **Patricia Chapter No. 8 Order of the Eastern Star Prize (*Self-Nomination*)**

This fund is offered to reward graduating students in the Undergraduate Medical Education program who have demonstrated excellence in patient care and leadership.

- **This prize is presented to the graduating student who best exhibits:**
  1. Demonstrated excellence in the area of patient care and leadership
  2. Had prior training and/or a career in an allied health field

### **Required Documentation:**

- Self-Nominee;
- Nominee submits a statement (max. 500 words) describing their prior training and/or career in an allied health field (examples may be nursing, occupational/physical therapist, audiology, etc.), as well as their accomplishments in the area of patient care and leadership.
- Letter of support from a clinician supervisor attesting to their excellence in patient care.
