
## **Consolidated revenue**

instructional activities, administrative support, operational costs, ancillary services, income funded activities.


#### Non-operating activities:

sponsored research projects, special purpose and trust endowments, capital.






## **Operating revenue and expenses** March 31, 2024

#### **Domestic Undergraduate Tuition** 2024-25, by province





### Revenue flow through the budget model








### **Consolidated surplus of \$79.4M**






## **2023-24 Budget Surplus**

### Annual source of surplus 2018-19 to 2023-24






## **2023-24 Budget Surplus** Operating Surplus 2018-19 to 2023-24

### Cumulative balances by fiscal year (millions)






Carryover and provisions: Facultiescombined \$160M as of March 2024 (by source)






## Carryover and provisions: university-wide

## \$820M, BOG approved May 2024

- Considerations:
  - Decline in international student enrolment.
  - Collective agreements expiring in 2024.
- Priorities:
  - Competitive salaries and benefits for faculty and staff.
  - Advancing academic and central unit priorities.
  - Investments in student retention and success.


## **Budget Model Revisions, 2025-26**

- Change in how provincial grant is allocated to academic units for:
  - increased stability and predictability;
  - reduced variability year over year; and
  - enhanced transparency.
- Introduction of new carryover procedures to more effectively spend funds while maintaining an appropriate financial reserve.

## 2025-26 to 2027-28 Planning


### Planning environment

- Limited Provincial grant increases.
- Increasing enrolment with less tuition revenue.
