There is no meal plan (food service) for May to August 2023, but a fully equipped kitchen is available for residents' use when needed.

Rooms are for single occupancy.

Room dimensions - Single: 10' x 10' Super Single: 10' x 18'

**RESIDENCE FEE PAYMENTS:** Full payment is required with application form. Reservations are "tentative" until full payment has been received by the St. Andrew's College Office. All residence fees MUST be paid to St. Andrew's College. We accept payments in the form of cheque, money order, travelers cheque, bank draft, debit card, cash, Visa and MasterCard. Ensure that the student's name and student number are clearly noted. **We do not accept online payments.** 

#### **Cheques, Bank Drafts, and Money Orders:**

- Cheques are to be made payable to St. Andrew's College.
- All cheques, bank drafts, and money orders must be in Canadian funds and drawn on a Canadian Institution.

#### **Debit and Credit Cards:**

- Ensure your daily withdrawal limit allows for the funds required to make the payment.
- If you are unsure whether your daily limit can cover the required withdrawal or you know that an increase to your allowable daily limit is required, contact your bank prior to your arrival

Cash: We only accept Canadian currency.

**WITHDRAWALS:** A resident breaking the housing contract and/or withdrawing from residence is responsible for the duration of the contract period and will assume financial responsibility for all room and meal plan fees.

### **ADDITIONAL FEES & PAYMENTS:**

- \$40 non-refundable application fee
- \$200 Security/Damage deposit (refundable following damage assessment after move-out, if not claimed within 6 months, it will be forfeited).
- \$40 one-time bed linen rental fee (linens must be returned in good condition).
- \$20 replacement charge will be charged for each key lost.

**ARRIVALS:** Date for arrival in Residence is May 1. Plan to check in Monday – Friday, between the hours of 8:30 am and 4:30 pm if possible - *otherwise*, *please make arrangements with the office*.

**DEPARTURES:** Students leaving Residence (i.e. at the end of the Term) must check out during business hours (8:30 am 4:30 pm), Monday through Friday. The security/damage deposit, or a portion thereof, will be refunded only after the room is checked for damage assessment by the maintenance staff.

**BEDDING & TOWELS:** Bedding (2 twin size sheets, 1 pillow case, 1 pillow, and blanket) will be provided by St. Andrew's College for a one-time rental fee of \$40. Residents are required to provide their own towels. Residents are expected to launder their bedding and towels regularly.

**NON-SMOKING POLICY:** St. Andrew's College is a smoke-free environment in all its facilities, including residence rooms.

I have completed this application for residence room / Residence Housing Agreement Contract truthfully to the best of my knowledge. I realize that providing false information may result in my application to residence being nullified. The information provided on this application form will be kept confidential by the St. Andrew's College Administration. I grant permission to St. Andrew's College Administration to contact my references and/or University of Manitoba offices as needed. The final decision of admission to residence is at the discretion of St. Andrew's College Administration.

I agree to abide by the conditions, regulations, and policies of St. Andrew's College in Winnipeg and those of the University of Manitoba as well as any that may be added during the academic year.

On this contract, payment of fees must be made upon acceptance to residence.

I understand and agree that full payment is required with application form. Reservations are "tentative" until full payment has been received by the St. Andrew's College Office.

I understand that if I break the Housing Contract and/or withdraw from residence, I am responsible for the duration of the contract period and will assume financial responsibility for all fees.

I agree to reimburse St. Andrew's College for any damages or penalties incurred, either by myself or my guests.

I acknowledge that by signing this Contract I authorize the St. Andrew's College Administration to contact my emergency contact, parent(s) and/or guardian(s) in the event of an Emergency situation as determined by the sole discretion of the St. Andrew's College Administration.

I assume responsibility for my room and the furnishings. I agree to maintain my room at a clean and sanitary level and I also agree to leave my room in the same condition as it was when I moved in. I will maintain a high level of personal hygiene, sanitation and safety conditions. I understand that, in not complying with said conditions, I may forfeit my Security/Damage Deposit and additional charges may be levied.

I understand there may be events beyond the control of St. Andrew's College that affect the College's ability to provide services and accommodation. These events would include some devastation to the premises like fire or flooding, and could also include a pandemic outbreak. In these typically rare situations, St. Andrew's College would not be liable for my damages or losses or for its inability to provide the contracted services and accommodation.

By signing below, I authorize St. Andrew's College in Winnipeg to conduct a criminal records search, as well as any related searches, including and without limitation, child abuse registry databases and vulnerable sector searches. I agree that St. Andrew's College shall be entitled to consider any results from the foregoing searches in determining whether to allow me to have access, or a continuation of access, to the Residence.

I hereby agree to comply with the residence regulations of St. Andrew's College Administration and the University of Manitoba. I also understand that noncompliance with the rules and regulations of St. Andrew's College will result in my expulsion from residence without refund.
