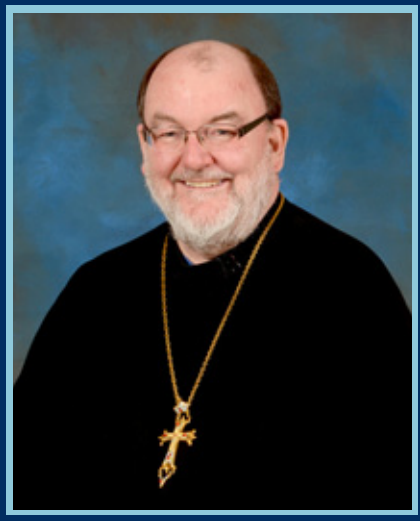

РЕЗИДЕНЦІЯ І СТУДЕНТСЬКЕ ЖИТТЯ

RESIDENCE AND STUDENT LIFE

Колегія Св. Андрея є частиною Університету Манітоби. У ній знаходиться гуртожиток для українських православних та інших студентів.

Привітний, дружній та затишний гуртожиток має великі і маленькі односпальні, а також двоспальні кімнати для 38 резидентів - чоловіків та жінок. Кімнати гуртожитку обладнані необхідними меблями для комфортного студентського життя. Більше того, для студентів є доступними різноманітні устаткування, що створюють домашню атмосферу та забезпечує якісне довкілля.

Досі оговтуючись від наслідків пандемічних обмежень (COVID), багато студентів все ще навчаються онлайн. Крім того, рішення федерального уряду різко обмежити кількість іноземних студентів, яким дозволено в'їжджати до Канади, негативно вплинуло на всі резиденції Манітобського Університету, та зокрема резиденцію Колегії Св. Андрея. У січні-квітні 2024 року та у вересні-грудні 2024 року резиденція Колегії Св. Андрея заселена на 50 %, що є на 10% більше, ніж за аналогічний період минулого року. Протягом літніх місяців 2024 року (з травня по серпень) резиденція Колегії Св. Андрея була заселена на 100 %.

Студентська Рада, Товариство Студентів Богослов'я, і Рада Українських Канадських Студентів Манітоби разом з адміністрацією Колегії сприяють і спонсорують різні види спорту, громадські, освітні, релігійні та культурні заходи.

St. Andrew's College is a Member College of the University of Manitoba and also a residence for Ukrainian and Orthodox and other students on the campus of the University of Manitoba.

The intimate, friendly, quiet Residence has premium super single, regular single, and double rooms available for 38 residents - men and women. The Residence rooms are furnished with the basic necessities for a comfortable study life, and the numerous College facilities available to the students make for a homey atmosphere catering to a wide variety of needs.

Still recovering from the effect of COVID pandemic restrictions, many students are still studying online from home. Also, the Federal Government decision to drastically limit the number of foreign students allowed into Canada has negatively impacted St. Andrew's College and all University of Manitoba residences. January to April 2024 and September to December 2024 St. Andrew's College residence is only at 50 % capacity (up by 10% from the same time last year). During the 2024 Summer months (May to August), residence rooms were filled to 100 % capacity.

The Resident Student Council, the Theology Student Association, and the University of Manitoba Ukrainian Student Association together with the College administration, usually promote and sponsor numerous sports, social, educational, religious, and cultural activities.



Working hand-in-hand with the Government of Manitoba Ukrainian Refugee Task Force, the St. Andrew's College residence accommodated 20 Ukrainian refugees for the months of March and April 2024.

We made them feel at home as they adjusted to life in Canada.



PHYSICAL PLANT

Building maintenance is managed by our Property Supervisor, Mike Kupiak, along with Assistant Property Supervisor, Fr. Bohdan Statkevych.

Many Physical Plant projects were done or are in the works. Some are planned and will be included in the budget - others are unexpected and have to be taken care of immediately.

Following is a list of major projects, regular maintenance, and repairs for the period of January - December, 2024:

- Repairs to coin operated washing machine
- Replace South East interior door closers
- Drain repair in laundry room
- Repair main kitchen sink leak
- Balance air supply in East wing offices and classrooms
- Repair timer and replace outside light – West wing UMFA
- Repair vestibule heater and thermostat at Main Courtyard entrance
- Repair leak in mechanical room from dining hall water fountain
- Repair flush valves
- Preventative maintenance sewer main line cleaning
- Replace belts in Mechanical crawlspace
- Safety technician took smoke alarm offline when pipe burst in basement
- West wing emergency exit door lock repairs for UMFA
- Replace toilet in 3rd floor women's washroom
- Weed control and fertilizer
- Power vac cleaning of heating coils in crawlspaces and vestibules in five entrance areas
- Repair dish room spray wand
- Repair to vertical rods and door closers at Courtyard entrance
- Emergency repair in basement TV lounge from burst pipe leak
- Toilet replacement and drain repair in basement apartment
- Courtyard electrical light fixture repair
- Thermostat repairs in resident rooms
- Plumbing repair to sump pump discharge pipe
- Patch leaking East wing roof
- Repair automatic door activator at UMFA handicap entrance
- Replace 22 of 44 emergency light batteries
- New fridge for residents' basement kitchen
- Replace main kitchen exterior screen door and repair to window in residence room



- Annual kitchen exhaust cleaning and fire suppression service
- Basement TV lounge floor asbestos abatement and tile replacement
- Mould remediation in the basement Laundry room
- Asbestos abatement in Classroom D, replace floor tiles, and patch ceiling leak

Upcoming Projects:

- Electrical – circuit breakers in the Main kitchen need to be replaced. We are reviewing options and looking for an electrical company.
- Replace leaking roof over East wing – we have three quotes (ranging between \$ 75, 000 and \$ 180, 000). We will begin discussion in the new year.



LIBRARY REPORT

St. Andrew's College Library is an essential part of the educational process for the students of Theology, the Centre for Ukrainian Canadian Studies, the University of Manitoba, researchers, the public, and all those interested in Orthodox and Eastern Christian Theology, Ukrainian history, culture, art and Ukrainian Canadian Studies.

Scholars from around the world access our library's holdings including many journals and publications, some of which are extremely rare. Such is the assistance provided by our Library in the research undertaken by: Oksana Klymenko, Candidate of Historical Sciences (PhD), Petro Jacyk Post-Doctoral Fellow at the Center for Ukrainian Canadian Studies at the University of Manitoba; Nataliia Kulish, Associate Professor at the Department of Philosophical Sciences and Physical Education, Candidate of Philosophical Sciences (PhD) from Khmelnytskyi University of Management and Law; Liudmyla Obukh, Doctor of Arts (PhD) from Zhytomyr State University of Ivan Franko; Andrii Tsebenko, Doctor of Theology (ThDr), Lecturer at St. Andrew's College.

Dr. Oleh Gerus continues his research on the Internet for materials on the current situation in Ukraine and is compiling a special collection for the benefit of the students of today and tomorrow.

We completed the project of correcting and verifying all author and title cards of the pamphlets collection, sorting and organizing boxes of brochures to make them more accessible for our visitors.

In addition to the regular routine work required to maintain a smoothly operating Library, the library staff continue the following projects:

- We are proceeding with an ongoing project – a compilation and cataloguing of our duplicates holdings.
- Library prepares thematic showcase displays: Ukrainian Christmas, Easter, Independence Day of Ukraine, National Interment Commemoration Day, Holodomor- Genocide commemoration and others.
- Library employees participate in organized St. Andrew's College events.

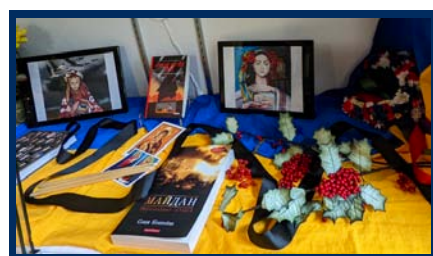

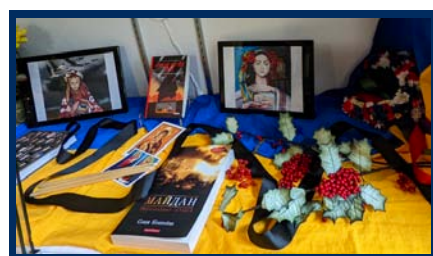

The Scholarship and Bursary Initiative was set up to promote donations for academic awards at Manitoba's post-secondary institutions.

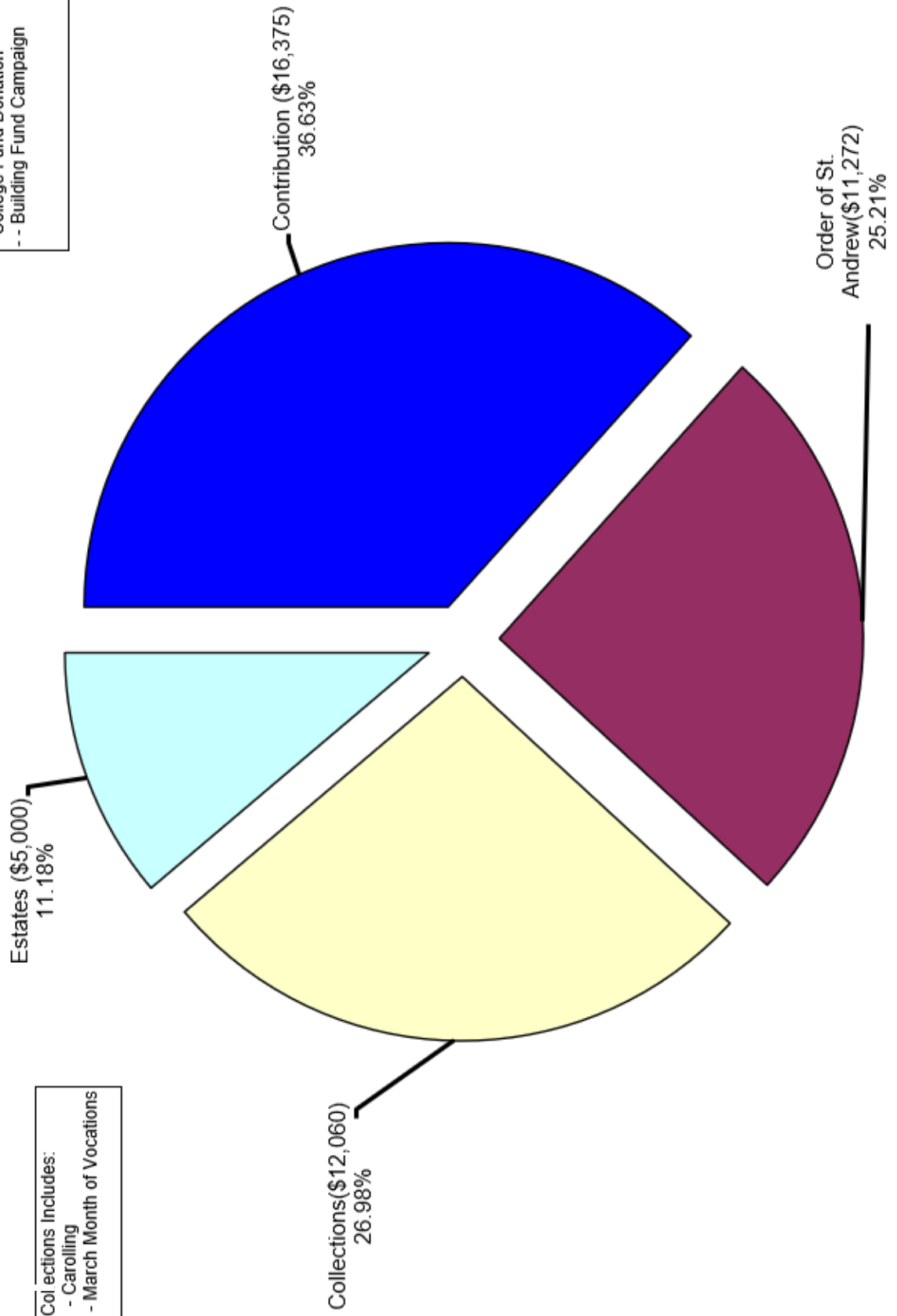

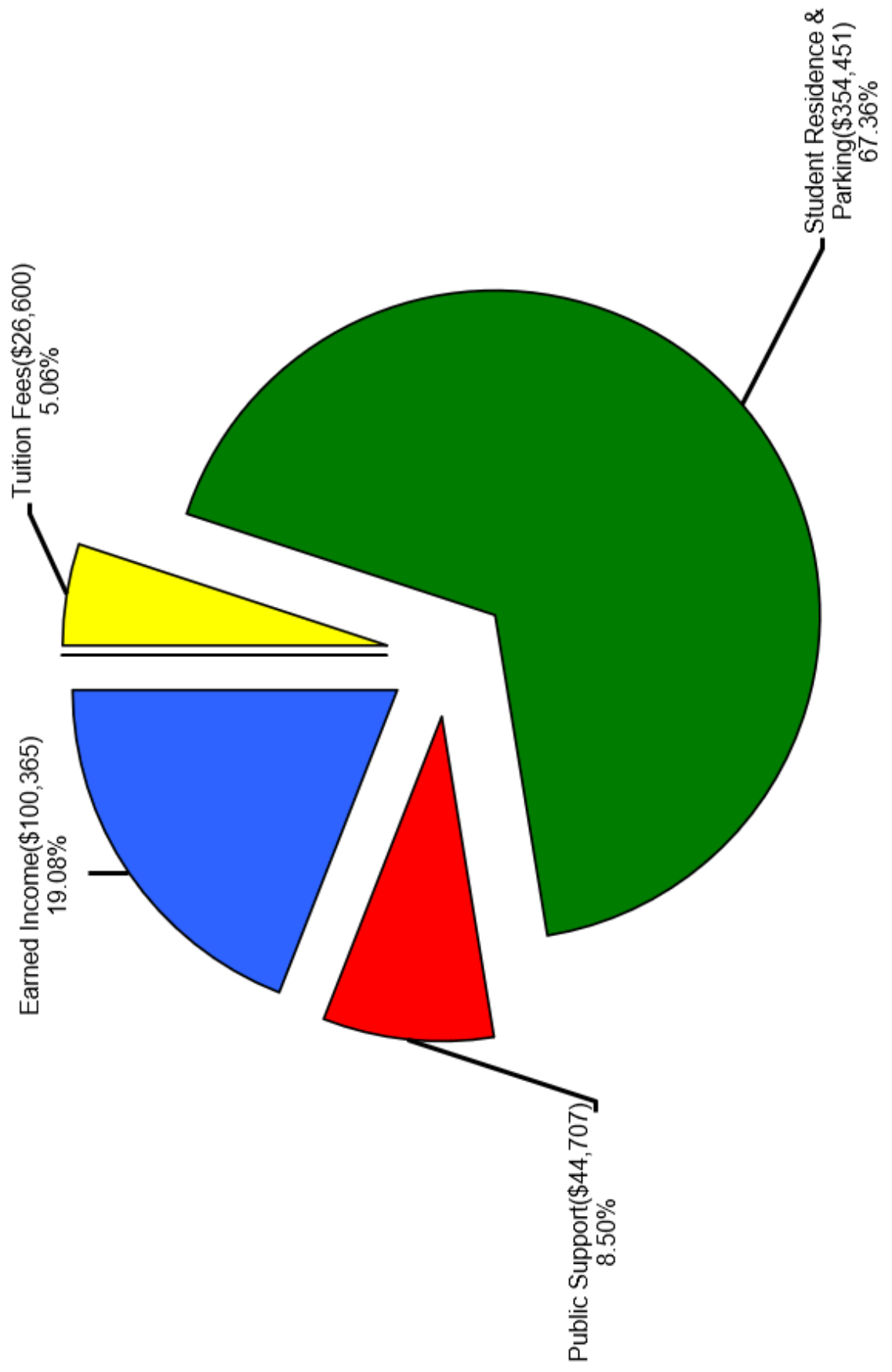
St. Andrew's College Public Support Revenue (General Fund) For The Year Ended June 30, 2024

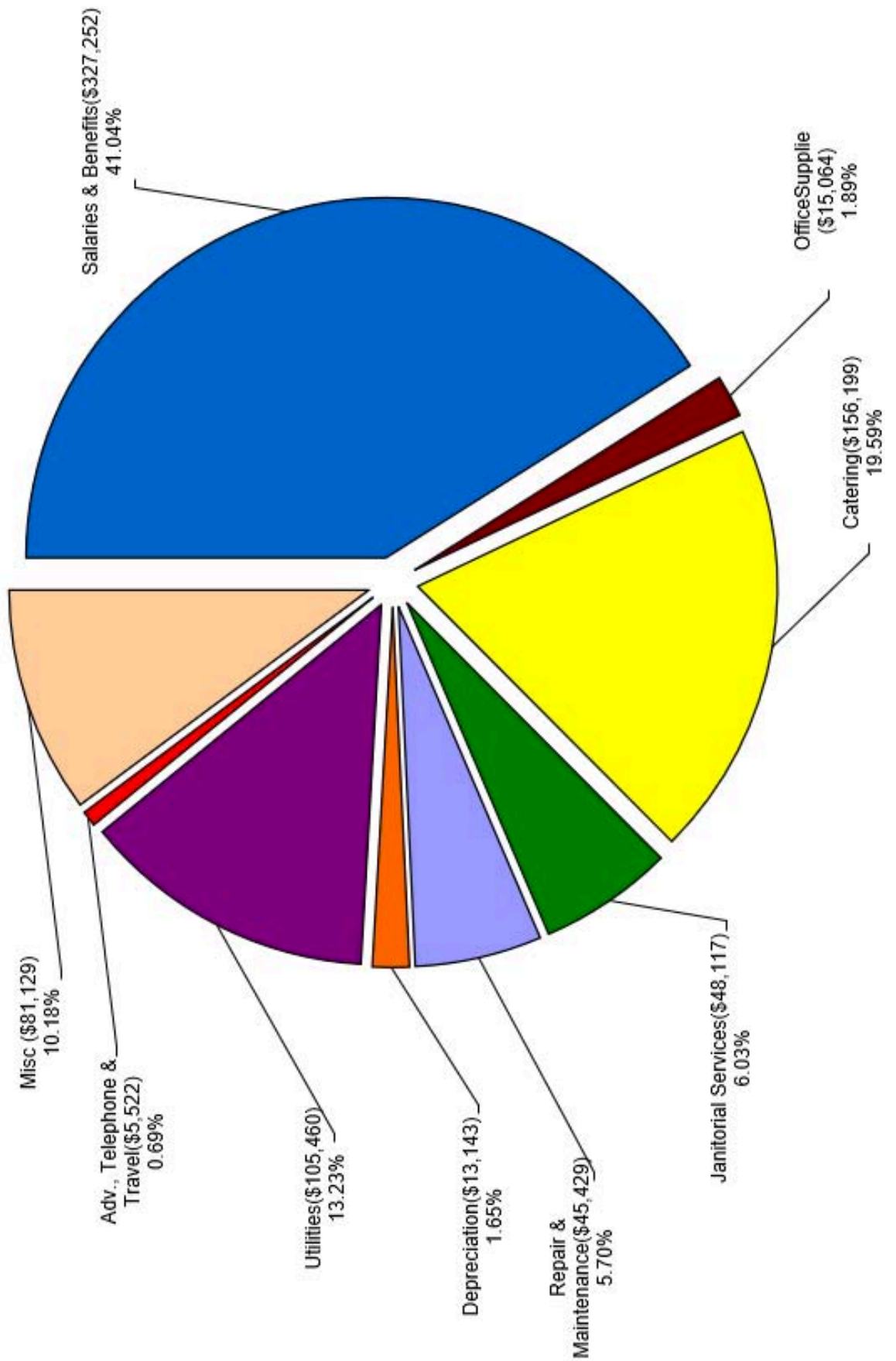

INDEPENDENT AUDITOR'S REPORT

To the Members of St. Andrew's College in Winnipeg

Qualified Opinion

We have audited the financial statements of St. Andrew's College in Winnipeg (the College), which comprise the statement of financial position as at June 30, 2024, and the statement of operations and changes in fund balances and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, except for the possible effects of the matter described in the *Basis for Qualified Opinion* section of our report, the accompanying financial statements present fairly, in all material respects, the financial position of the College as at June 30, 2024, and the results of its operations and cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO).

Basis for Qualified Opinion

In common with many not-for-profit organizations, the College derives revenue from donations the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of the College. Therefore, we were not able to determine whether any adjustments might be necessary to donation revenue, excess of revenues over expenses, and cash flows from operations for the year ended June 30, 2024, current assets and net assets as at June 30, 2024. Our audit opinion on the financial statements for the year ended June 30, 2023 was modified accordingly because of the possible effects of this limitation of scope.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the College in accordance with ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with ASNPO, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the College's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the College or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the College's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the College's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the College's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the College to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

1. NATURE OF ORGANIZATION

St. Andrew's College in Winnipeg is an institution of the Ukrainian Orthodox Church of Canada and is affiliated with the University of Manitoba. The College exists to promote spiritual, academic, cultural and moral leadership with the Church and the Ukrainian Canadian and Canadian communities. The College houses the Faculty of Theology, which prepares candidates for the clergy and other professionals for service in the Ukrainian Orthodox Church of Canada and other Orthodox churches, the Centre for Ukrainian Canadian Studies, which offers university credit courses through the University of Manitoba, and a student residence.

St. Andrew's College in Winnipeg is a registered charitable organization and is exempt from income taxes under the provisions of the Income Tax Act of Canada.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO). Canadian accounting standards for not-for-profit organizations are part of Canadian GAAP.

Fund accounting

The College uses fund accounting procedures which result in a self-balancing set of accounts for each fund established by legal, contractual or voluntary actions. The College maintains the following funds:

- a) The General Fund accounts for the College's program delivery and administrative activities.
- b) The Capital Assets Fund reports the assets, liabilities, revenues and expenses related to the College's property, plant and equipment.
- c) The Designated Funds and Scholarship Funds report the specified uses of the College's restricted funds.

Revenue recognition

The College follows the restricted fund method of accounting for contributions.

Unrestricted contributions for general operations are recognized as revenue of the general fund in the year in which they are received. Restricted contributions for specified projects, programs and scholarships are recognized as revenue of the appropriate fund when received.

Revenue from tuition fees, board, lodging and parking and levy income is recognized on a time proportionate basis. Other revenue is recognized when it is earned.

Property and equipment

Property and equipment are stated at cost less accumulated amortization. Property and equipment are amortized over their estimated useful lives at the following rates and methods:

Buildings	2%	straight-line method
Storage shed	5%	straight-line method
Computer equipment	25%	straight-line method
Furniture and equipment	10%	straight-line method
Parking lot	5%	straight-line method

The Library is considered to have a residual value of at least the net book value and, therefore, amortization is no longer required.

Amortization is reported in the Capital Assets Fund.

The College regularly reviews its property and equipment to eliminate obsolete items.

Financial instruments policy

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.

The College's financial instruments measured at amortized costs consist of cash, accounts receivable, amounts due from St. Andrew's College Foundation Inc., investment in Trident Press Company Ltd., accounts payable and accrued liabilities, scholarships payable and loan payable.

Government assistance

Government assistance for current expenses is recorded as income.

Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

4. INTERFUND BALANCES

Interfund balances are non-interest bearing with no set terms of repayment.

5. CONTROLLED ENTITIES

The College controls St. Andrew's College Foundation Inc as noted below.

The Endowment Fund was created in 1979 to provide donors an opportunity to donate funds which would be held intact in perpetuity. The net assets of the Endowment Fund were transferred to St. Andrew's College Foundation Inc. effective September 1, 1987. All donations of the Endowment Fund to August 31, 1987 and all donations to the Foundation thereafter are invested and held in trust in order to earn income for the exclusive use of the College. The net earnings of the Endowment Fund to August 31, 1987 and the net earnings of the Foundation thereafter are transferred to the College for its operating needs.

The College controls St. Andrew's College Foundation Inc. by virtue of its ability to appoints the majority of the Foundation's Board of Directors. The Foundation was established to receive from the College donations, contributions and bequests made to the College by various donors and to hold, invest and manage these for the sole use and purpose of the College. The Foundation is a registered charitable organization and is exempt from income taxes under the provisions of the Income Tax Act of Canada.

The Foundation reported net income of \$73,411 (2023 - (\$100,122)) in its general fund with \$73,411 transferred to the College for the year ended June 30, 2024 (2023 - \$nil). As a result of net transfers to the College during the year, the Foundation owes the College \$29,759 as at June 30, 2024 (2023 - \$195,401). This amount is non-interest bearing.

The College provides management and administration services to the Foundation for no consideration.

The Foundation has not been consolidated in the College's financial statements. Financial statements of the Foundation is available on request. Financial summaries of these unconsolidated entities as at June 30, 2024 and 2023 is as follows:

In accordance with donor imposed restrictions, \$706,472 (2023 — \$657,608) of the Foundation's net assets has to be used to assist in various operating requirements of the College and \$3,607,364 (2023 — \$3,372,324) has to be used for the payment of scholarships to deserving students studying religion. A further \$1,788,687 (2023 — \$1,644,258) of the Foundation's net assets is subject to donor imposed restrictions that they be maintained permanently with the investment revenue earned to be used to provide scholarships for worthy students studying religion.

7. FACILITIES

The College has a \$150,000 overdraft facility available that bears interest at prime plus 0.75% and is secured by an asset of St. Andrew's College Foundation.

8. FINANCIAL INSTRUMENTS

The College is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the College's risk exposure and concentration as of June 30, 2024. There has been no significant change to the risk exposure from the prior year.

(a) Credit risk

Credit risk arises from the potential that a counter party will fail to perform its obligations. The College is exposed to credit risk from customers. In order to reduce its credit risk, the College reviews a new customer's credit history before extending credit and conducts regular reviews of its existing customers' credit performance. An allowance for doubtful accounts is established based upon factors surrounding the credit risk of specific accounts, historical trends and other information. The College has a significant number of customers which minimizes concentration of credit risk. The allowance for doubtful accounts at year end is \$nil (2023 - \$nil)

(b) Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The College is exposed to this risk mainly in respect of its receipt of funds from its customers and other related sources, short-term debts, and accounts payable.

(c) Interest rate risk

Interest rate risk is the risk that the value of a financial instrument might be adversely affected by a change in the interest rates. In seeking to minimize the risks from interest rate fluctuations, the College manages exposure through its normal operating and financing activities. The College is exposed to interest rate risk primarily through its floating interest rate bank indebtedness and credit facilities.

Unless otherwise noted, it is management's opinion that the College is not exposed to significant other price risks arising from these financial instruments.

9. EXPENSE RECOVERIES

Certain expenses in the general fund were recovered from designated funds.
