It has been a long time since Assembly met and in the meantime our world has been turned upside down. This report then reflects the pre-COVID activities where there were a lot of meetings and travel and the “stay at home” where all activities take place in front of a computer. Like most faculty, I had to scramble to move my course on-line, and in the process recorded a

series of 13 lectures that were posted through the UMLearn system, as well as coping with the high levels of student stress. End of term marking had a different level of challenge this year.

I continue to participate in the committees of the College such as Membership, Honorary Degrees, and Administration and Finance in person prior to the lock down and now on Zoom. I also continue to be active on the Board of the Rupert's Land News and the Anglican-Mennonite dialogue.

This term the College offered two courses in conjunction with Canadian Mennonite University. The Rev. Andrew Rampton is offering "The Eucharist in Anglican Liturgical History" (9 participants) and Dr. Graham MacFarlane is offering "The Christian Life – an Anglican account" (18 participants) at St Margaret's Church. We have renewed our Memorandum of Understanding with CMU for these courses. CMU is suggesting, and I agree, that we move into an ongoing MOU with them rather than continuing on a course-by-course basis. Our Spring course on Indigenous Theologies has been cancelled, and we are looking to planning for the Fall term.

Dean of Studies: Report to Assembly/Council May 2020

When the Covid-19 outbreak led to the cancellation of classes in early March, and then full closure of the university, we had to cancel a number of events, including a Soup and Bread Lecture by Annette Desmarais, the End of Term Reception, and, sadly our inaugural Music Competition finale. I want to thank everyone who worked so hard on preparation for these and other College activities that we couldn't carry through – at least not yet.

We also have two retirements from the College this term that we have not been able to recognize, Barry Ferguson and Dianna Brydon. We were to have raised a glass in their honour at the End of Term Reception. I do hope that circumstances will allow us, at another time, to say 'goodbye' to our colleagues and celebrate with them their long careers at UM, and their time with us at St John's. We will miss them.

I also want to say farewell to Jill Stafford, from the Development Office, who has retired in the midst of a pandemic! Jill has often invited Fellows to present their research to alumni and other friends of the College, thus promoting the work that we do here, and building connections between our faculty, senior graduate students, Visiting Researchers, and the broader College community. Thank you, Jill.

Membership Committee

This year, we had a number of applications for Fellowship. The Membership Committee met virtually to consider those, and we are putting forward a motion today recommending the election of three new College Fellows:

Caroline Piotrowski is an Associate Professor in the Department of Community Health Sciences, Faculty of Health Sciences. She is the Director of the UM Violence and Injury Prevention Research Group, and is affiliated with the Children's Hospital Research Institution of Manitoba. Her research focuses on trauma and resilience, particularly in children and families. Her recent publications include work on the impact of intimate partner violence on children, family and child coping mechanisms in dealing with serious chronic disease, and child perspectives on the use of bicycle helmets and car booster seats.

Anne Lindsay is a Doctoral Candidate in the Department of History, under the supervision of Prof. Adele Perry. She completed her candidacy exams in 2019. She also has an MA in Archival Studies. Anne was the Research and Access Archivist for the National Centre for Truth and

Reconciliation for three years, and is currently a Consultant for the University of British Columbia, Indian Residential Schools History and Dialogue Centre.

Shelisa Klassen is a Doctoral Candidate in the Department of History, under the supervision of Prof. Adele Perry. Her doctoral research focuses on the discourse around immigration in Red River and Winnipeg in the 1870s, an almost entirely Indigenous space that was radically transformed by the immigration of settlers and displacement of Métis and First Nations peoples by the end of the decade. Shelisa is a very active member of the History Department, with significant committee and organizing experience.

The suspension of worship and shutdown of campus has meant significant changes and challenges for the function of the chaplaincy, as with all parts of the college. Unsurprisingly, there is no list of events or meetings to present, though the chaplaincy is not without activity:

- Writing regular pastoral letters for the college membership
- Maintaining contacts with staff, fellows, and students to check in and provide support at a distance
- Cooperating alumni and supporters of the college, with direction of the Development Office, to provide updates on the college's response to the current pandemic and maintain relationships
- Planning for programming and scheduling for the 2020-21 year, realizing that there will be many challenges and constraints on what is possible
- Participating in Sunday morning worship for the diocese as the chaplain of St John's College, livestreamed from diocesan office

Bursar

Bursars' Report to Assembly April 5th, 2020

Financial

Clearly, the COVID-19 pandemic has had a major impact on the College. Since March 23rd, the only revenues we have had coming into the College budget have been residence fees. Despite all classes moving online, we maintained an occupancy level of approximately 79% through to the end of the term. This is largely due to the international students in our residence. We continue to have approximately 50 students in our residence as we start the summer term. This continued albeit diminished revenue stream will assist us in continuing to be able to pay our staff.

We have not laid anyone off yet and will retain staff for as long as we are able. All discretionary spending has been halted and we are monitoring our cash flows. The College was able to take advantage of the \$40,000 small business loan program through RBC, which will remain interest free if we pay it back by 2021. And if we do, \$10,000 of that loan will be forgiven. We are also utilizing the 10% temporary wage subsidy.

The University of Manitoba, at the request of the Provincial Government, was required to develop scenarios that envisioned workforce cuts of 10, 20, and 30% from May – August. St John's was required to participate in this exercise, and we have done so. Our submission achieved this goal by not hiring for the vacant Awards Clerk position. This would allow us to retain the rest of our university staff at full capacity. We have not yet had a response from the University.

Our audit is set to begin on June 15th. We continue to work on our year end statements and prepare for the audit. BDO Canada is planning for the audit to take place remotely, with no on-site presence.

As is the case for everyone these days, everything is new and unprecedented. We will continue to monitor our financial situation and do our best to adapt to the ever-changing landscape safely, and as successfully as we can.

Residence

As I alluded to previously, we currently have 50 students staying in residence. They continue to social distance and do whatever they can to stay safe in relatively close quarters. Our food service operations have adapted to provide a great service safely, and with minimal contact. Students eat their meals in their rooms for the most part, although some remain in the dining room (one student per table). Our housekeeping staff is keeping everything clean. Residence life is inherently social, so this has been a huge adjustment for the students. But they have been willing to change their behaviour and are taking the circumstances seriously. Many have unexpected financial needs, and we have been able to meet a lot of those needs through the incredible generosity of alumni, fellows, and staff. This has been great to see.

Staff

We are all pulling together to work together. Our food service and housekeeping staff have been amazing. Our Dons in the residence have really risen to the occasion. And the admin staff are staying in touch and collaborating on projects that could use some extra attention. Things like a complete audit of our website, and re-imagining and re-establishing our Annual Report.

There have been three overarching concerns since we last met in May: 1) government-imposed budget reductions on the University. This was a very difficult struggle during May, but in the end the College was able to cover our share of the cuts through reductions in office supplies, travel and the like. We did not have to lay anyone off or lose positions. 2) the University has made two serious attempts to shut down our residence which I have resisted. I have yet to play our trump card which is that the residence is entirely owned and operated by the College and they have no say in the matter. 3) the planning for and submission of the Phase 2 and Phase 3 recovery plans.

Chaplain's Report to SJC Assembly

20 September 2020

Activity in the chaplaincy since May's meeting has been limited, both by the pandemic-related campus restrictions and the typical summer slowdown. My study leave and annual holiday occupied much of the early summer time, though a few important meetings and events relating to ongoing work with students occurred during this time.

In early July it was announced that 5 October 2020 will be my last day as college chaplain. On 6 October I become priest in charge of Holy Trinity Anglican Church, Winnipeg, an appointment which takes me from both SJC and St Bartholomew's Parish in Windsor Park.

Major points of work since our last meeting include:

- Assisted with planning and executing an online prayer vigil for victims of racism on 6 June
- Facilitated a recording session in the college chapel for a student applying to doctoral programmes in music
- Planned and presided at the wedding of Ann Ding and Andrew Weber on 2 August
 - Andrew has been one of our residence dons the past couple of years
- Planned and presided at the memorial service for Dr Laura Taylor, Faculty of Social Work, on 17 September in the college chapel
- Assisting SJCSA with fall event planning and establishing work patterns and systems for a year that will be primarily online
- Worked with representatives from St Paul's College and UManitoba to supply material about SJC, college membership, and college life for the online orientation sessions and websites
- Hosting a game of SJC Jeopardy! for the Jumpstart programme on 16 September

Bursars' Report to Assembly September 22nd, 2020

Financial

The Impact of COVID-19 on the operations of the College continued over the course of the summer. Courses were delivered remotely, and the Fort Garry Campus was officially closed. Our only revenues have been from the international St John's members we had living in our Residence. Fortunately, the College was deemed eligible to qualify for the Federal CEWS program (Emergency Wage Subsidy), which has offset 75% of our employment costs. This, along with our residence operations and eliminating all discretionary spending, has allowed us to keep all our staff employed and provide a safe and secure place for our students to live. In addition, we ended the 2019-20 fiscal year in a strong position with a modest surplus so that has strengthened our ability to weather these unprecedented circumstances. Right now, the CEWS program is scheduled to continue to the end of 2019. We have also not yet had to access our investment income budgeted for operating this year, so we remain in a stable position.

Our annual audit was completed over the summer and although it was challenging to go through the entire process remotely, it was successful. The entire process took longer than normal but draft statements will be presented to the Finance & Admin Committee on September 23rd.

Residence / Operations

Due to COVID-19 all our summer groups were cancelled. We maintained an occupancy level of 35-50 students during the entire summer. Given all the inherent challenges brought on by the pandemic, affecting both students and staff, everything went very well. Safety measures and enhanced cleaning was enacted, and students were very responsible and cooperative in adhering to physical distancing protocols, hygiene, and now the addition of mandatory masks.

Beginning in September, some students moved out and 3 moved in – all local, from either Winnipeg or the surrounding area – so our current occupancy is 34. The health and safety of our students and staff remains our top priority, and we are continuing with all our enhanced protocols including additional washroom cleaning, individually served meals, mandatory masks in public spaces, and ongoing physical distancing. We have kept two of our apartments vacant to be used as quarantine space should the need arise.

On September 14th we re-opened the Daily Bread Café. The Café is accessed exclusively through the Patio Entrance to minimize any traffic through the rest of the College. The Café has been fitted with safety glass in all serving areas, physical distancing signs have been displayed on the floor, and seating has been drastically reduced and properly spaced to conform to all Provincial safety standards.

Registrar's Report September 2020

It has been a busy summer as acting Awards Clerk.

For the April 1 deadline there were 455 applications from 92 Applicants.

23 of Applicants are International students
16 of Applicants are Permanent residents
1 Applicant is a refugee

1 student applied for 26 scholarships and bursaries
1 student applied for 24 scholarships and bursaries

91 of the applications are for the July 31 deadline

Averages to 5 applications per student

For the July 31 deadline, 395 applications were received, plus the 91 that came in on April 1 means there are 486 applications from 119 applicants.

These are, I believe, record numbers. It is good to see students finally taking advantage of this part of their membership, and yet the amount of financial need, and knowing that we won't be able to help everyone makes it a bitter-sweet situation.
