ENDOWED FUNDS – ADMINISTRATION FEE REVIEW

Preamble

St John's College's endowed funds are an important source of funding for various programmes within the College. Alum and friends have donated money to the College to be maintained in perpetuity for the purposes of providing awards, bursaries and scholarships, for the general operation and maintenance of the College and its facilities, as well as academic programming and lecture series. These funds have been combined into a master trust, the Endowment Trust Funds (SJC Trust).

The financial management of the Trust is the responsibility of the Finance & Administration Committee of St John's College, appointed by the Council and Assembly of the College. The Committee hired the firm of Doherty & Associates, based out of Ottawa and Montreal, to manage the Trust. The guidelines given to the investment manager are 60% equity and 40% fixed income. No restriction has been placed on the investment manager regarding the relative percentages of Canadian versus non-Canadian assets or on the percentage of cash and short-term notes within the fixed income asset class. The assets and securities of the Trust are held by RBC Global Services (the custodian), who also tracks the Trust assets and transactions and reports monthly to the College. The equity manager charges up to 1% to administer SJC Trust.

It has been the practice of the College not to charge an administration fee to the endowed funds which is valued at just under \$10 million as of the 31st March, 2023. The Finance and Administration Committee would like to revisit that decision given the financial insecurity the College faced during Covid.

Other Organizations

After some preliminary research it would appear most organizations recoup a portion of operating funds from the endowed funds. A quick sampling was done of some Winnipeg based organizations.

1. University of Manitoba – 0.81% for 2022-2023
Total value of the University Investment Trust (UIT) is \$935.7M with a spending rate of 4.25% based on a rolling 48-month average market value.
As per their policy "...Fees include investment management, custodian, consulting, performance measurement, and internal administrative fees."
2. The Winnipeg Foundation – All Funds: 0.5% for the first \$10 million
Agency funds are those held on behalf of charities within Winnipeg. The College has an Agency Fund held at the Foundation valued under \$100,000 therefore we are charged 0.5% administration fee annually on that fund.

3. St Paul's College Foundation – 1% for 2022-2023
Total investment is \$10,711,655 not all is in endowed funds. Fee is to “support administrative costs, including investment management fees, professional accounting services, an annual audit and other operational expenditures”.

4. The Jewish Foundation of Manitoba – 0%
They do not apply an administrative fee to the endowed fund. Philosophy is one that this is not new money and they want to distribute as much as possible to the community. It was explained to me as an “exercise in optics” as operating expenses show to be less when the fee is charged against the endowed fund.

Warden's Report to College Council, November 2023

It has been a great fall term at the College, and the first “normal” feeling academic year since I became the Warden. There is a lot of energy around the College, and a renewed feeling of community among our students, fellows, staff, and alumni. Over the weekend of Nov. 3-5 we enjoyed all of the festivities associated with our annual Convocation, which were well attended, meaningful, and just a lot of fun. In October, the Development Officer and I had a very successful trip to Toronto, where we were able to connect with yet more alumni and supporters. We also continue to grow our numbers after a pandemic slowdown, welcoming many new students, fellows, and staff to the College.

College Building Projects

Per the motion passed by Council in September 2023, I have signed the letter of intent between the College and University of Manitoba regarding the potential collaboration on a new student residence. The Bursar and I had another very positive meeting with representatives from UM that affirmed their strong commitment to making the partnership work, and we expect an update on the financial aspects of the project in late 2023 or early 2024. In the meantime, the Admin team is developing plans for possible operational models for this new residence to present to UM, considering how a new residence will align with our other building projects surrounding food service and the third floor of the College building, and laying ground work for a capital campaign.

Student Recruitment/Experience

Led by our Registrar and Marketing and Communications Officer, the Admin team and SJCSA have continued with the concentrated student recruitment campaign begun during Welcome Week in September. We are thrilled to have added almost 200 new members since the start of the term, and have established benchmark goals for the rest of the academic year and beyond which we are on track to meet. We have also been carrying on in our efforts to better understand who our current students are, and what specific supports they need, through our ongoing data analysis project. Most significantly, we received permission from the UM Vice-Provost of Student Affairs to send out a survey to all nearly 30,000 UM students to find out what they know about SJC and what they are or could be looking for from membership in the College. We are still processing the results, but they have already been very illuminating.

Theology

Since Council last met, we have been pleased to welcome Ryan Turnbull, the new Diocesan Discipleship Developer, who is working out of the College and helping us to determine our path forward with respect to theological education. He will be presenting to Council directly about his role and plans. However, I wanted to note here that Ryan and I have recently held

meetings with Canadian Mennonite University and St. Margaret's Anglican Church about our ongoing theology course sharing arrangements. Ryan also joined me at a meeting of the Heads of Anglican and Lutheran Colleges on Nov. 14.

Teaching, Scholarship, and Public History

I continue to teach a course for the History Department, "Between Victoria and Elizabeth: Britain, 1901-1952," which is new to me and UM and so far has gone very well. On Oct. 24, I had the pleasure of visiting River Heights Junior High to talk to two grade 8 social studies classes about the work of a historian. Since Council last met, I completed a peer review of a book proposal for Manchester University Press, and chaired two panels (offering a comment on one of them) at the North American Conference on British Studies in Baltimore, MD, from Nov. 10-13. I have also been working with the Rector and a parishioner from All Saint's Anglican Church on an oral history project collecting the stories of two members of their congregation who lived through WWII, including the College's own Dr. Anthony Waterman.

Highlights of Other Recent Activities

- On Sept. 20, I attended and introduced our speaker, Dr. Jade Weimer, at a Lunch & Lively.
- On Sept. 21, the Development Officer and I hosted a group of students and alumni at the SJC table at UM's Distinguished Alumni Awards banquet.
- On Sept. 25, I led the second annual SJC Orientation for new fellows and staff.
- On Sept. 29, I attended the first meeting of the Evangelical Lutheran Church in Canada's Task Force for Candidacy and Leadership, and will continue to serve on the committee.
- The College was pleased to host Faith Horizons from Oct. 13-14, for which I attended the opening worship service and keynote talk.
- On Oct. 24, I attended the launch event for the revived Winnipeg chapter of the United Nations Associations.
- On Nov. 16, the Rector of St. Paul's College and I made a presentation to UM's Provost's Council about the relationship between our affiliate colleges and the University.
- I attended two meetings of the Scholarship Committee, and helped determine the recipients of our College scholarships and bursaries.
- I attended two Soup & Bread lunch presentations by our fellows.
- I continue to serve on the Advisory Circle for the Emmanuel Mission Learning Centre at Holy Trinity Church.
- I continue to represent the College at meetings of Dean's Council, Provost's Council, University Senate, Faculty of Arts Council, and Diocesan Council.

Soup & Bread Lecture Series

We have had two great lectures thus far – Murray Evans and Jocelyn Thorpe – and our final presenter of the term will be Sean Carleton on Nov 30 from 1-2pm on the topic of residential school denialism in Canada.

Fellowship Roles and Responsibilities

The SJC Fellow's handbook is ready! The warden and I have updated the book with the help of the SJC staff to reflect the current roles and responsibilities of the fellowship, update the history of the college, and provide an overview of all committees and staff roles.

New Fellows

We are delighted to welcome our more recent fellows including Annette Riziki, Joerg Stedefeld, and Sean Carleton!

Convocation

This event took place Sunday, November 5th @ 3pm. It was very successful, and we had a good number of grads and award winners attend. We gave out 2 honorary degrees (to Patricia Bovey and Brian Bowman), honorary fellowship to Vince Solomon, and the fellow's recognition award to Dr. Brenda Cantelo.

Membership Committee

We have received one more application for fellowship since our last assembly meeting and the Membership Committee has voted to admit Ryan Turnbull. This will be brought before Assembly for a vote on Nov 20, 2023.

Visiting Fellow positions (1-year term)

Ryan Turnbull is a doctoral candidate from the University of Birmingham, who studies the theology of place. He is set to defend his PhD shortly and has joined the college as the Diocesan Discipleship Developer.

Bursars' Report to Council November 22nd, 2023

College Operations/Financial update

The College is operating at pre-pandemic levels in nearly every way except for our Residence which is still hovering below 50% occupancy. We are continuing to push hard to get the word out to students that we have vacancies and are seeing some positive responses to those efforts. Our goal is to boost our numbers for the winter term. Catering and DBC and Soup4U sales continue to do very well. However, because our Residence revenues/operations are so closely integrated with those other services, and as we continue to all experience the high price of food, not having that anticipated revenue is putting a significant strain on our overall budget. In the meantime, we continue to do everything we can to minimize spending and reduce costs where we can.

CRA Appeal

The latest update on the resolution of our case and recouping payment for our outstanding claims is that we have received an initial cheque for \$172,474.11, that covers the periods during the time of our appeal. We are in the process of responding to a request from CRA for additional information regarding specifics of the subsequent CEWS claims that were made so that the remainder of the amount owed to the College will be paid.

Audit

At its September meeting, College Council approved the 2022-23 Audited Financial Statements upon the recommendation of the Finance & Administration Committee and reappointed BDO Canada for the 2023-24 fiscal year.

Building Projects

Following an agreement on a letter of intent between St John's and the University of Manitoba, Allison and I met with the UM CFO and Associate VP Admin to check in on our previous discussions regarding the residence project. They affirmed their commitment to the project and their desire to partner with the College in a way that is beneficial to both St John's and the University. Architectural & Engineering Services is planning to schedule an initial, high level design meeting and St John's will be included in that. We also have another meeting scheduled for February with University Administration to continue discussions.

Dean of Residence Report – November 2023

Fall and Winter Sessions

As of November 14, we have 38 people in the Residence, with 4 Winter applications in various stages of our application process.

On October 19, I again participated in ICM's online Housing Open House and was able to advertise the Residence to the approximately 40 people in attendance.

On October 25, I e-mailed 118 high school guidance counsellors, letting them know about the availability of rooms for January in the Residence, as well as advertising the benefits the College has to offer both resident and non-resident members. I will follow up with these contacts in the Spring as their students begin to consider plans for Fall 2024.

On November 9, I e-mailed the Associate Deans of all U of M faculties advertising both Residence and College membership. The response has been overwhelmingly positive, with all the ADs who have responded indicating a willingness to ensure students in their units are aware of what the College has to offer.

Several Kijiji ads ran during late September and early October. There were approximately 50 views per ad, but only one inquiry.

I have connected regularly with the Student Experience and Marketing teams at ICM, U of M Case Managers, Migizii Agamik, and the International Centre regarding the ongoing availability of Residence rooms. During October, we had two students referred from the International Centre stay in the Residence who needed temporary housing. I will be meeting with ICM on November 16 to discuss the possibility of them having between 10 and 25 residents in the Residence for at least one (maybe two) three-week period during the Winter months as they host an international mobility program.

Marissa Naylor has been an excellent resource in getting the word out about the Residence. She has connected with all of the parishes of the Diocese of Rupert's Land and the Residence has been included in the weekly "4 Your Parish" sent by the Diocesan Office to all parishes, as well as being included in Rupert's Land News. Several paid Facebook and Kijiji ads will be forthcoming in the next few weeks.

I am hopeful that our all-out effort will result in many more applications for Winter 2024 residence. If you know of anyone looking for housing in the coming months, or have any creative ideas about how we can get the word out and fill up the Residence, please be in touch.

Residence Activity

The Residence Council has gotten off to a slow but promising start. They held one event in September and have plans to hold several more during the rest of the Fall and Winter terms. The Council is currently considering opening Residence Banquets up to wider attendance from SJCSA members, with non-residence guests needing to RSVP and purchase a ticket to attend.

The Dons Team has held a number of Residence community-building events which were very well attended: a movie and pizza night in the Games Room; a bon-fire and s'mores night at Kings Park; and a paint and pizza night inspired by the popular "Paint Nite."

Later in November, I will begin the process of hiring three or four Winter Break Dons, who will offer the regular Dons Team a well-needed break during the Winter closure.
