Code of Conduct

All carrel applicants are required to accept all terms and conditions of this code of conduct. Please initial beside each condition to show that you have read and understood it.

- I understand that **excessive noise and talking is prohibited** within the carrel room. If I need to talk for a long period of time or if I need to talk on my cell phone, I will exit the room.
- I understand that using another person's carrel without their permission is prohibited.
- I will not change my seating assignment without consulting the Student Services Representative first.
- I understand that bring a guest into the carrel room with me is **prohibited**.
- I understand that I have a duty to the rest of the carrel community to keep the **door locked** at all times.
- I will show respect for all other members of the carrel community at all times.
- I understand that I may not post items on the walls of the carrel room using tape, staples or tacks. I also understand that I may not move my carrel from its original position or alter it in any way.
- I understand that there is a **\$25.00 charge if I lose my key** and that I must return my key and vacate my carrel at the end of the term (SJCSA Student Services Representative will notify carrel holders of the specific date). If I do not return my key, I know that a hold will be placed on my student record and my possessions will be removed from the carrel room. I acknowledge that if I do not pick up my possessions by the end of the following term they will become the property of the SJCSA.
- I understand that the SJCSA is not responsible for any damage or loss of property in the carrel room.
- I understand that my right to use the carrel room may be revoked at the discretion of the SJCSA Student Services Representative and that **no refund** will be received.
- I understand that after 10pm I am allowed in the college but must remain in the carrel room unless going to the washroom, getting water, or answering a phone call.
- I understand after 10pm the college doors will be locked, and I am not allowed to let anyone into the college or ask a friend to open the doors for me.
- I understand that the use of any personal extension cords is not permitted in the carrel room
- I will respect the carrel community by sharing the space in the fridge, removing food before it turns rotten and removing any of my food that has an expiration date before it has expired.
- I will respect other carrel members by eating food that is loud or has a strong smell outside of the room.
- I will respect other carrel members by keeping my carrel desk clean and clear of items that may produce strong odours (candles, rotten food, essential oils etc.)
- I understand that it is prohibited to have open flames or burn items anywhere in the college. This includes, but is not limited to, candles and incents.
- The use of appliances is prohibited in the carrel room. This includes, but not limited to, electric kettles, toaster ovens, coffee machines etc. Laptops and other small electronic chargers are allowed.
- I understand these rules are subject to change without notice.
