#### GENERAL INFORMATION

St. Paul's College extends Study Carrel space privileges to its undergraduate student members. However, Study Carrel space is limited to 44 spots. The Student Members who submit their applications before or on the deadline will have their names screened for allocation for Study Carrel space during the 2024-2025 Fall & Winter Sessions. Student Members who held Study Carrel space in the academic year 2023/2024 are not guaranteed a space for the Fall & Winter Sessions 2024/2025 (must sign renewal form and pay fee). Carrels are allocated on a first-come, first-serve basis on the rental day (September 10 & 11, 2024).

#### APPLICATION DEADLINE

- All applications for Study Carrel space in the 2024 Fall & Winter Sessions, must be received on September 10 & 11, 2024.
- Applications received after September 11, 2024, will be added to the waiting list if applicable.
- **If you qualify for a carrel, payment, and access to carrels will begin on September 10th**
- Only one carrel per student. Personal ID and College membership must be presented at the time of rental.
- **Carrels must not be moved due to fire regulations.**

#### STUDY CARREL FEES

**Fall & Winter Sessions** (September 10, 2024 – April 25, 2025) is **\$60.00**.

**Spring/Summer Session** (May 5, 2025- August 22, 2025) is **\$30.00**.

#### BEHAVIOUR AND LOSS OF PRIVILEGES

All students are to refrain from making loud noise, talking, smoking and/or eating and drinking in the study carrel area. The study carrel area is for studying only, we ask that socializing take place in the cafeteria area. *Study carrels are not to be moved due to fire regulations.* All study carrel area holders will be held responsible for their actions and agree to comply with the "Study Carrel Policies and Guidelines". *Students are forbidden to share their room code with another nor allow others who are not registered to use the carrel room.* The Rector's Office will revoke all carrel room privileges from those students who do not comply with the policies and guidelines noted here.
