I. GENERAL INFORMATION

The Faculty of Human Ecology offers vibrant and progressive undergraduate programs that allow students to understand, develop, and transmit knowledge that is essential to human health and well-being.

This brochure is attached to and constitutes part of every application form issued. It must be assumed, therefore, that all applicants have read and understood it prior to submitting an application.

The following information outlines the entrance requirements, selection policies and admission procedures that will be in effect for students applying for the 2011-2012 session of the Bachelor of Human Ecology (Family Social Sciences and General Degree), Bachelor of Science (Human Nutritional Sciences and Textile Sciences), Bachelor of Health Sciences and Bachelor of Health Studies degree programs.

II. PROGRAMS

Applicants must apply for admission both to the Faculty as well as to their intended degree program, in one of the following areas: Family Social Sciences, the Human Ecology program, Human Nutritional Sciences, Textiles Sciences, Health Sciences, and Health Studies.

III. STATEMENT CONCERNING INTAKE QUOTAS

The Faculty of Human Ecology will accept a maximum of eighty (80) students in each program. The Adjusted Grade Point Average (see VI. Criteria for Selection) will be used to select the top students. The academic caliber of the annual applicant pool will determine the academic cut-off (AGPA).

A waiting list will be kept to ensure that students who rank below the cut-off for the regular session admission will be contacted in the event that space becomes available. Students will be contacted regarding their status before the end of the registration revision period in September.

IV. MID SESSION TRANSFER

The Faculty will admit internal applicants for the January (winter) term, only if space becomes available within the programs. Admission is subject to the number of students registered by the end of the September revision period. First preference will be given to students already admitted to the Faculty of Human Ecology. Applicants interested in applying must contact the Dean's Office. *The deadline for applying is October.* Applicants applying from other programs at the University of Manitoba will be advised of space availability with an announcement on the Faculty's web-site prior to the mid-session transfer deadline of November 1.

V. SPECIAL STUDENTS

Students who have been awarded a Baccalaureate Degree, with a minimum Cumulative Grade Point Average (CGPA) of



2.00 from the University of Manitoba or another university may apply as a Special Student. Students must contact the Faculty at 474- 9759 for further information.

VI. ELIGIBILITY REQUIREMENTS

REGULAR CATEGORY

1. All applicants must have completed a minimum of twenty-four (24) credit hours of university level course work, with a minimum Adjusted Grade Point Average of 2.00. Course work must consist of 6 credit hours of Arts course work, 6 credit hours of Science course work, and 12 credit hours of electives. All course work must be completed by the end of the April exam period. NOTE: The written English and Mathematics requirements are satisfied by required courses HMEC 2030 and STAT 1000 in the Faculty of Human Ecology. HMEC 2030 will be replaced by HMEC 2000, effective September 2011, subject to Senate approval. These courses will be available to students upon admission to the Faculty of Human Ecology.

2. Applicants who have been awarded a first degree from a recognized university, with a minimum cumulative grade point average of 2.00 or better may be eligible for admission to a Second Degree. Family Social Sciences and Human Nutritional Sciences offer second degree programs; applicants must have included in their first degree 6 credit hours of Arts and 6 credit hours of Science course work to be eligible. Applicants with degrees will become part of the applicant pool ranked within each program.

3. Red River College graduates from the Disability and Community Support, Child and Youth Care, and Early Childhood Diploma programs are eligible to apply to the Family Social Sciences program in the Faculty of Human Ecology and will receive 60 credit hours of transfer credit. The entrance requirement of 6 credit hours of science course work will be waived for admission purposes, and students will be required to complete the science requirement in the first year of admission.

Information is available on the Faculty of Human Ecology's website regarding allocation of coursework.

4. Applicants who have attended other recognized institutions who do not meet the Eligibility Requirement in (see. IV Eligibility Requirements) may be eligible for admission.

VII. CRITERIA FOR SELECTION

1. An Adjusted Grade Point Average (AGPA) is calculated by excluding the lowest credit hours of course work in accordance with the following table:

VIII. REQUIRED DOCUMENTATION

The following documents will be required to complete your application:

Final official transcripts from high school and any university or college attended other than the University of Manitoba. Official transcripts become the property of the university and as such are not returnable. Calendar course outlines may be requested as part of the evaluation process.

IX. ORIENTATION

Successful applicants are required to confirm their acceptance to the faculty by completing a confirmation form of acceptance, and attendance of the orientation session. The letter of confirmation will be included with the acceptance letter and must be returned within 10 days of receipt of the Certificate of Acceptance.

New students must attend an orientation session, prior to registration. Orientation sessions will be held in late June and early July. Please contact the Faculty at 474-8508 to register for the session. Any student who is unable to attend a session should call the General Office at (204) 474 - 8508 for further information.

The Faculty will provide entering students with an orientation package. Individual programs of study will be planned in consultation with an academic advisor. A program plan for the succeeding year must be submitted by returning students before the end of the second term.



X. ACADEMIC ADVISING

The Faculty of Human Ecology and the Admissions Office are eager to assist all applicants who seek counseling regarding admission to the Human Ecology program. However, it is the Faculty's policy not to instruct applicants as to a specific course of action they should follow, but rather to provide the information needed for the applicant to make their own choices with respect to the alternatives available.

Applicants are encouraged to discuss their plans with all who can usefully advise them, but they should be aware that second and third hand information about Faculty admission policies is often incorrect and should be confirmed with the Admissions Officer.

All applicants are advised to supplement any personal inquiries with written inquiries so that an official written response can be made. It is only these written responses which will be considered as evidence of any advice given by the Faculty of from the Admissions Office.

XI. DEADLINE DATE

- May 2, 2011 Deadline date for receipt of an application form by the Admissions Office. Students applying from Universities other than Manitoba are encouraged to apply earlier so course evaluations can begin.
- June 15, 2011 Deadline date for receipt of complete and official transcripts from high school and all universities/colleges requested by the Admissions Office.

XII. APPLICATION FEE

The application fee of \$80.00 (CAD) must be included with the application, and it is non-refundable. The fee for international applicants is \$110.00 (CAD).

XIII. APPEALS

Applicants may request reconsideration of any decision made by the Admissions Committee. Individuals who wish to have their applications reconsidered should, in the first instance, submit their request to the Dean's Office, Faculty of Human Ecology within twenty (10 days) of notification of a negative admission decision. Past experience has shown that most inquiries are satisfied at this level without further reference.

However, to appeal the reconsidered decision, the applicant must submit a request in writing to the Senate Secretariat, 312 Administration Building, University of Manitoba, within ten days of the receipt of the reconsidered result. The request will be conveyed to the Senate Admission Appeals Committee.
